Requested Action

Authorize the NH Department of Agriculture, Markets & Food, Division of Regulatory Services (NHDAMF) to budget and expend carry forward funds from State Fiscal Year 2014, in the amount of \$7,500; for Out-of-State Travel (080), to fulfill the scope of work to attend conferences and training sessions related to Organic Process Handlers Certification. These non-lapsing funds are fees collected for organic certification and inspections of organic operations in New Hampshire; for the period of Governor and Council approval to June 30, 2015. 100% Other Funds – Organic.

These Funds are to be budgeted in the existing account, **02-18-18-181000-26080000 Organic Process – Handlers Cert**, as follows:
