Dear Governor Hassan and Council:

Consistent with the requirement of RSA 383:15, I am pleased to submit the 170th Annual Report of the Bank Commissioner, for calendar year 2014.

Despite challenging national trends, New Hampshire's financial institutions remain stable and supportive of our State's economy. Due to the merger of Centrix Bank with Massachusetts-chartered Eastern Bank, however, total bank assets were reduced by 7.4%, and total loans were reduced by 7.5%. Credit union total assets grew 6.7%, while total loan balances grew 12.7%. Overall, capital positions remain well within regulatory parameters. In a fiscal and regulatory climate in which further industry consolidation remains likely, the State ended the year with 16 state-chartered banks and 11 credit unions. Nondepository trust companies continued their steady growth in both the number of institutions and the total assets under management. The year ended with a total of 29 state-chartered corporate trust companies and two family trust companies, with over \$418 billion in assets under management. The Department expects these trends will continue as the industry goes through a predicted period of expansion in the use of corporate trustees for both personal wealth and employee retirement plan management.

In 2014 there was continued growth in the number of non-depository licensed mortgage bankers (non-banks that fund mortgages) and associated branch offices. In addition, the number of licensed mortgage loan originators continued to steadily increase. All other license types, including mortgage brokers, mortgage servicers, sales finance companies, retail sellers, debt adjusters, and money transmitters, remained stable. The Department has undertaken joint and concurrent examinations with other states and continues to seek additional ways to collaborate to save time and resources, including coordinating with the other New England states to conduct joint examinations of New England based mortgage companies. Through enforcement actions and examinations, the Department collected approximately \$500,000 in administrative penalties and \$100,000 in restitution that was returned to New Hampshire consumers.

In addition to the Department's supervisory responsibilities, it serves New Hampshire consumers who are experiencing mortgage foreclosure and other problems, through "hotline" and complaint resolution procedures, and in coordination with the Department of Justice. In the first two years of the enhanced HomeHelp NH program, supported with funds from the National Mortgage Servicing Settlement, which increased availability of mortgage foreclosure counseling, over 1,800 New Hampshire households received such counseling, many with demonstrated positive outcomes.

While recovery from the recent recession has been challenging, New Hampshire financial institutions remain strong and continue to support businesses and consumers.



Foreword

The one hundred seventieth annual report of the Bank Commissioner contains management, financial information and locations of banks, credit unions, and other financial institutions operating under state charters. This report also contains information concerning debt adjusters, money transmitters, mortgage bankers and brokers, mortgage servicer registrations, retail sellers, sales finance companies, and small loan lenders licensed in 2014.

Mission Statement

The New Hampshire Banking Department is committed to protecting the public's interest through the professional supervision of the financial services we regulate.

Functions of the Banking Department

The Bank Commissioner is responsible for the general supervision of all New Hampshire chartered financial institutions. These institutions include commercial banks, fiduciary trust companies, family trust companies, mutual savings banks, guaranty savings banks, co-operative banks, and credit unions. The Commissioner is also charged with the licensing and supervision of non-bank mortgage lenders and brokers, money transmitters, mortgage loan servicers, retail sellers, sales finance companies, small loan, title loan, payday lenders, and debt adjusters.

State laws mandate that the Department conduct periodic examinations of each financial institution and licensed lender and broker to ensure sound financial management and compliance with state and federal laws and regulations.

The Department is responsible for the investigation of branch applications, new bank applications and conversions, merger and consolidation applications of state chartered institutions. The Department investigates consumer complaints on the entities it regulates, and also investigates complaints of unlicensed activity. The Department is authorized to bring administrative actions against licensed and unlicensed entities for violations of state banking and consumer credit laws.





(\$ thousands)**




**NH Asset Distribution - Five Year Trend
(\$ thousands)**




**NH Loan Trend - Five Year

(\$ thousands)**




Consumer Credit Division Money Transmitter Registrations





Mortgage Loans by Purpose


