Your Excellency and Members of the Council:

**REQUESTED ACTION**

That approval be and hereby is given to the Attorney General to grant a salary increase to Sean P. Gill, as an Assistant Attorney General (Position #9U049, Appropriation #02-20-20-200010-2601-013-500132), from a salary level of \$95,000 to a salary level of \$100,000 upon Governor and Executive Council approval or January 29, 2021, whichever is later.

**EXPLANATION**

In accordance with the 2001 N.H. Laws Chapter 158, Section 101, and 2018 N.H. Laws Chapter 162, Section 14, this request seeks your approval to grant a salary increase for Assistant Attorney General Sean P. Gill.

Mr. Gill is a resident of Derry, New Hampshire and a member of the New Hampshire Bar. He received his law degree from Wake Forest University School of Law in 1984 with an undergraduate degree from Saint Anselm College. Prior to joining this office, Mr. Gill retired after serving 20 years in the United States Coast Guard in various positions including command and operational law advisor, courts-martial prosecutor; Naval Justice School Instructor; and Coast Guard Academy Staff Judge Advocate and Military Judge (both the trial and appellate bench). Mr. Gill was appointed as an Assistant Attorney General in May, 2016 and was assigned to the Criminal Bureau. On September 17, 2017, he became a Senior Assistant Attorney General and manager of the Medicaid Fraud Unit. In December, 2019, Mr. Gill was appointed to the position of Chief of Staff. In this position, he has managed the day-to-day staffing issues and is primarily responsible for the recruitment and retention efforts of the office. He was designated as an Associate Attorney General on November 5, 2020. His salary will increase by \$5,000, from \$95,000 to \$100,000. I will continue his assignment as Chief of Staff for the Department.
