REQUESTED ACTION

That approval be and hereby is given to the Attorney General to appoint Rachel C. Harrington, Position #9U636 (Appropriation #02-20-20-200510-26100000-013-500132), as an Assistant Attorney General at a salary level of \$79,000, effective upon Governor and Executive Council approval or February 12, 2021, whichever is later, for a term ending on July 1, 2024.

EXPLANATION


Ms. Harrington is a resident of Pembroke and a member of the New Hampshire Bar. She graduated, *summa cum laude*, from the University of New Hampshire in 1998 with a Bachelor of Arts in Political Science and earned her Juris Doctor from Northeastern University School of Law in 2003. While in law school, she worked as a legal research and writing Teaching Assistant and helped place student mentors through the Youth Advocacy Caucus Mentoring Program. Ms. Harrington was an Assistant County Attorney in the Merrimack County Attorney's Office from 2003 through 2016 where she prosecuted sexual assault and domestic violence cases. She joined the New Hampshire Department of Justice in December 2019 and has been working in the Criminal Justice Bureau, Cold Case Unit. I plan to continue her current assignment. Her salary will increase \$3,000 from \$76,000 to \$79,000. A copy of her resume is attached.

RSA 94:1-a(I)(c)(3) provides that designation of positions, salary levels, and salary increases for attorneys at the Department of Justice shall be determined by the Attorney General, subject to approval of the Governor and Council, within appropriations made to the Department of Justice.
