Requested Action

Explanation

As part of construction related to 46 Pettengill Rd, Londonderry, Prosit LLC and NH Fish and Game mutually agreed to a \$14,554 contribution associated with impacts to state endangered New England cottontails. Funds will be directed to conservation actions for New England cottontails.

The New Hampshire Fish and Game Commission voted unanimously to accept this donation at their January 12, 2021 meeting.

FACTS & PROGRESS OF LICENSE RETENTION COMMITTEE:


- Committee established by Director Mason for the purpose of deciding on ways to help retain the "bubble" of people who bought hunting and fishing licenses during the pandemic.
- Through August, NH saw an increase of approximately 22,000 additional fishing licenses sold in 2020 over 2019. This represents a 34% increase.
- The Committee was made up of staff from the Public Affairs, Law Enforcement, Legal Affairs, Business and Licensing, Wildlife, Marine, and Fisheries Divisions.
- The Committee has met several times. As a group we decided on the following first steps.





- D. Thirty-Five percent (35%) to the **New Hampshire Fish and Game Department**, with an address of 11 Hazen Drive, Concord, New Hampshire 03301-6500, to be added to the funds dedicated to its Nongame and Endangered Wildlife Program. ✓
