REQUESTED ACTION

Authorize the Department of Justice to accept and expend the remainder of a grant from the US Department of Justice, Office for Victims of Crime, in an amount of \$79,154 to provide trainings and resources to public and non-profit agencies providing victim services, upon approval of the Governor and Executive Council through September 30, 2021. 100% Federal Funds.

EXPLANATION

The New Hampshire Department of Justice is seeking approval to accept and expend the remainder of a grant award from the US Department of Justice, Office for Victims of Crime, specifically geared toward teaching and enhancing proper techniques used by individuals directly

servicing victims of crime. These funds were not previously budgeted because this grant will end on September 30, 2021.

The Department of Justice will utilize a portion of the funding to provide multidisciplinary trainings to victim service individuals and agencies throughout the state. Additionally, a modest amount of funding will be set aside to provide scholarships for entities to attend national trainings.

Performance will be measured by the number of trainings conducted and by the number of victim service individuals attending the trainings. Any training put on by the Department of Justice will be evaluated by attendees. The evaluations will be utilized to enhance future teaching sessions.

Federal award funds are budgeted to support the activities as follows:

072-500575: Federal grant to be utilized for training scholarships for national trainings.

In the event that federal funds become no longer available, general funds will not be requested to support this program.

1. Requirements of the award; remedies for non-compliance or for materially false statements

16. Effect of failure to address audit issues

The recipient understands and agrees that the DOJ awarding agency (OJP or OVW, as appropriate) may withhold award funds, or may impose other related requirements, if (as determined by the DOJ awarding agency) the recipient does not satisfactorily and promptly address outstanding issues from audits required by the Part 200 Uniform Requirements (or by the terms of this award), or other outstanding issues that arise in connection with audits, investigations, or reviews of DOJ awards.

7. Requirement to report potentially duplicative funding

If the recipient currently has other active awards of federal funds, or if the recipient receives any other award of federal funds during the period of performance for this award, the recipient promptly must determine whether funds from any of those other federal awards have been, are being, or are to be used (in whole or in part) for one or more of the identical cost items for which funds are provided under this award. 21. Restrictions on "lobbying"

In general, as a matter of federal law, federal funds awarded by OJP may not be used by the recipient, or any subrecipient ("subgrantee") at any tier, either directly or indirectly, to support or oppose the enactment, repeal, modification, or adoption of any law, regulation, or policy, at any level of government. See 18 U.S.C. 1913. (There may be exceptions if an applicable federal statute specifically authorizes certain activities that otherwise would be barred by law.)

Another federal law generally prohibits federal funds awarded by OJP from being used by the recipient, or any subrecipient at any tier, to pay any person to influence (or attempt to influence) a federal agency; a Member of Congress, or Congress (or an official or employee of any of them) with respect to the awarding of a federal grant or cooperative agreement, subgrant, contract, subcontract, or loan, or with respect to actions such as renewing, extending, or modifying any such award.
