REQUESTED ACTION

Authorize the Department of Business and Economic Affairs, Division of Economic Development, Office of International Commerce (OIC) to **retroactively** renew its membership with The Council of State Governments d/b/a State International Development Organization (SIDO) (VC # 285335), Lexington, KY in the amount of \$3,500.00 to provide national export trade research and related trade development programs effective upon approval of the Governor and Executive Council for the period of July 1, 2021 to June 30, 2022. **100% General Funds.**

EXPLANATION

The State International Development Organizations, Inc. (SIDO) is the premiere U.S. organization dedicated to supporting state international trade agencies. SIDO is the only national organization focused exclusively on state international trade development. SIDO helps state international trade agencies better serve American exporters by sharing innovative ideas and resources, developing the skills of state trade professionals, advocating the interests of states in trade promotion, and facilitating multi-state collaboration. SIDO provides a forum for state international trade practitioners to learn from each other for the benefit of local, regional, and national economies. As the global economy continues to recover from COVID-19, OIC's continued membership of SIDO allows access to resources which provide the latest data about trends and trade policies that businesses can use to expand their customer base internationally.

This request is **retroactive** because the membership period starts on July 1 of each year. OIC could not request approval for funds before the enactment of the most recent State Budget.

Listed below are answers to standard questions required for Governor and Executive Council organization dues and membership approval submissions:

1. How long has this organization been in existence and how long has this agency been a member of this organization? *The Office of International Commerce has been a member for three (3) years.*
2. Is there any other organization which provides the same or similar benefits which your agency belongs to? *No, there are no other organizations that OIC belongs to which offers the same or similar benefits on the national trade level. However, OIC is a member of the Eastern Trade Council (ETC), which provides trade support specifically on the North East regional level.*
3. How many other states belong to this organization and is your agency the sole New Hampshire state agency that is a member? *Every other U.S. state (49 + New Hampshire), and one U.S. territory, are members of the organization. The Office of International Commerce is the only New Hampshire agency that is a member.*
4. How is the dues structure established? (Standard fee for all states, based on population, based on other criteria, etc.) *The dues structure is a standard fee for all states.*
5. What benefit does the state receive from participating in this membership? *Advocacy: SIDO is the voice of state trade professionals in Washington, D.C advocating greater state-federal collaboration. Additionally, SIDO is a strong voice on behalf of state trade professionals in support of continuing federal funding for small business exporters. New Hampshire benefits from this federal funding in that it allows OIC to directly support businesses in the state. Training: SIDO organizes formal training seminars for state trade professionals and provides opportunities to attend training programs organized by the US Department of Commerce. Resources: SIDO utilizes surveys and studies to provide trade agencies with up-to-date information on funding opportunities, latest trade trends and best practices.*
6. Are training or educational/ research materials included in the membership? If so, is the cost included? Explain in detail. *Research materials, data and select training opportunities are provided through SIDO, and the costs are considered part of the membership dues.*
7. Is the membership required to receive any federal grants or required in order to receive or participate in licensing or certification exams? Explain. *No, the membership is not required to receive any federal grants in order to receive or participate in licensing or certification exams.*
8. Is there any travel included with this membership fee? Explain in detail any travel to include the number of employees involved, the number of trips, destination if known and purposes of membership supported trips. *No travel is included with this membership fee.*
9. Which state agency employees are directly involved with this organization? (Indicate if they are members, voting members, committee members, and/or officers of the organization.) *The Program Manager for the Office of International Commerce, and two (2) International Trade Officers for the Office of International Commerce, are directly involved with the organization. The Program Manager is a voting member of the organization.*

10. Explain in detail any negative impact to the State if the Agency did not belong to this organization. *SIDO is an organization made up of 50 states and 1 U.S. territory and works collaboratively to increase exports, thereby creating and retaining jobs, and enhancing global competitiveness. The convergence of SIDO members' expertise builds critical mass, facilitates innovation, and expands export opportunities.*

SIDO enhances state trade programs by advocating on behalf of the states on issues such as trade barriers, sharing trade development data, best practices and advocating for federal funding of international trade programs. Without being a member of SIDO, New Hampshire businesses would not have access to new, additional opportunities to access new markets and international business development, thereby affecting the growth of their businesses.
