REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract with Pike Industries, Inc. (Vendor 177300) of Belmont, NH, on the basis of a low bid of \$3,545,767.14 for pavement preservation in Wakefield and Ossipee, from the date of Governor and Council approval through September 9, 2022, unless extended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

Funding is available in State Fiscal Years 2022 and 2023, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

2. Further authorize that a contingency in the amount of \$177,288.36 be approved for payment of latent conditions, which may appear during the construction of the project. The contingency requested is 5% of the contract amount.

EXPLANATION

This project is part of the State's Ten Year Transportation Improvement Plan, under the Pave-T2-Resurf Program. This project resurfaces two (2) sections of Tier 2 roads within two (2) towns in District 3. The sections total approximately 10.4 miles in length.

- 20301 - Wakefield-Ossipee, NH 16, Bonded Wearing Course (BWC) with spot inlays, 7.4 miles
- 20301A - Ossipee, NH 16, ¾" Paver Shim (PMST), 3.0 miles

This project is part of the CY 2022 federally funded Tier 2 resurfacing program. Sections 20301 will be resurfaced via spot inlay and either full width BWC or travel width plus one foot of BWC and fog sealing of shoulders. Section 20301A will be resurfaced via paver shim overlay. Other work includes removal and replacement of centerline rumble strips, bridge joint repair, drainage structure adjustments, and guardrail improvements.

The proposed contingency amount is 5% of the contract amount. This is to account for escalation in asphalt prices, that quantity calculations are based on aerial and street view photography and field conditions will vary, and that the sections will need to endure one additional winter season before the proposed work takes place.

Although the bid costs exceeded the Department's estimate by 0.94% the low bid of 2 bids received is felt to be reasonable for the work involved. Re-advertising this project would result, in our opinion, in higher prices and prevent the completion of the work in a timely manner. The Department considers it to be in the best interest of the State to accept this bid to accomplish these needed repairs.


The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is: 80% Federal (PAVE-T2-RESURF), with anticipated utilization of Turnpike Toll Credits for the State's 20% match, effectively using 100% Federal Funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

Your approval of this resolution is respectfully requested.



PROJECT INITIATED: The Pavement Management Section has reviewed the road segments included in this project and identified a need for pavement preservation and light capital paving pavement treatments. This project will improve roadway ride quality and extend pavement life.

PROJECT EXPLANATION: This project is part of the CY 2022 federally funded Tier 2 resurfacing program. Sections 20301 will be resurfaced via spot inlay and either full width BWC or travel width plus one foot of BWC and fog sealing of shoulders. Section 20301A will be resurfaced via paver shim overlay. Other work includes removal and replacement of centerline rumble strips, bridge joint repair, drainage structure adjustments, and guardrail improvements.

TRAFFIC IMPLICATION: Only one section will be paved at a time. Traffic impacts are anticipated to be limited to temporary lane closures, shoulder closures, and short term one lane, alternating two-way traffic during work hours. Paving and milling will be night work, while other ancillary work, which includes guardrail work, striping, and drainage work, will be day work

WAKEFIELD-OSSIPEE BWC - NH 16




