Re: **PETITION – Hudson – 17-01-CMAQ #41754**

The Department of Transportation requests placing this item on the Consent Calendar.

Pursuant to RSA 230:14, 1, attached hereto is a petition for a hearing on the proposed safety improvements on Lowell Road (Route 3A), roadway widening Right-of-Way as well as the Circumferential Highway on ramp in Hudson.

Since the petition is not for the limitation or control of access, a Commission of Three persons should be appointed by the Governor with the advice of the Executive Council to hold a hearing. The Commission of Three persons shall determine whether there is occasion for the laying out of the roadway widening.

The purpose of this project will implement capacity and safety improvements on Lowell Road (Route 3A), including the intersection of Lowell Road/Flagstone Drive/Wason Road intersection, as well as the Circumferential Highway on ramp. The improvements will include roadway widening to add a southbound lane along Lowell Road for approximately 1,000 lineal feet. The project also includes approximately 700 lineal feet of widening on the Circumferential Highway on ramp, creating two lanes, then merging back into one lane.
