EXPLANATION

The funds were accepted in September 2021 to administer the New Hampshire Initiative to Address COVID-19 and STD under the American Rescue Plan Act of 2021 (Public Law 117-2). This act provides additional relief to address the continued impact of the COVID-19 pandemic on the economy; public health; and state and local governments. To support the governmental public health response to COVID-19, the Centers for Disease Control and Prevention (CDC) created a Supplement to CDC-RFA-PS19-1901. CDC intends to make these resources available over a five-year period. At this time, CDC has awarded funding totaling \$1,000,000 to New Hampshire to strengthen the capacity of State, Tribal, Local and Territorial (STLT) public health departments to mitigate the spread of COVID-19 and other infections. Additional funds of \$1,000,000 is expected to be awarded on or about February 7, 2022.

This request to reallocate the budget is being made to increase the amount needed in Class 102, Contracts for Program Services. The funds will be used to contract with Manchester and Nashua Health Departments to provide field work for STD and COVID-19 for disease outbreaks, investigation and mitigation. These departments will provide highly specialized public health infectious disease control with identified high-risk populations through investigation, education, clinical testing, targeted outreach to include field work and education to prevent and control Sexually Transmitted Diseases and COVID-19. The Department has conducted a detailed review of line items in the budget to ensure that available funds are maximized to the greatest degree possible.

EXPLANATION

This request is being made to accept additional grant funds available for the STD Prevention and Control program. On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (Public Law 117-2). This act provides additional relief to address the continued impact of the COVID-19 pandemic on the economy; public health; and state and local governments. To support the governmental public health response to COVID-19, the Centers for Disease Control and Prevention (CDC) created a Supplement to CDC-RFA-PS19-1901. CDC intends to make these resources available over a five-year period. At this time, CDC is awarding funding totaling \$1,000,000 to New Hampshire to hire and support Disease Intervention Specialists (DIS) to strengthen the capacity of State, Tribal, Local and Territorial (STLT) public health departments to mitigate the spread of COVID-19 and other infections. These funds are in addition to, and separate from, funds CDC previously awarded to these 59 jurisdictions through CDC-RFA-PS19-1901 on January 1, 2021.

The funds are to be budgeted as follows:

- Class 018 Disease Investigators need to be available seven days a week and during non-business hours. The funds will be used to pay for Overtime costs if necessary.
- Class 020 The funds will be used to pay for current expense items such as printing, copying, basic office supplies for staff, postage, advertising and pamphlets.
- Class 030 The funds will be used to purchase equipment for the laboratory to increase STD testing capacity and efficiency.
- Class 037 The funds will be used to purchase computer equipment for personnel hired for the positions requested with these funds.
- Class 038 The funds will be used to purchase software including for tracking purposes for the STD staff.
- Class 039 The funds will be used for cell phones for personnel working on STD COVID Workforce Development activities.
- Class 041 The funds will be used to pay for audit fund set aside.
- Class 042 The funds will be used to pay for post-retirement expense for the new positions.
- Class 059 The funds will be used to pay for the 5 full time temporary positions requested.

Infectious Disease Care Coordinator

This position will develop internal policies and programs and provide highly specialized public health infectious disease control investigation, activities and education with identified high-risk populations.

Infectious Disease Care Coordinator:

This position will provide highly specialized public health infectious disease control with identified high-risk populations through investigation, education, and development of programs and policies.

Compliance Specialist:

This position will evaluate fiscal and programmatic requirements of the Infectious Disease Prevention Investigation and Care Services Section (IDPICSS) in order to provide technical assistance to ensure contractor compliance with state and federal policies.

Public Health Detailing Specialist:

The Public Health Detailing Specialist will develop and implement program policies, procedures, and prevention program activities related to COVID-19, sexually transmitted infections (STIs), human immunodeficiency virus (HIV), and other infectious diseases with the goal of statewide dissemination of best-practice prevention strategies among pharmacists and other healthcare professionals.

Public Health Education Specialist:

The Public Health Education Specialist will develop and implement program policies, procedures, and prevention program educational activities related to prevention of the spread of COVID-19, sexually transmitted infections (STIs), human immunodeficiency virus (HIV), and other infectious diseases with the goal of increasing access to best-practice prevention and disease intervention among the public health workforce, community-based healthcare and other professionals.

- Class 060 The funds will be used to pay for benefits for the above positions.
- Class 070 The funds will be used to pay for In-State travel for staff traveling to interview COVID-19 and STD clients, attend in-state meetings and contractor site visits

- Class 080 The funds will be used to pay for staff to attend virtual conferences on HIV/AIDS.
- Class 102 The funds will be used to contract with Nashua and Manchester Health Departments to provide highly specialized public health infectious disease control with identified high-risk populations through investigation, education, clinical testing, targeted outreach to include field work and education to prevent and control Sexually Transmitted Diseases and COVID-19.

The following information is provided in accordance with the comptroller's instructional memorandum dated September 21, 1981:

1. List of personnel involved: 5 new positions will be created utilizing this funding including 2 Infectious Disease Care Coordinators; 1 Compliance Specialist; 1 Public Health Detailing Specialist and 1 Public Health Workforce Development Specialist (all Program Specialist IV's).
2. Nature, Need, and Duration: Creation of these positions will support the COVID-19 response by bolstering the Disease Investigation Workforce in New Hampshire, which is a key part of infectious disease outbreaks and pandemics.
3. Relationship to existing agency programs: This new funding will support the evolving needs of the COVID-19 pandemic response and enhancement of infectious disease public health workforce.
4. Has a similar program been requested of the legislature and denied? No
5. Why wasn't funding included in the agency's budget request? At the time of budget submission it was not known that this ARPA COVID-19 funding would be available.
6. Can portions of the grant funds be utilized? All grant dollars are being used for this request.
7. Estimate the funds required to continue this position:



Dear Ms. Doe,

The Division of Personnel approves your request received on August 26, 2021 for the Department of Health & Human Services to establish five (5) positions #9T3152, #9T3153, #9T3154, #9T3155 and #9T3156 as full-time temporary Program Specialist IV, LG 25; pending approval of funding.

These positions are being established to increase capacity in the Bureau of Infectious Disease Control. The positions will support the prompt response to outbreaks and efforts to prevent infectious disease, including COVID-19.

Of the five requests, two of the Program Specialist IV positions will function as Infectious Disease Care Coordinators. These positions will utilize specialized knowledge to provide disease intervention services for cases of HIV/STD, HCV, and COVID-19. Duties include case investigations, contact tracing and provision of technical assistance to medical providers.

The Program Specialist IV, Compliance Specialist will evaluate fiscal and programmatic requirements of the Infectious Disease Prevention Investigation and Care Services section, assuring contractor compliance with state and federal policy.


The Program Specialist IV, Public Health Detailing Specialist will develop and implement a prevention program, its policies and procedures for infectious diseases including COVID-19, HIV, and other sexually transmitted infections. A goal of this position is to disseminate preventive best-practices to healthcare professional and pharmacists statewide.

Program Specialist IV, Public Health Workforce Training Specialist will develop and implement a prevention program its policies and procedures for infectious diseases including COVID-19, HIV and other sexually transmitted infections. A goal of this position is to disseminate preventive and intervention best-practices among the professionals in public health and community-based healthcare.

These position numbers will be inactive until you receive funding approval from the Fiscal Committee per RSA 124:15.
