**REQUESTED ACTION**

Pursuant to the provisions of RSA 14:30-a, VI, authorize the Department of Health and Human Services, Office of the Commissioner, to accept and expend federal funds from the American Rescue Plan Act (ARPA) in the amount of \$15,015,000 which will be used to provide capital defrayment to Portsmouth Regional Hospital and its parent company HCA Healthcare, Inc. to develop a consolidated behavioral health hospital effective upon Fiscal Committee and Governor and Executive Council approval through June 30, 2023 and further authorize the allocation of these funds in the accounts below. This is an allowable use of ARP FRF funds under Section 602 (c)(1)(A) to respond to the public health emergency or its negative economic impacts.<sup>1</sup> 100% Federal Funds.

#### EXPLANATION

Portsmouth Regional Hospital will work with the State on a consolidated behavioral health hospital in Epping, NH. Services provided at this hospital include:

- Inpatient Adult Beds (all to be licensed as voluntary/involuntary) – 68 beds
- Inpatient Geriatric Beds – 16 beds
- Inpatient Adolescent Beds (12 years of age and older) – 12 beds
- Outpatient Partial Hospitalization Program – Capacity of 15
- Two Specialty Programs (Child & Adolescent Partial Program, Eating Disorder Unit and/or Dual Diagnosis Unit for mental illness and substance use.

This new consolidated unit would increase HCA's current psychiatric capacity by the following amounts:

- Inpatient Adult Beds : 41.7%
- Inpatient Geriatric Beds: 60%
- Inpatient Adolescent Beds: 100%
- Partial Hospital Program : 100%

The estimated cost to build the behavioral health hospital is approximately \$45 million. The State of New Hampshire would provide \$15 million in capital defrayment at intervals throughout the build of the new facility. Portsmouth Regional Hospital has committed to run a minimum number of beds for psychiatric care (number yet to be determined), for a minimum of 7 years. Construction is anticipated to be complete in the fall of 2023.

This project is one of two capital defrayment projects that the Department of Health and Human Services will propose in the next 24 months.

Funds will be budgeted as follows:

Class 041 – The funds will be used to pay for audit fund set aside per State requirement.


Class 102 – The funds will be used to pay for the contract with Portsmouth Regional Hospital and its parent company HCA Healthcare, Inc.
