REQUESTED ACTION

That approval be and hereby is given to the Attorney General to reappoint Jennifer Schirmer to serve on the New Hampshire Victims' Assistance Commission. Ms. Schirmer's term will be for three years, from April 20, 2022 to April 20, 2025, upon approval of the Governor and Executive Council.

EXPLANATION

NH RSA 21-M:8-g authorizes the Attorney General to nominate, for approval by the Governor and Executive Council, members to serve on the New Hampshire Victims' Assistance Commission. This Commission reviews claims for financial reimbursement of expenses submitted by innocent victims of violent crimes. This program has been in effect since 1990.

Ms. Schirmer has a Master of Science degree in Clinical Mental Health Counseling and is an accomplished trauma specialist and a New Hampshire licensed and nationally certified counselor. She brings over 13 years of experience and knowledge in the community mental health system. Ms. Schirmer's knowledge and expertise in the mental health field will benefit the operation of the Victims' Assistance Commission.
