REQUESTED ACTION

For inclusion on the Governor and Council Consent Calendar, pursuant to MOP 1200, I. (D)., authorize the NH Department of Corrections to pay the Correctional Leaders Association (VC# 424623), Iona, ID, the amount of \$5,555.00 for membership dues effective upon Governor and Executive Council approval for the period of January 1, 2023 through December 31, 2023. 100% General Funds association

EXPLANATION

The Correctional Leaders Association (CLA) is an organization whose membership consists of persons who are appointed to serve on a full-time basis to be directly responsible for the administration of the correctional facilities or system of a jurisdiction. These persons include heads of state correctional agencies, Los Angeles County, the District of Columbia, New York City, Philadelphia, the Federal Bureau of Prisons, US Military Correctional Services (Army, Navy, Air Force, Marines) and any United States territory, possession, and/or commonwealth. The CLS provides a collaborative forum for the members to share ideas concerning issues of public safety, security, healthcare practices and orderly facilities to improve the corrections profession.¹

1. *How long has this organization been in existence and how long has this agency been a member of this organization?*

The CLA (formerly ASCA) has been in existence since 1960 with the NH Department of Corrections (NHDOC) being a member since at least 1984.

2. *Is there any other organization which provides the same or similar benefits which your agency belongs to?*

No.

3. *How many other states belong to this organization and is your agency the sole New Hampshire state agency that is a member?*

All 50 states are eligible members of CLA and the NHDOC is the only organization representing the State of New Hampshire.

4. *How is the dues' structure established? (Standard fee for all states, based on population, based on other criteria, etc.)*

According to the CLA, there is a three-tier dues system based on the size of the prisoner population. NH is in the lowest tier.

5. *What benefit does the state receive from participating in this membership?*

NHDOC participation in CLA allows our chief executive officer to gain information that assists the NHDOC executive team to anticipate and identify public policy, legislation, and litigation issues and to pro-actively act on these issues; one of the most effective methods of acquiring this information is through CLA organized surveys with correctional agencies from the other states and membership on specific national committees (i.e. Behavioral Health Committee, Recruitment and Retention Committee, Reentry and Community Corrections Committee and Restrictive Housing Committee). CLA facilitates numerous conference opportunities for members to attend which include presentations from non-profits engaged in providing services in correctional facilities, vendors who present on new technologies (e.g., contraband detection systems, drone detection, risk assessment software and many others), and program sharing by CLA members. These conferences assist all members in advancing correctional and field service operations by sharing program design and outcome data. CLA also coordinates a grant information network and works with other national organizations to provide training for correctional staff at different levels.

6. *Are Training or educational/research materials included in the membership?*

Research on multiple issues of interest to state correctional departments takes place throughout each year with research findings disseminated to the membership electronically and in hard copy. These have included corrections officers wage analysis, restrictive housing operational practices and implementation of medication-assisted treatment to list a few.

7. *Is the membership required to receive any federal grants or required in order to receive or participate in licensing or certification exams?*

8. *Is there any travel included with this membership fee? Explain in detail any travel to include the number of employees involved, the number of trips, destination if known and purposes of membership supported trips.*

There were a number of on-line forums created during the time in which travel was reduced due to COVID-19 which were conducted to review correctional practices associated with COVID-19 and national comparative review of state responses and challenges through the year associated with the pandemic. Commissioner Hanks attended the 2021 Northeast ASCA annual business meeting held in Niagara Falls, NY. This was a multi-day conference which reviewed national practices in corrections and field services in areas including but not limited to internal affairs investigations and professionalism within correctional law enforcement, managing women who are pregnant during incarceration and vocational programs, managing transgender populations, staff wellness and recruitment practices. There are opportunities for travel to conferences at a minimum of biannually with other opportunities to participate in advocacy at the Congressional level in the field of Corrections. Warden Edmark attended in the Commissioner's absence, as she stayed in state to handle operational needs here, the winter conference in Louisiana, where she was able to learn more about methods to reduce the use of restrictive housing, correctional staff wellness initiatives and national approaches being used to attempt to attract correctional officers in this challenging national economy. These are important opportunities to learn from other State leaders. This group continually examines security practices, community reintegration strategies, treatment approaches in behavioral health and methods to assist in correctional recruitment and retention with a key focus on improving existing staff wellness.

9. *Which state agency employees are directly involved with this organization? (Indicate if they are members, voting members, committee members, and/or officers of the organization).*

Commissioner Hanks is a member of CLA with voting privileges and is the committee chair of the Behavioral Health Committee, a committee member of the Recruitment and Retention Committee, the Reentry and Community Corrections Committee, and the Restrictive Housing Committee described as follows:

Behavioral Health Committee

The Mental Health and Substance Abuse Committee was established to provide a forum for the exchange of ideas and current initiatives regarding substance abuse and mental health treatment and services. Substance abuse is the leading cause of increasing prison populations and specifically, female prison populations. Mental health issues are also a major contributor to increases in incarceration. The Committee focuses on prevention, alternatives, institutional care, case management, release planning, continuation of care and best practices with limited resources. Specific goals include:

- Identification of good, evidence-based best practices;
- Collaboration with Federal partners such as National Institute of Corrections (NIC), Substance Abuse and Mental Health Services Administration (SAMHSA), and Bureau of Justice Assistance (BJA);
- Collaboration with organizational partners such as Council of State Government (CSG), National Association of State Alcohol and Drug Abuse Directors (NASADAD) and the National Association of State Mental Health Program Directors (NASMHPD);
- Advocacy for both preventative and community-based alternatives; and
- Collaboration with state and local partners such as state mental health directors and state substance abuse directors.

Recruitment and Retention Committee

This committee works hard at seeking ways to decrease turnover in our correctional ranks and also create innovative ways to attract people to this rewarding profession.

Reentry and Community Corrections Committee

The Reentry and Community Corrections Committee were formed to identify and promulgate disciplinary practices that are likely to reduce the number of offenders returning to prison after release. To that end, this committee does the following:

- Solicits presentations and reports on promising reentry projects;
- Monitors several information sharing projects produced by other committees and entities when they relate to reentry successes;
- Participates in the Council of State Governments (CSG) National Reentry Resource Center; and
- Searches and shares with members federal funding for institutional and community reentry programs and services.


Restrictive Housing Committee

The Restrictive Housing Committee was formed in January 2017 in response to an increasing national focus relative to the use of restrictive housing. The primary purpose of the committee is to facilitate member dialogue on the use of restrictive housing. CLA has undertaken a number of initiatives to facilitate dialogue and to identify potential best practices for members to employ in their jurisdictions.

10. *Explain in detail any negative impact to the State if the Agency did not belong to this organization.*

Without active participation by the Commissioner in CLA, the State would lose the opportunity to gain critical information on a regular basis that allows the NH Department of Corrections to anticipate and prepare for legislative and legal issues, learn from other state's past and current practices, to advance and/or adjust operations in a timely manner, and receive communications of national correctional relevance from which to consider policy implications or adjustments. This association focuses on the needs for rehabilitation, sustainable workforce initiatives and is extremely collaborative to assist all correctional leaders from avoiding adjustment to rules and policies that can be costly to the State as well as sharing practices that serve to advance our department.
