REQUESTED ACTION

For consideration to be placed on the consent calendar. Pursuant to RSA 110-B: 75, and in accordance with RSA 4:8, authorize the Department of Military Affairs and Veterans Services to accept donations of engraving on the plaque for Trees for Boscawen donations, computer consultations, items for the Memorial Walkway to include Quickrete, pavers, paver edging and spikes and walkway bricklaying, Monument refurbishing of monuments, paver, bench and brick engraving, granite benches, supplies to fix the Army monument, flags for graves, Turf Master Hydro-Seeder, Scotchgard and fabric for Urn table covers, Bitdefender, toner for copier, replacing the floor in the VHLC and mulch in the amount of \$59,319.88 for the New Hampshire State Veterans Cemetery to be used for the operation, maintenance, and improvement of the cemetery as listed on the attachment.

EXPLANATION

RSA 110-B:75 states that the Adjutant General is authorized to accept, on behalf of the state, gifts of money, material, equipment, and/or services for the operation, maintenance, and improvement of the cemetery, with the concurrence of the governor in accordance with the provisions of RSA 4:8.
