**REQUESTED ACTION**

Authorize the Governor's Office for Emergency Relief and Recovery (GOFERR) to enter into a **retroactive sole source** subaward agreement with New Hampshire Housing Finance Authority (Vendor Code 174411), 32 Constitution Drive, Bedford, NH 03110, in the amount of \$19,977,520 to administer the Emergency Temporary Housing Support Program for eligible households temporarily in hotels or motels as part of the New Hampshire Emergency Rental Assistance Program (NHERAP) to help ensure households at risk of homelessness are stably housed through the cold season, effective upon Governor and Executive Council approval retroactive to December 1, 2022 through June 30, 2023. This is an allowable use of ARPA SFRF funds under Section 602 (c)(1)(A) to respond to the public health emergency or its negative economic impacts. **100% Federal Funds.**

**EXPLANATION**

This subaward is a **retroactive sole source** agreement because the New Hampshire Housing Finance Authority (NHHFA) has administered the New Hampshire Emergency Rental Assistance Program (NHERAP) since March 2021 in partnership with the Community Action Partnerships (CAPs) and GOFERR, and the program defined in this subaward is intended to complement and run alongside NHERAP. This item is retroactive to December 1, 2022 due to the immediate need for these funds to ensure that eligible households that are currently staying in hotels or motels to continue to do so. Moreover, NHHFA is uniquely positioned to administer this program as the primary provider of housing services in the State. This request would authorize a sole source agreement between GOFERR and NHHFA to facilitate the Emergency Temporary Housing Support Program, which will provide assistance to households temporarily staying in hotels or motels as part of NHERAP to help ensure those households at risk of homelessness and without alternative housing are stably housed through the State's cold season.

This voluntary program would make available funding to be utilized to support households already in hotels or motels as part of NHERAP, as well as eligible households that applied or reapplied for assistance as of the date of the NHERAP application pause on October 21, 2022.


The intent of the program is to assist families in need and at risk of homelessness, reduce potential demand on homeless or emergency shelters, and ensure additional time for these households to find and access more permanent housing solutions. As a result, NHHFA and the CAPs will encourage hotels and motels to continue to take in or retain households with no children through April 1, 2023, and households with children through June 15, 2023.

The Emergency Temporary Housing Support Program will largely utilize the NHERAP program infrastructure already in place for administrative efficiency, will to the extent possible mirror NHERAP eligibility requirements, and will utilize an average rate per night cap to ensure equitable use of funds where needed throughout the State. Supportive services that are provided through NHERAP, such as case management and legal services, will continue to be made available to households throughout the life of this program as well.

This is an allowable use of ARPA SFRF funds under Section 602 (c)(1)(A) to respond to the public health emergency or its negative economic impacts.

In the event that Federal Funds become no longer available, General Funds will not be requested to support this program.



2. **SCOPE OF ALLOWABLE USE OF FUNDS:** In exchange for grant funds from the State award under the Coronavirus State and Local Fiscal Recovery Funds ("CSLFRF") established by the American Rescue Plan Act of 2021 ("ARPA"), H.R. 1319, Section 9901 on March 11, 2021, provided by the United States Department of Treasury, CFDA number 21.027 to the State of New Hampshire, acting through the Agency identified in Paragraph 1.1 (hereinafter referred to as "GOFERR"), the Grantee identified in Paragraph 1.3 (hereinafter referred to as "the Grantee"), agrees and covenants that the funds will be used solely for an allowable purpose as defined in H.R. 1319, Section 9901, for which Grantee has not received payment or reimbursement from any other source, defined as: provide financial assistance to support households in hotels or motels as part of the New Hampshire Emergency Rental Assistance Program (NHERAP), as well as eligible households that applied or reapplied for assistance as of the date of NHERAP's application pause on October 21, 2022. The Federal Award Identification Number (FAIN) for this award is SLFRP0145.

The allowable purposes and use of funds are more specifically described in EXHIBIT A.

3. **EFFECTIVE DATE: COMPLETION OF GRANT.**

Notwithstanding any provision of this Agreement to the contrary, and subject to the approval of the Governor and Executive Council of the State of New Hampshire, if applicable, this Agreement, and all obligations of the parties hereunder, shall become effective on the date the Governor and Executive Council approve this Agreement as indicated in paragraph 1.14, unless no such approval is required, in which case the Agreement shall become effective on the date the Agreement is signed by the State Agency as shown in paragraph 1.1 ("Effective Date").

Except as otherwise specifically provided herein, this Grant, including all activities and reports required by this Agreement, shall be completed in their entirety prior to June 30, 2023.

4. **GRANT AMOUNT: LIMITATION ON AMOUNT: VOUCHERS: PAYMENT.**

The Grant Amount is identified in paragraph 1.8 and is more particularly described in EXHIBIT B, attached hereto. The manner of, and schedule of payment shall be as set forth in EXHIBIT B.

In accordance with the provisions set forth in EXHIBIT B, and in consideration of the satisfactory performance of the Grant, as determined by the GOFERR, the GOFERR shall pay the Grantee the Grant Amount.

The payment by the GOFERR of the Grant amount shall be the only, and the complete payment to the Grantee for all expenses, of whatever nature, incurred by the Grantee and claimed as allowable expenses under this Agreement. To the extent that the Grant amount does not cover all of the Grantee's allowable expenses, nothing in this Agreement shall be construed to limit the Grantee's ability to pursue other COVID-19 relief that may be available. However, under this Agreement, the GOFERR shall have no liabilities to the Grantee other than the Grant Amount.

Notwithstanding anything in this Agreement to the contrary, and notwithstanding unexpected circumstances, in no event shall the total of all payments authorized, or actually made, hereunder exceed the Grant limitation set forth in Paragraph 1.8 of these general provisions.

5. **COMPLIANCE BY GRANTEE WITH LAWS AND REGULATIONS.** In connection with the performance of the Grant, the Grantee shall comply with all statutes, laws, regulations, and orders of federal,

State, county, or municipal authorities which shall impose any obligations or duty upon the Grantee, including the acquisition of any and all necessary permits.

#### 6. RECORDS AND ACCOUNTS.

Between the Effective Date and the date five (5) years after the Completion Date, the Grantee shall keep detailed accounts of all expenses incurred in connection with the Grant, including, but not limited to, costs of administration, transportation, insurance, telephone calls, and clerical materials and services. Such accounts shall be supported by receipts, invoices, bills and other similar documents.

Between the Effective Date and the date five (5) years after the Completion Date, at any time during the Grantee's normal business hours, and as often as the GOFERR, the U.S. Department of Treasury or OMB shall demand, the Grantee shall make available to the GOFERR, the U.S. Department of Treasury or OMB all records pertaining to matters covered by this Agreement. The Grantee shall permit the GOFERR, the U.S. Department of Treasury or OMB to audit, examine, and reproduce such records, and to make audits of all contracts, invoices, materials, payrolls, personnel records, data, and other information relating to all matters covered by this Agreement. As used in this paragraph, "Grantee" includes all persons, natural or fictional, affiliated with, controlled by, or under common ownership with, the entity identified as the Grantee in Paragraph 1.3 of these provisions

#### 7. PERSONNEL.

The Grantee shall, at its own expense, provide all personnel necessary to perform the Grant. The Grantee warrants that all personnel engaged in the Grant shall be qualified to perform such Grant, and shall be properly licensed and authorized to perform such Grant under all applicable laws. Grantee shall comply with all GOFERR and federal personnel and labor laws applicable to its employees.

The Grant Officer shall be the representative of the State hereunder. In the event of any dispute hereunder, the interpretation of this Agreement by the Grant Officer, and his/her decision on any dispute, shall be final.

8. CONDITIONAL NATURE OF AGREEMENT. Notwithstanding anything in this Agreement to the contrary, all obligations of the GOFERR hereunder, including, without limitation, the continuance of payments hereunder, are contingent upon the availability or continued appropriation of funds, and in no event shall the GOFERR be liable for any payments hereunder in excess of such available or appropriated funds. In the event of a reduction or termination of those funds, the GOFERR shall have the right to withhold payment until such funds become available, if ever, and shall have the right to terminate this Agreement immediately upon giving the Grantee notice of such termination.

#### 9. EVENT OF DEFAULT: REMEDIES.

Any one or more of the following acts or omissions of the Grantee shall constitute an event of default hereunder (hereinafter referred to as "Events of Default"):

- Failure to perform the Grant satisfactorily or on schedule;
- Failure to submit any report required hereunder;
- Failure to maintain, or permit access to, the records required hereunder; or
- Failure to perform any of the other covenants and conditions of this Agreement.

Upon the occurrence of any Event of Default, the GOFERR may take any one, or more, or all, of the following actions:

Give the Grantee a written notice specifying the Event of Default and requiring it to be remedied within, in the absence of a greater or lesser specification of time, thirty (30) days from the date of the notice; and if the Event of Default is not timely remedied, terminate this Agreement, effective two (2) days after giving the Grantee notice of termination; and

Give the Grantee a written notice specifying the Event of Default and suspending all payments to be made under this Agreement and ordering that the portion of the Grant Amount which would otherwise accrue to the Grantee during the period from the date of such notice until such time as the GOFERR determines that the Grantee has cured the Event of Default shall never be paid to the Grantee;

Set off against any other obligation the GOFERR may owe to the Grantee any damages the GOFERR suffers by reason of any Event of Default;

Recoup from the Grantee, including by withholding any other payment of funds that becomes due to Grantee from the GOFERR, any payments under this Agreement that have been used in a manner contrary to the terms of this Agreement or the CLSFRF, H.R. 1319, Section 9901; and/or

Treat the Agreement as breached and pursue any of its remedies at law or in equity, or both.

#### 10. TERMINATION.

In the event of any early termination of this Agreement for any reason other than the completion of the Grant, the Grantee shall deliver to the Grant Officer, not later than fifteen (15) days after the date of termination, a report (hereinafter referred to as the "Termination Report") describing in detail all Grant expenses reimbursed, and the Grant Amount earned, to and including the date of termination.

In the event of Termination under paragraph 9 of these general provisions, the approval of such a Termination Report by the GOFERR shall entitle the Grantee to retain the portion of the Grant amount earned up to and including the date of termination.

The approval of such a Termination Report by the GOFERR shall in no event relieve the Grantee from any and all liability for damages sustained or incurred by the GOFERR as a result of the Grantee's breach of its obligations hereunder.

Notwithstanding anything in this Agreement to the contrary, either the GOFERR or, except where notice default has been given to the Grantee hereunder, the Grantee, may terminate this Agreement without cause upon thirty (30) days written notice.

11. CONFLICT OF INTEREST. No officer, member or employee of the Grantee, and no representative, officer or employee of the State of New Hampshire or of the governing body of the locality or localities in

which the Grant is to be performed, who exercises any functions or responsibilities in the review or approval of the undertaking or carrying out of such Grant, shall participate in any decision relating to this Agreement which affects his or her personal interest or the interest of any corporation, partnership, or association in which he or she is directly or indirectly interested, nor shall he or she have any personal or pecuniary interest, direct or indirect, in this Agreement or the proceeds thereof.

12. GRANTEE'S RELATION TO THE GOFERR. In the performance of this Agreement the Grantee, its employees, and any subcontractor or subgrantee of the Grantee are in all respects independent contractors, and are neither agents nor employees of the GOFERR. Neither the Grantee nor any of its officers, employees, agents, members, subcontractors or subgrantees, shall have authority to bind the GOFERR nor are they entitled to any of the benefits, workmen's compensation or emoluments provided by the GOFERR to its employees.

13. ASSIGNMENT AND SUBCONTRACTS. The Grantee shall not assign, or otherwise transfer any interest in this Agreement without the prior written consent of the GOFERR.

14. INDEMNIFICATION. The Grantee shall defend, indemnify and hold harmless the GOFERR, its officers and employees, from and against any and all losses suffered by the GOFERR, its officers and employees, and any and all claims, liabilities or penalties asserted against the GOFERR, its officers and employees, by or on behalf of any person, on account of, based on, resulting from, arising out of (or which may be claimed to arise out of) the acts or omissions of the Grantee or subcontractor, or subgrantee or other agent of the Grantee. Notwithstanding the foregoing, nothing herein contained shall be deemed to constitute a waiver of the sovereign immunity of the GOFERR, which immunity is hereby reserved to the GOFERR. This covenant shall survive the termination of this Agreement.

15. INSURANCE AND BOND.

The Grantee shall, at its own expense, obtain and maintain in force, the following insurance:  
Statutory workmen's compensation and employees liability insurance for all employees engaged in the performance of the Grant; and  
Comprehensive public liability insurance against all claims of bodily injuries, death or property damage, in amounts not less than \$1,000,000 per occurrence and \$2,000,000 aggregate for bodily injury or death in any one incident, and \$500,000 for property damage in any one incident; and

The policies shall be the standard form employed in the State of New Hampshire, issued by underwriters acceptable to the State and authorized to do business in the State of New Hampshire.

16. WAIVER OF BREACH. No failure by the GOFERR to enforce any provisions hereof after any Event of Default shall be deemed a waiver of its rights with regard to that Event, or any subsequent Event. No express waiver of any Event of Default shall be deemed a waiver of any provisions hereof. No such failure of waiver shall be deemed a waiver of the right of the GOFERR to enforce each and all of the provisions hereof upon any further or other default on the part of the Grantee.

17. NOTICE. Any notice by a party hereto to the other party shall be deemed to have been duly delivered or

given at the time of mailing by certified mail, postage prepaid, by United States Mail, addressed to the parties at the addresses first above given.

**18. AMENDMENT.**

This Agreement may be amended, waived or discharged only by an instrument in writing signed by the parties hereto and only after approval of such amendment, waiver or discharge by the Governor and Council of the State of New Hampshire unless no such approval is required under the circumstances pursuant to State law, rule or policy.

**19. CONSTRUCTION OF AGREEMENT AND TERMS.** This Agreement shall be construed in accordance with the law of the State of New Hampshire, and is binding upon and inures to the benefit of the parties and their respective successors and assignees. The captions are used only as a matter of convenience, and are not to be considered a part of this Agreement or to be used in determining the intent of the parties hereto.

**20. THIRD PARTIES.** The parties hereto do not intend to benefit any third parties and this Agreement shall not be construed to confer any such benefit.

**21. ENTIRE AGREEMENT.** This Agreement, which may be executed in a number of counterparts, each of which shall be deemed an original, constitutes the entire agreement and understanding between the parties, and supersedes all prior agreements and understandings relating hereto.

**22. SPECIAL PROVISIONS.** The additional provisions set forth in EXHIBIT C hereto are incorporated as part of this Agreement.

## GRANT AGREEMENT EXHIBIT A

### Scope of Allowable Uses of Coronavirus State and Local Fiscal Recovery Fund Grant

1. Grantee, the New Hampshire Housing Finance Authority ("NHHFA"), will use the grant funds for the Emergency Temporary Housing Support Program ("ETH Program"), which will provide financial assistance to support households in hotels or motels as part of the New Hampshire Emergency Rental Assistance Program (NHERAP), as well as eligible households that applied or reapplied for assistance as of the date of NHERAP's application pause on October 21, 2022. The intent of the ETH Program is to keep NHERAP eligible households that would be otherwise homeless stably housed through New Hampshire's coldest months by utilizing the emergency measure of temporary stays at hotels or motels for those households.

In coordination with GOFERR, NHHFA shall design The ETH Program with the following goals:

- Utilizing the existing NHERAP structure and largely mirroring its program requirements;
- Assisting families in need that are homeless or at risk of homelessness;
- Reducing potential demand on homeless or emergency shelters;
- Enabling the continued stay of eligible households at local hotels or motels so long as their need remains during the State's cold season; and
- Ensuring additional time for these households to find and access more permanent housing solutions.

GOFERR shall have final approval of ETH Program design.

At a minimum, the ETH Program shall provide financial assistance for eligible households to cover the per night cost of a hotel or motel for households with no children from December 1, 2022 through April 1, 2023, and households with children from December 1, 2022 through June 15, 2023. In keeping with the structure of NHERAP, NHHFA shall work with and/or through the Community Action Partnerships (CAPs) to facilitate any necessary agreements or contracts that seek to keep the average nightly hotel or motel costs at or below \$200, understanding that regional or seasonal distinctions may require flexibility when working with hotels and motels, in order to ensure funds are effectively and equitably utilized.

In addition, eligible households shall receive ongoing housing support services, such as case management, housing counseling, legal assistance, and more, with the goal of assisting eligible households find permanent housing.

2. Grantee agrees and covenants that the funds will be used solely for an allowable purpose as set forth in paragraph 1 and as defined in the American Rescue Plan Act of 2021 ("ARPA"), H.R. 1319, Section 9901, for which Grantee has not received payment or reimbursement from any other source, specifically, to respond to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19) or its negative economic impacts, including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality.

3. To the extent that Grantee is making sub-awards from this award, Grantee shall develop and

use a template for sub-awards that will be subject to review and approval by GOFERR before use to ensure that the sub-awards contain adequate provisions that the funds can only be used for allowable ARPA costs and require compliance with other applicable 2 CFR 200 requirements.

4. The U.S. Treasury's final rules on allowable uses of CSLFRF funds at [2022-00292.pdf \(govinfo.gov\)](#) Overview of the final rule at [SLFRF-Final-Rule-Overview.pdf \(treasury.gov\)](#); and the U.S. Treasury's Answers to Frequently Asked Questions (FAQ's) <https://home.treasury.gov/system/files/136/SLFRPFAQ.pdf> regarding allowable uses of CSLFRF funds are incorporated herein and made part of this Agreement as if set forth in full.

5. The administrative cost for the Grantee, not to exceed 3.5%, is included in the total for the program. This cap on administrative costs is a total administrative cost cap that includes 0.5% reserved for Grantee and 3% reserved for Grantee's subawardees. This administrative cost maximum rate may be reviewed from time to time to determine if it remains appropriate.

6. Reporting: Grantee shall submit quarterly reports electronically to the GOFERR grant officer by email or other electronic means subsequently designated by GOFERR to ensure timely program administration and assistance, including data needed to comply with federal laws, regulations, and guidance. Such reports shall include at least expenses and costs related to the ETH Program for which the grant funds have been used, including any required subrecipient related information, and shall break down the reporting by hotel and motel location at the town and county level for assistance provided. Grantee shall provide such reports within 15 days of the close of each quarter.

Additionally, bi-weekly reports, the specific elements to be designated by GOFERR, shall track the assistance provided by hotel, town, and county, as well as the administrative budget expenditures for the prior two-week period.

Grantee will also provide a program-end summary report by July 31, 2023, with specific elements to be designated by GOFERR in coordination with the Grantee, but it will include at a minimum summary details on the expended funds and households assisted over the life of the program.

If deemed appropriate by GOFERR, the Grantee may also be required to provide higher-level/summary weekly reporting electronically to the GOFERR grant officer by email or other electronic means subsequently designated by GOFERR.

7. Any portion of the grant not expended by Grantee for allowable costs by June 30, 2023 shall lapse and shall not be paid or must be returned to GOFERR if already paid to but go unused by the Grantee for eligible purposes.

8. Unique entity identifier and System for Award Management (SAM)—Required. Grantees must (i) Be registered in SAM before submitting an application or entering into an agreement; (ii) provide a valid unique entity identifier in its application (until April 4, 2022 the federal government is accepting DUNS numbers but after that date it must be a UEI); and (iii) continue to maintain an active SAM registration with current information at all times during which it has an active Federal award or an application or plan under consideration by a Federal awarding agency. EXHIBIT J should be returned

completed with the executed Grant Agreement, and must be received completed before any disbursement can be made. This requirement must be passed through to sub-recipients.

9. The U.S. Treasury may issue subsequent or further guidance on allowable uses of CSLFRF funds at its website <https://home.treasury.gov/policy-issues/coronavirus/assistance-for-state-local-and-tribal-governments/state-and-local-fiscal-recovery-funds>. Any such guidance shall be considered incorporated into this agreement by reference without further notice.

## GRANT AGREEMENT EXHIBIT B

### Methods and Conditions of Payment

Grantee must register with the Department of Administrative Services for a State of New Hampshire vendor number (see page 1, para 1.6) in order for a payment to be issued. Registration can be done online at [https://das.nh.gov/purchasing/vendorregistration/\(S\(5wm5gw45ho4qvr55aww2os55\)\)/welcome.aspx](https://das.nh.gov/purchasing/vendorregistration/(S(5wm5gw45ho4qvr55aww2os55))/welcome.aspx). Payment will be by check or ACH, depending on the vendor registration.

1. Upon execution of this Agreement, GOFERR will advance to Grantee the sum of \$19,977,520.00, which will be used to provide financial assistance to support households in hotels or motels as part of the New Hampshire Emergency Rental Assistance Program (NHERAP), as well as eligible households that applied or reapplied for assistance as of the date of NHERAP's application pause on October 21, 2022.

2. Grantee will bill for direct and indirect costs related to program marketing and oversight, reporting to GOFERR, and additional staff, if necessary, to answer questions of potential program recipients. Grantee reimbursement for these costs shall not exceed .5% of program expenditures.

3. NHHFA shall contract with the state's five Community Action Partnerships (CAPs) to provide direct services to ETH Program applicants/eligible households. This will include receiving and processing applications, making direct payments to hotels and motels on behalf of clients, related case management services, and required program reporting. The CAPs shall bill Grantee through the ETH Program for their direct and indirect costs associated with this work. These costs will be capped at 3% of total program expenditures, both individually and in aggregate.

4. Grantee shall return any unexpended funds within 45 days of the Completion Date.

5. Notwithstanding anything to the contrary herein, Grantee agrees that any funding under this agreement may be withheld, in whole or in part, in the event of non-compliance with any Federal or State law, rule, or regulation applicable to the services provided, or if the said services or products have not been satisfactorily completed in accordance with the terms and conditions of this agreement.

## GRANT AGREEMENT EXHIBIT C

### Special Provisions

1. Fund payments are largely subject to the requirements of the Uniform Guidance (2 C.F.R. Part 200). The applicable provisions of 2 C.F.R. Part 200 as amended are considered legally binding and enforceable documents under this contract. The GOFERR reserves the right to use any legal remedy at its disposal including, but not limited to, disallowance of costs or withholding of funds.
2. To the extent required to comply with 2 CFR 200, Subpart F - Audit Requirements, Grantee shall complete an audit at the end of the Grantee's fiscal year when the award was spent. Grantee shall provide a copy of any single audit report for the period of this grant to GOFERR concurrently with submission.

If required, the audit report shall include a schedule of prior year's questioned costs along with a response to the current status of the prior year's questioned costs. Copies of all management letters written as a result of the audit along with the audit report shall be forwarded to GOFERR within one month of the time of receipt by the Grantee accompanied by an action plan, if applicable, for each finding or questioned cost.

3. The costs charged under this contract shall be determined as allowable under the cost principles detailed in 2 CFR 200 Subpart E - Cost Principles.
4. Program and financial records pertaining to this contract shall be retained by the Grantee for 5 (five) years from the date of submission of the final expenditure report as per requirements from the Treasury Office of Inspector General.
5. This award is not a grant for research and development as defined in 2 CFR 200.1.
6. The following paragraphs shall be added to the general provisions:

"23. RESTRICTION ON ADDITIONAL FUNDING. It is understood and agreed between the parties that no portion of the "Grant" funds may be used for the purpose of obtaining additional Federal funds under any other law of the United States, except if authorized under that law."

"24. ASSURANCES/CERTIFICATIONS. The following are attached and signed: Certification Regarding Drug-Free Workplace Requirements; Certification Regarding Lobbying; Certification Regarding Debarment, Suspension and Other Responsibility Matters; Certification Regarding the Americans With Disabilities Act Compliance; Certification Regarding Environmental Tobacco Smoke; Assurance of Compliance Nondiscrimination in Federally Assisted Programs; and Certification Regarding the Federal Funding Accountability and Transparency Compliance."

"25. COPELAND ANTI-KICKBACK ACT. All contracts in excess of \$2,000.00 for construction or repair using funds under this grant shall include a provision for compliance with Copeland "Anti-Kickback" Act (18 USC 874) as supplemented in Department of Labor Regulations (29 CFR, Part 3).
