EXPLANATION

The Assistance for Firefighters grant program provides funding to State fire training agencies to purchase the equipment necessary to ensure firefighters and emergency medical personnel continue to be trained throughout the State. Based on the size of the State of New Hampshire, there is a 15% match to this grant for which the Division will be utilizing current budgeted funding. The funding is for monitoring equipment, training manikins, SCBA units and protective clothing used in fire training.

The funds are to be budgeted as follows:

Funds in class 020 will be used to purchase personal protective clothing used in fire training evolutions.

Funds in class 030 will be used to purchase two gas meters, 10 training manikins, and 53 SCBA units used in fire training evolutions.


Funds in class 040 will be used for indirect costs.

Funds in class 041 will be used for audit purposes.

Although the Department included this grant in the SFY 22/23 budget, the actual amount of the federal grant received was higher than expected.

In the event that Federal funds are no longer available, General funds and/or Highway funds will not be requested to support this program.



Article 1

Assurances, Administrative Requirements, Cost Principles, Representations and Certifications

I.
