**REQUESTED ACTION**

Pursuant to MOP 1200, I.D., authorize the New Hampshire Lottery Commission (Lottery) to **retroactively** pay the North American Association of State and Provincial Lotteries (NASPL) (VC #206566), Concord, Ohio, the amount of \$25,000 for Calendar Year 2023 membership dues effective upon Governor and Council approval for the period of January 1, 2023, through December 31, 2023. **100% Lottery Funds.**

**EXPLANATION**

The NASPL membership facilitates communication among lottery organizations regarding development of industry standards and matters of mutual interest, particularly those which relate to the integrity, security, and efficiency of state and provincial lottery jurisdictions. With the expansion of New Hampshire Lottery's games and the creation of the Council for Responsible Gambling, membership in this organization has become even more essential to the agency's success and the welfare of our customers.
