REQUESTED ACTION

That approval be and hereby is given to the Attorney General to appoint Mary F. Stewart, Position #9U543 (Appropriation #02-20-20-200510-26110000-013-500132) as an Assistant Attorney General at a salary level of \$98,000, effective upon Governor and Executive Council approval or April 21, 2023, whichever is later, for a term ending October 20, 2023.

EXPLANATION

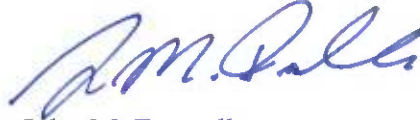
Ms. Stewart, a resident of Bow, earned a Bachelor of Science in Finance and Management from Lehigh University in 1985, and her Juris Doctor from Vermont Law School in 1993. She alternated between private practice and judicial clerkships at the United States Bankruptcy Court over the course of her legal career. She clerked for the Hon. James Yacos from 1993 to 1995, operated her own law office from 1995 to 1997, and served as an Advocate at the Legal Advice and Referral Center from 1997 to 1998. She was associated with Feniger and Uliasz, PLLC, from 2004 to 2005 and Firstenberger and Stewart, PLLC, from 2004 to 2005. After a six-month temporary clerkship with the Hon. J. Michael Deasy in 2005, she resumed private practice as a solo practitioner from 2005 to 2018. Ms. Stewart also clerked for the Hon. Bruce Harwood from 2018 to 2021. She was a Member of the National Association of Consumer Bankruptcy Attorneys from 2006 to 2018, the New Hampshire Pro Bono Advisory Board from 2011 to 2012, and the National Association of Consumer Advocates from 2014 to 2018. Ms. Stewart was honored with the Distinguished Pro Bono Service Award for Consumer Bankruptcy in 2010. She joined the Department last year and was assigned to the Consumer Protection Bureau. I plan to continue her assignment there. Her salary will increase by \$1,898 from \$96,102 to \$98,000. A copy of her resume is attached.
