REQUESTED ACTION

Authorize the Governor's Office for Emergency Relief and Recovery (GOFERR) to finalize the grant agreements using signed terms and conditions (see example attached) and in the amounts indicated in the table below totaling \$149,876 from the approved accept and expend of \$3,000,000 in American Rescue Plan Act (ARPA) State Fiscal Recovery Funds (SFRF) previously approved on November 22, 2021 to grant funds to support the Local Restaurant Infrastructure Investment Funds Program designed to help address workforce issues and overall restaurant safety challenges experienced by small, locally-owned restaurants across the State, effective upon Governor and Council approval through June 30, 2023. This is an allowable use of ARPA SFRF funds under Section 602 (c)(1)(A) to respond to the public health emergency or its negative economic impacts. **100% Federal Funds.**

EXPLANATION

On November 22, 2021, Governor & Executive Council approved the funding for the Local Restaurant Infrastructure Investment Funds program (Item #60). Local restaurants continue to bear a heavy burden due to the COVID-19 pandemic. Challenges include finding and retaining workforce, supply chain disruptions, and changes in consumer behavior and expectations. Coming into the slower "off-season," with increasing COVID cases, these issues are likely to be amplified.

The State of New Hampshire sought to continue to provide opportunities for long-term investments among smaller/independently owned New Hampshire restaurants, as well as help challenges created by workforce shortages, consumer behavior, and overall restaurant safety.

In doing so, GOFERR started accepting applications for the Local Restaurant Infrastructure Investment Funds Program on April 21, 2022, and it reviewed and determined eligibility on a rolling basis. After the initial program application period closed, authorized funds and industry needs remained. As a result, GOFERR reopened this program on November 1, 2022, and accepted applications through March 15, 2023.

Entities in the table above with "***" following their name are businesses that received a previous award that did not require approval from Governor and Council. However, they are receiving a subsequent award that puts them over the \$10,000 threshold, requiring approval here. GOFERR is reviewing applications on a rolling basis.

As with previous awards authorized under this program, requests for award authorizations for those over \$10,000 will continue to be submitted to the Governor and Executive Council on a rolling basis in batches. Such "batch" approval requests will occur from now through the application deadline (March 15, 2023) and final review.

Upon approval of this request, the terms and conditions become the grant agreement under which an award is approved and subsequently issued or paid.

To avoid delay in payments to these businesses, you will notice on the table that some do not have vendor codes set up at the time of this request. GOFERR along with the assistance of the Department of Administrative Services is working with these restaurants to have one set up to be paid as quickly as possible once approved at Governor and Council.

Awards issued in the thirteenth batch total \$223,144.85 leaving \$614,492.57 available for approval and allocation. Within the total awards issued by GOFERR in this batch, awards equaling \$149,876 are being submitted for approval by Governor and Executive Council as part of this request because they exceed the \$10,000 per entity threshold. Attached you will find a cumulative list of awards issued, including those

awards issued to entities below that threshold and those approved at the July 12, 2022, July 27, 2022, August 17, 2022, September 7, 2022, September 21, 2022, December 7, 2022, January 18, 2023, February 8, 2023, February 22, 2023, March 8, 2023, March 22, 2023, and April 12, 2023 Governor & Executive Council meetings.

Examples of potentially eligible expenses for reimbursement include equipment or software to expand or adopt digital services such as online reservations, and host-less check in, at-table payment systems and menus that help provide more flexibility and increase capacity, HVAC system upgrades to improve COVID-19 mitigation, and more.

In the event that Federal Funds become no longer available, General Funds will not be requested to support this program.




