## REQUESTED ACTION

Authorize the Governor's Office for Emergency Relief and Recovery (GOFERR) to enter into a **sole source** amendment of a subaward (or grant) agreement with New Hampshire Housing Finance Authority (Vendor Code 174411), 32 Constitution Drive, Bedford, NH 03110, to continue providing housing stability and related services to eligible New Hampshire households, by extending the completion date from June 30, 2023 to December 31, 2023, with no change to the price limitation, effective upon Governor and Council approval. The original agreement was approved by the Governor and Executive Council on May 18, 2022, Item #55G and amended with Governor and Council approval on December 7, 2022, Item #39C. This is an allowable use under the Emergency Rental Assistance fund established by the American Rescue Plan Act of 2021, H.R. 1319, Section 3201 on March 11, 2021 (ERA2). **100% Federal Funds.**

## EXPLANATION

Pursuant to **sole source** subaward agreements under Emergency Rental Assistance (ERA) funding, specifically funding provided through ERA1 (Consolidated Appropriations Act) and ERA2 (American Rescue Plan Act), New Hampshire Housing Finance Authority (NHHFA) is responsible for administration of the New Hampshire Emergency Rental Assistance Program (NHERAP), in collaboration with the State's five Community Action Partnerships (CAPs), and GOFERR.

On May 18, 2022, and utilizing authorized ERA2 funds, Governor and Council authorized GOFERR to enter into a sole source agreement with NHHFA in the amount \$1,773,000 (G&C Item #55G) for the purposes of providing housing stability and related services to households as part of NHERAP, a subaward which enabled the continued provision of services previously authorized with ERA1 funds. In December 2022 this agreement was amended with NHHFA for housing stability related services, increasing the price limitation by \$2,000,000 and expanding the services provided therein.

The housing stability services program through NHHFA has supported access to NHERAP assistance and leverages other resources to promote housing stability. NHHFA uses these funds to enter into subawards with the five CAP agencies to provide housing stability services, including:

- Application assistance that helps households access ERA programs (assistance may be provided to both tenants and landlords);



- Housing counseling including financial management, budgeting, tenants' rights and finding another rental, if necessary;
- Wraparound case management related to housing stability including referrals to and help with filling out applications for services offered by the CAP and Department of Health and Human Services;
- Housing-related services for survivors of domestic abuse or human trafficking; and
- Specialized services for individuals with disabilities or seniors that support their ability to access or maintain housing; and
- Direct assistance that reduce major barriers needed to ensure household become permanently housed, such as application fees, moving expenses, and security deposits.

The no-cost amendment would extend the completion date of the existing agreement beyond June 30, 2023, and enable NHHFA and the CAPs to continue to provide the above services until funds previously authorized for the programs are exhausted.

In the event that Federal Funds become no longer available, General Funds will not be requested to support this program.

**Amendment to Subaward between the Governor's Office for Emergency Relief and the  
New Hampshire Housing Finance Authority**

The State of New Hampshire Governor's Office for Emergency Relief and Recovery (hereinafter "GOFERR") and the New Hampshire Housing Finance Authority (hereinafter "Grantee") hereby mutually agree to a no-cost amendment to the subaward for ERA2 Housing Stability Services. This subaward was previously approved by Governor and Council on May 18, 2022 and amended on December 7, 2022. This amendment is to extend the Grant Agreement term by 6 months, from June 30, 2023 to December 31, 2023.

This amendment is being made pursuant to Section 18 of the Grant Agreement, regarding the procedures for amending the subaward.

Wherefore, the Grant Agreement is amended as follows:

1. Amend Section 1.7 (page 1) of the Grant Agreement by extending the Completion Date from June 30, 2023 to December 31, 2023.
2. Amend Exhibit A, paragraph 6 to change the date from "June 30, 2023" to "December 31, 2023."
3. Amend Exhibit C, paragraph 6, subparagraph 26 by removing the existing text and replacing with the following:

26. CLOSE OUT OF CONTRACT. By January 31, 2024 Grantee shall submit a final report electronically to the GOFERR grant officer or other GOFERR designated individual by e-mail or other electronic means subsequently designated by GOFERR of the uses of the grant funds through December 31, 2023, and shall break down the reporting by facility location at the town level. In the event that the Grantee has not demonstrated that the grant funds have not been expended for allowable costs of at least the amount of this grant, the excess grant funds shall be returned with the final report to GOFERR, by check payable to Treasurer, State of New Hampshire.
4. Amend the period covered by the certification in Exhibit D (bottom of page 14) from "From effective date through June 30, 2023" to "From effective date through December 31, 2023."
5. Amend Exhibit E of the Grant Agreement to change the Contract Period from "Effective date through June 30, 2023" to "Effective date through December 31, 2023."
6. All other provisions of the Grant Agreement shall remain the same.

Notwithstanding this amendment, Grantee is aware that funding beyond June 30, 2023 is contingent upon the availability or continued appropriation of funds beyond that date, as set forth in Section 8 of the Grant Agreement. In no event shall GOFERR be liable for any payments in

excess of such available or appropriated funds.

**Grant Agreement Amendment**

The State of New Hampshire Governor's Office for Emergency Relief and Recovery (GOFERR) and the New Hampshire Housing Finance Authority (NHHFA or Grantee) hereby mutually agree to amend the Grant Agreement previously entered into and approved by Governor and Council on May 18, 2022, to increase the Price Limitation by \$2,000,000, expand the scope of allowable uses under this Grant, and increase the time Grantee has to return unexpended funds.

Wherefore the Grant Agreement is amended as follows:

1. Amend Section 1.8 of the Grant Agreement (Page 1) by increasing the Price Limitation by \$2,000,000.00 from \$1,773,000.00 to \$3,773,000.00.
2. Amend Exhibit A by adding a new section 2.a., below:

2.a. Additional Services to be Provided. As necessary, Grantee shall provide wraparound case management services to allow for higher focus on more challenging cases. Services provided under wraparound case management shall include:

- The addition of specialized case managers to support wholistic services across multiple agencies;
- Coordinating case management, services, and supports with the focused goal of securing and maintaining permanent housing;
- Coordinating with mental health, SUD, and other supportive services;
- Entering into and/or extending contracts with organizations/entities to provide housing support and other solutions;
- Direct assistance to households experiencing homelessness for use with application fees, security deposits, or other barriers to permanent housing.

3. Amend Paragraph 3 of Exhibit B by increasing the time Grantee has to return any unexpended funds from "within 30 days of the Completion Date" to "within 45 days of the Completion Date."
4. All other provisions of the Grant Agreement approved by Governor and Council on May 18, 2022 shall remain in full force and effect.



EXPLANATION

Pursuant to sole source subaward agreements under Emergency Rental Assistance (ERA) funding, specifically funding provided through ERA1 (Consolidated Appropriations Act) and ERA2 (American Rescue Plan Act), New Hampshire Housing Finance Authority is responsible for administration of the New Hampshire Emergency Rental Assistance Program (NHERAP), in collaboration with GOFERR.

On September 15, 2021, Governor and Council authorized GOFERR to enter into a sole source agreement with the New Hampshire Housing Finance Authority (NHHFA) in the amount \$1,773,000 under ERA1 for the purposes of providing housing stability services to households as part of NHERAP. ERA1 funding expires September 30, 2022, and ERA2 funding will be required to continue these services thereafter. This item requests to enter into a sole source agreement with NHHFA for the same services through June 30, 2023, utilizing ERA2 funding.

The existing housing stability services program through NHHFA supports access to NHERAP assistance and leverages other resources to promote housing stability. NHHFA will use these new funds to enter into sub-awards with the five CAP agencies to continue providing housing stability services, including:

- application assistance that helps households access ERA programs (assistance may be provided to both tenants and landlords);
- housing counseling including financial management, budgeting, tenants' rights and finding another rental, if necessary;
- case management related to housing stability including referrals to and help with filling out applications for services offered by the CAP and Department of Health and Human Services;
- fair housing counseling and referrals to NH Legal Assistance;
- housing-related services for survivors of domestic abuse or human trafficking;
- specialized services for individuals with disabilities or seniors that support their ability to access or maintain housing.

With this funding, the CAPs will be able to maintain or increase their staffing as needed, which will also allow them to work more efficiently in processing NHERAP application and provide on-the-ground assistance at Circuit Court locations to support the Eviction Diversion and Landlord and Tenant Mediation Programs that are the subject of a separate fiscal item.

This item is sole source as NHHFA, as the sole statewide housing authority and the administrator of NHERAP, is uniquely positioned to administer this housing stability services program and manage the CAPs in their efforts to improve NHERAP access and leverage other available resources for the benefit of tenants as well as landlords whose tenants have fallen behind in payment of rent during the pandemic. Moreover, as mentioned above, this amounts to an extension of already provided services but under a new funding source.

In the event that Federal Funds become no longer available, General Funds will not be requested to support this program.



**2. SCOPE OF ALLOWABLE USE OF FUNDS:** In exchange for grant funds from the State under the Emergency Rental Assistance fund established by Section 3201 of the American Rescue Plan Act of 2021, Pub. L. No. 117-2 (March 11, 2021) (hereinafter referred to as "Section 3201") provided by and subject to the terms of the award from the United States Department of Treasury, CFDA number 21.023, FAIN Nos. ERAE0119, to the State of New Hampshire, acting through the Agency identified in Paragraph 1.1 (hereinafter referred to as "GOFERR"), the Grantee identified in Paragraph 1.3 (hereinafter referred to as "the Grantee"), agrees and covenants that the funds will be used solely for an allowable purpose as defined in Section 3201, for which Grantee has not received payment or reimbursement from any other source, to provide Housing Stability Services under Section 3201(d)(1)(B) to help keep households stably housed by supporting the access to New Hampshire Emergency Rental Assistance Program and to leverage other available resources to keep eligible households stably housed.

The allowable purposes and use of funds are more specifically described in EXHIBIT A.

**3. EFFECTIVE DATE: COMPLETION OF GRANT.**

This Agreement, is entered into and authorized by the State's Joint Legislative Fiscal Committee and the Governor and Executive Council and all obligations of the parties hereunder shall become effective on the date of execution of this Agreement by GOFERR ("the effective date").

Except as otherwise specifically provided herein, this Grant, including all activities and reports required by this Agreement, shall be completed in their entirety prior to June 30, 2023.

**4. GRANT AMOUNT: LIMITATION ON AMOUNT: VOUCHERS: PAYMENT.**

The Grant Amount is identified in paragraph 1.8 and is more particularly described in EXHIBIT B, attached hereto. The manner of, and schedule of payment shall be as set forth in EXHIBIT B.

In accordance with the provisions set forth in EXHIBIT B, and in consideration of the satisfactory performance of the Grant, as determined by the GOFERR, the GOFERR shall pay the Grantee the Grant Amount.

The payment by the GOFERR of the Grant amount shall be the only, and the complete payment to the Grantee for all expenses, of whatever nature, incurred by the Grantee and claimed as allowable expenses under this Agreement. To the extent that the Grant amount does not cover all of the Grantee's allowable expenses, nothing in this Agreement shall be construed to limit the Grantee's ability to pursue other state or federal funding that may be available. However, under this Agreement, the GOFERR shall have no liabilities to the Grantee other than the Grant Amount.

Notwithstanding anything in this Agreement to the contrary, and notwithstanding unexpected circumstances, in no event shall the total of all payments authorized, or actually made, hereunder exceed the Grant limitation set forth in Paragraph 1.8 of these general provisions.

**5. COMPLIANCE BY GRANTEE WITH LAWS AND REGULATIONS.** In connection with the performance of the Grant, the Grantee shall comply with all statutes, laws, regulations, and orders of federal,

State, county, or municipal authorities which shall impose any obligations or duty upon the Grantee, including the acquisition of any and all necessary permits.

#### **6. RECORDS AND ACCOUNTS.**

Between the Effective Date and the date five (5) years after the Completion Date, the Grantee shall keep detailed accounts of all expenses incurred in connection with the Grant, including, but not limited to, costs of administration, transportation, insurance, telephone calls, and clerical materials and services. Such accounts shall be supported by receipts, invoices, bills and other similar documents.

Between the Effective Date and the date five (5) years after the Completion Date, at any time during the Grantee's normal business hours, and as often as the GOFERR, the U.S. Department of Treasury or OMB shall demand, the Grantee shall make available to the GOFERR, the U.S. Department of Treasury or OMB all records pertaining to matters covered by this Agreement. The Grantee shall permit the GOFERR, the U.S. Department of Treasury or OMB to audit, examine, and reproduce such records, and to make audits of all contracts, invoices, materials, payrolls, personnel records, data, and other information relating to all matters covered by this Agreement. As used in this paragraph, "Grantee" includes all persons, natural or fictional, affiliated with, controlled by, or under common ownership with, the entity identified as the Grantee in Paragraph 1.3 of these provisions.

#### **7. PERSONNEL.**

The Grantee shall, at its own expense, provide all personnel necessary to perform the Grant. The Grantee warrants that all personnel engaged in the Grant shall be qualified to perform such Grant, and shall be properly licensed and authorized to perform such Grant under all applicable laws. Grantee shall comply with all GOFERR and federal personnel and labor laws applicable to its employees.

The Grant Officer shall be the representative of the State hereunder. In the event of any dispute hereunder, the interpretation of this Agreement by the Grant Officer, and his/her decision on any dispute, shall be final.

**8. CONDITIONAL NATURE OF AGREEMENT.** Notwithstanding anything in this Agreement to the contrary, all obligations of the GOFERR hereunder, including, without limitation, the continuance of payments hereunder, are contingent upon the availability or continued appropriation of funds, and in no event shall the GOFERR be liable for any payments hereunder in excess of such available or appropriated funds. In the event of a reduction or termination of those funds, the GOFERR shall have the right to withhold payment until such funds become available, if ever, and shall have the right to terminate this Agreement immediately upon giving the Grantee notice of such termination.

#### **9. EVENT OF DEFAULT: REMEDIES.**

Any one or more of the following acts or omissions of the Grantee shall constitute an event of default hereunder (hereinafter referred to as "Events of Default"):

- Failure to perform the Grant satisfactorily or on schedule;
- Failure to submit any report required hereunder;
- Failure to maintain, or permit access to, the records required hereunder; or
- Failure to perform any of the other covenants and conditions of this Agreement.

Upon the occurrence of any Event of Default, the GOFERR may take any one, or more, or all, of the following actions:

Give the Grantee a written notice specifying the Event of Default and requiring it to be remedied within, in the absence of a greater or lesser specification of time, thirty (30) days from the date of the notice; and if the Event of Default is not timely remedied, terminate this Agreement, effective two (2) days after giving the Grantee notice of termination; and

Give the Grantee a written notice specifying the Event of Default and suspending all payments to be made under this Agreement and ordering that the portion of the Grant Amount which would otherwise accrue to the Grantee during the period from the date of such notice until such time as the GOFERR determines that the Grantee has cured the Event of Default shall never be paid to the Grantee;

Set off against any other obligation the GOFERR may owe to the Grantee any damages the GOFERR suffers by reason of any Event of Default;

Recoup from the Grantee, including by withholding any other payment of funds that becomes due to Grantee from the GOFERR, any payments under this Agreement that have been used in a manner contrary to the terms of this Agreement or Section 3201; and/or

Treat the Agreement as breached and pursue any of its remedies at law or in equity, or both.

#### 10. TERMINATION.

In the event of any early termination of this Agreement for any reason other than the completion of the Grant, the Grantee shall deliver to the Grant Officer, not later than fifteen (15) days after the date of termination, a report (hereinafter referred to as the "Termination Report") describing in detail all Grant expenses reimbursed, and the Grant Amount earned, to and including the date of termination.

In the event of Termination under paragraph 9 of these general provisions, the approval of such a Termination Report by the GOFERR shall entitle the Grantee to retain the portion of the Grant amount earned up to and including the date of termination.

The approval of such a Termination Report by the GOFERR shall in no event relieve the Grantee from any and all liability for damages sustained or incurred by the GOFERR as a result of the Grantee's breach of its obligations hereunder.

Notwithstanding anything in this Agreement to the contrary, either the GOFERR or, except where notice default has been given to the Grantee hereunder, the Grantee, may terminate this Agreement without cause upon thirty (30) days written notice.

11. CONFLICT OF INTEREST. No officer, member or employee of the Grantee, and no representative, officer or employee of the State of New Hampshire or of the governing body of the locality or localities in

which the Grant is to be performed, who exercises any functions or responsibilities in the review or approval of the undertaking or carrying out of such Grant, shall participate in any decision relating to this Agreement or the proceeds thereof which affects his or her personal or pecuniary interest or the interest of any corporation, partnership, or association in which he or she is directly or indirectly interested.

**12. GRANTEE'S RELATION TO THE GOFERR.** In the performance of this Agreement the Grantee, its employees, and any subcontractor or subgrantee of the Grantee are in all respects independent contractors, and are neither agents nor employees of the GOFERR. Neither the Grantee nor any of its officers, employees, agents, members, subcontractors or subgrantees, shall have authority to bind the GOFERR nor are they entitled to any of the benefits, workmen's compensation or emoluments provided by the GOFERR to its employees.

**13. ASSIGNMENT AND SUBCONTRACTS.** The Grantee shall not assign, or otherwise transfer any interest in this Agreement without the prior written consent of the GOFERR.

**14. INDEMNIFICATION.** The Grantee shall defend, indemnify and hold harmless the GOFERR, its officers and employees, from and against any and all losses suffered by the GOFERR, its officers and employees, and any and all claims, liabilities or penalties asserted against the GOFERR, its officers and employees, by or on behalf of any person, on account of, based on, resulting from, arising out of (or which may be claimed to arise out of) the acts or omissions of the Grantee or subcontractor, or subgrantee or other agent of the Grantee. Notwithstanding the foregoing, nothing herein contained shall be deemed to constitute a waiver of the sovereign immunity of the GOFERR, which immunity is hereby reserved to the GOFERR. This covenant shall survive the termination of this Agreement.

**15. INSURANCE AND BOND.**

The Grantee shall, at its own expense, obtain and maintain in force, the following insurance: Statutory workmen's compensation and employees liability insurance for all employees engaged in the performance of the Grant; and Comprehensive public liability insurance against all claims of bodily injuries, death or property damage, in amounts not less than \$1,000,000 per occurrence and \$2,000,000 aggregate for bodily injury or death in any one incident, and \$500,000 for property damage in any one incident; and

The policies shall be the standard form employed in the State of New Hampshire, issued by underwriters acceptable to the State and authorized to do business in the State of New Hampshire.

**16. WAIVER OF BREACH.** No failure by the GOFERR to enforce any provisions hereof after any Event of Default shall be deemed a waiver of its rights with regard to that Event, or any subsequent Event. No express waiver of any Event of Default shall be deemed a waiver of any provisions hereof. No such failure of waiver shall be deemed a waiver of the right of the GOFERR to enforce each and all of the provisions hereof upon any further or other default on the part of the Grantee.

**17. NOTICE.** Any notice by a party hereto to the other party shall be deemed to have been duly delivered or given at the time of mailing by certified mail, postage prepaid, by United States Mail, addressed to the parties at the addresses first above given.

**18. AMENDMENT.**

This Agreement may be amended, waived or discharged only by an instrument in writing signed by the parties hereto and only after approval of such amendment, waiver or discharge by the State's Joint Legislative Fiscal Committee if required, or the Governor and Council of the State of New Hampshire if required, or by the signing State Agency.

**19. CONSTRUCTION OF AGREEMENT AND TERMS.** This Agreement shall be construed in accordance with the law of the State of New Hampshire, and is binding upon and inures to the benefit of the parties and their respective successors and assignees. The captions are used only as a matter of convenience, and are not to be considered a part of this Agreement or to be used in determining the intent of the parties hereto.

**20. THIRD PARTIES.** The parties hereto do not intend to benefit any third parties and this Agreement shall not be construed to confer any such benefit.

**21. RESEARCH GRANT STATUS.** This award is not a grant for research and development as defined in 2 CFR 200.1.

**22. EXTENSION.** The State may extend the Subaward Agreement for up to one (1) additional two (2) year term from the Completion Date, contingent upon satisfactory delivery of services, availability of funding, and appropriate State approval. If the Subaward Agreement is extended, the deadlines for the final report referenced in Exhibit C, paragraph 26 shall be likewise extended by two (2) years. All other terms and conditions for any extension period shall remain the same.

**23. ENTIRE AGREEMENT.** This Agreement, which may be executed in a number of counterparts, each of which shall be deemed an original, constitutes the entire agreement and understanding between the parties, and supersedes all prior agreements and understandings relating hereto.

**24. SPECIAL PROVISIONS.** The additional provisions set forth in EXHIBIT C hereto are incorporated as part of this Agreement.

## GRANT AGREEMENT EXHIBIT A

### Scope of Allowable Uses of ERA2 Housing Stability Services Grant

1. The New Hampshire Housing Finance Authority, Grantee, agrees and covenants that the funds will be used solely to provide Housing Stability Services under Section 3201(d)(1)(B), which includes case management and other services intended to help keep households stably housed, for which Grantee has not received payment or reimbursement from any other source and GOFERR has determined is an allowable purpose as defined in Section 3201 of the American Rescue Plan Act.

2. Services to Be Provided: Grantee will be responsible for state-wide administration of Housing Stability Services including but not limited to coordinating, contracting with and monitoring the work of sub-grantees, agencies and/or service providers to efficiently and effectively provide the following:

- application assistance that helps households access ERA programs (assistance may be provided to both tenants and landlords);
- housing counseling including financial management, budgeting, tenants' rights and finding another rental, if necessary;
- case management related to housing stability including referrals to and help with filling out applications for services offered by the CAP and Department of Health and Human Services;
- fair housing counseling and referrals to NH Legal Assistance;
- housing-related services for survivors of domestic abuse or human trafficking;
- specialized services for individuals with disabilities or seniors that support their ability to access or maintain housing
- recordkeeping, reporting and other activities as needed to fully and fairly administer the program.

3. To the extent that Grantee is making sub-awards from this award, Grantee shall develop and use a template for sub-awards that will be subject to review and approval by GOFERR before use to ensure that sub-awards contain adequate provisions that the funds can only be used for allowable costs under Section 501 and compliance with 2 C.F.R. 200.331 – 200.333 requirements. All sub-awards must be reviewed and approved by GOFERR.

#### 4. Reporting:

4.1 Grantee will work with the GOFERR to support a comprehensive reporting platform and dashboard on the GOFERR website.

4.2 Grantee shall submit monthly reports to the GOFERR grant officer by email or other electronic means subsequently designated by GOFERR to ensure timely program administration and assistance. The monthly reports, the specific elements to be designated by the GOFERR, shall track assistance provided by town and administrative budget expenditures for the prior month.

4.3 Grantee shall provide quarterly reports electronically to the GOFERR grant officer by email or other electronic means subsequently designated by GOFERR detailing the uses of grant funds to date as necessary to comply with federal laws, regulations and guidance. Grantee shall include in such reports expenses and costs related to Housing Stability Services for which the grant funds have been used, and shall

break down the reporting by residential unit location at the town level for assistance provided.

5. **Record Retention:** Between the Effective Date and the date five (5) years after the Completion Date the Grantee shall keep, or require to be kept by sub-recipients, detailed records of all services performed in connection with the Grant including all applications for assistance, supporting documents for recommendations and notices of awards. At any time during the Grantee's normal business hours, and as often as the GOFERR, the U.S. Department of Treasury or OMB shall demand, the Grantee shall make available to the GOFERR, the U.S. Department of Treasury or OMB all records pertaining to matters covered by this Contract. The Grantee shall permit the GOFERR, the U.S. Department of Treasury or OMB to audit, examine, and reproduce such records, and to make audits of all contracts, invoices, materials, payrolls, records of personnel, data, and other information relating to all matters covered by this Grant. As used in this paragraph, "Grantee" includes all persons, natural or fictional, affiliated with, controlled by, or under common ownership with, the entity identified as the Grantee.

6. Except as specifically provided by GOFERR in writing, in no event can reimbursement be made for Housing Stability Services expenses incurred beyond June 30, 2023.

7. **Administrative Expenses:** Grantee shall provide a proposed budget for administrative expenses, which may include direct and indirect costs as allowed by 2 CFR 200, Subpart E, Cost Principles.

8. **Unique entity identifier and System for Award Management (SAM)—Required.** Grantee must (i) be registered in SAM; (ii) provide a valid unique entity identifier; and (iii) continue to maintain an active SAM registration with current information at all times during which it has an active Federal award or an application or plan under consideration by a Federal awarding agency. EXHIBIT I and J should be returned completed with the executed Grant Agreement, and must be received completed before any disbursement can be made. This requirement must be passed through to sub-recipients.

9. The U.S. Treasury guidance on allowable uses of Emergency Rental Assistance Funds and U.S. Treasury Answers to Frequently Asked Questions (FAQ's) regarding allowable uses of Emergency Rental Assistance Funds are incorporated herein and made part of this Agreement as if set forth in full.

The U.S. Treasury may issue subsequent or further guidance on allowable uses of Emergency Rental Assistance Funds. All such changes shall be considered as incorporated into this Agreement.

11. Grantee agrees to establish data privacy and security requirements as required by Section 501(g)(4).

12. Statutes and regulations prohibiting discrimination applicable to this Agreement, include, without limitation, the following:

i. Title VI of the Civil Rights Act of 1964 (42 U.S.C. §§ 2000d et seq.) and Treasury's implementing regulations at 31 C.F.R. Part 22, which prohibit discrimination on the grounds of race, color, or national origin under programs or activities receiving federal financial assistance;

ii. The Fair Housing Act, Title VIII-IX of the Civil Rights Act of 1968 (42 U.S.C. § 3601 et seq.), which prohibits discrimination in housing on the basis of race, color, national origin, sex, familial status, or disability;

iii. Section 504 of the Rehabilitation Act of 1973, as amended (29 U.S.C. § 794), which prohibits discrimination on the basis of handicap under any program or activity receiving or benefiting from federal assistance;

iv. The Age Discrimination Act of 1975, as amended (42 U.S.C. §§ 6101 et seq.) and Treasury's implementing regulations at 31 C.F.R. Part 23, which prohibit discrimination on the basis of age in programs or activities receiving federal financial assistance; and

v. The Americans with Disabilities Act of 1990, as amended (42 U.S.C. §§ 12101 et seq.), which prohibits discrimination on the basis of disability under programs, activities, and services provided or made available by state and local governments or instrumentalities or agencies thereto.

13. Publications: Any publications produced with funds from this award must display the following language: "This project [is being] [was] supported, in whole or in part by, federal award numbers BRA0012 and BRA0435 awarded to the State of New Hampshire by the U.S. Department of the Treasury."

## GRANT AGREEMENT EXHIBIT B

### Methods and Conditions of Payment

Grantee must register with the Department of Administrative Services for a State of New Hampshire vendor number (see page 1, para 1.6) in order for a payment to be issued. Registration can be done online at [https://das.nh.gov/purchasing/vendorregistration/\(S\(5wm5gw45ho4qvr55nvv2os551\)/welcome.aspx](https://das.nh.gov/purchasing/vendorregistration/(S(5wm5gw45ho4qvr55nvv2os551)/welcome.aspx). Payment will be by check or ACH, depending on the vendor registration.

1. GOFERR will pay the Grantee, the sum of \$1,773,000.00 (the Grant Amount) for expenses incurred to support access to NHERAP assistance and leverage other resources to promote housing stability.
2. The administrative costs for the Grantee, not to exceed 8.5%, is included in the total for the program. This cap on administrative costs is a total administrative cost cap that includes 1% reserved for Grantee and 7.5% reserved for Grantee's subawardees.
3. Grantee shall provide GOFERR with monthly reports of expenses actually incurred and shall return any unexpended funds within 30 days of the Completion Date.

## GRANT AGREEMENT EXHIBIT C

### Special Provisions

1. Fund payments are largely subject to the requirements of the Uniform Guidance (2 C.F.R. Part 200). Grantee shall refer to the Assistance Listing for details on the specific provisions of the Uniform Guidance that do not apply, which is available on beta.SAM.gov. The applicable provisions of 2 C.F.R. Part 200 as amended are considered legally binding and enforceable documents under this contract. The GOFERR reserves the right to use any legal remedy at its disposal including, but not limited to, disallowance of costs or withholding of funds.

2. To the extent required to comply with 2 CFR 200, Subpart F - Audit Requirements, Grantee shall complete an audit at the end of the Grantee's fiscal year when the award was spent.

The audit report shall include a schedule of prior year's questioned costs along with a response to the current status of the prior year's questioned costs. Copies of all management letters written as a result of the audit along with the audit report shall be forwarded to GOFERR within one month of the time of receipt by the Grantee accompanied by an action plan, if applicable, for each finding or questioned cost.

3. The costs charged under this contract shall be determined as allowable under the direct cost principles detailed in 2 CFR 200 Subpart E - Cost Principles.

4. Program and financial records pertaining to this contract shall be retained by the Grantee for 5 (five) years from the date of submission of the final expenditure report as per requirements from the Treasury Office of Inspector General.

5. The following paragraphs shall be added to the general provisions:

"23. RESTRICTION ON ADDITIONAL FUNDING. It is understood and agreed between the parties that no portion of the "Grant" funds may be used for the purpose of obtaining additional Federal funds under any other law of the United States, except if authorized under that law."

"24. ASSURANCES/CERTIFICATIONS. The following are attached and signed: Certification Regarding Drug-Free Workplace Requirements; Certification Regarding Lobbying; Certification Regarding Debarment, Suspension and Other Responsibility Matters; Certification Regarding the Americans With Disabilities Act Compliance; Certification Regarding Environmental Tobacco Smoke; Assurance of Compliance Nondiscrimination in Federally Assisted Programs; and Certification Regarding the Federal Funding Accountability and Transparency Compliance."

"25. COPELAND ANTI-KICKBACK ACT. All contracts in excess of \$2,000.00 for construction or repair using funds under this grant shall include a provision for compliance with Copeland "Anti-Kickback" Act (18 USC 874) as supplemented in Department of Labor Regulations (29 CFR, Part 3). This Act provides that each Grantee, subcontractor or subgrantee shall be prohibited from inducing, by any means, any person employed in the construction, completion or repair of public work, to give up any part of the compensation to which he is otherwise entitled. The Grantee should report all suspected violations to GOFERR."

**"26. CLOSE OUT OF CONTRACT.** By July 30, 2023 Grantee shall submit a final report electronically to the GOFERR grant officer by e-mail or other electronic means subsequently designated by GOFERR of the uses of the grant funds through June 30, 2023, and shall break down the reporting by facility location at the town level. In the event that Grantee has not demonstrated that the grant funds have not been expended for allowable costs of at least the amount of this grant, the excess grant funds shall be returned with the final report to GOFERR, by check payable to Treasurer, State of New Hampshire.

6. Because the Grantee is a public instrumentality of the State entity organized as a body corporate and politic under RSA 204-C:2, the following paragraphs shall be deleted from the general provisions:

**"14. INDEMNIFICATION.** The Grantee shall defend, indemnify and hold harmless the GOFERR, its officers and employees, from and against any and all losses suffered by the GOFERR, its officers and employees, and any and all claims, liabilities or penalties asserted against the GOFERR, its officers and employees, by or on behalf of any person, on account of, based on, resulting from, arising out of (or which may be claimed to arise out of) the acts or omissions of the Grantee or subcontractor, or subgrantee or other agent of the Grantee. Notwithstanding the foregoing, nothing herein contained shall be deemed to constitute a waiver of the sovereign immunity of the GOFERR, which immunity is hereby reserved to the GOFERR. This covenant shall survive the termination of this Agreement.

**"15. INSURANCE AND BOND.**






