Pursuant to RSA 14:30-a, VI, authorize the Department of Education (NHED) to amend an accept and expend item of Federal Funds approved by the Governor pursuant to RSA 4:45, RSA 21-P:43, and Section 4 of Executive Order 2020-04 as extended by Executive Orders 2020-05 AND 2020-08, 2020-09, 2020-10, 2020-14, 2020-15, 2020-16, 2020-17, 2020-18, 2020-20, 2020-21, 2020-23, 2020-24, 2020-25, 2021-01, 2021-02, 2021-04, 2021-05, and 2021-06 as extended to allow the NHED to extend the end date from June 30, 2023 to June 30, 2024; and to modify and reallocate the budget by transferring \$71,458.00 between classes, effective upon approval of the Fiscal Committee and the Governor and Executive Council. The acceptance of these funds was presented to Fiscal Committee on May 21, 2021 (FIS 21-130) and the Governor and Council on May 19, 2021 (Item #Y); and amended by the Fiscal Committee on November 18, 2022 (FIS 22-396) and the Governor and Council on November 22, 2022 (Item #151). 100% Federal Funds (ESSER II – CRRSA ACT 2021).

EXPLANATION

The New Hampshire Department of Education received a grant through the Elementary and Secondary School Emergency Relief (ESSER II) Fund as part of the Coronavirus Response and Relief and Supplemental Appropriations (CRRSA) Act. This program allows the state and its school districts to expend funds flexibly to meet the pressing demands created by the impact of COVID-19.

The New Hampshire Department of Education (NHED), upon receipt of regulatory and guidance documents from the US Education Department, will award CARES funds to all local education agencies (LEAs) according to a formula based on population and poverty rate (formula for Title I, A funds). The NH DOE will prepare allocations and deliver funds via the existing reporting and application software, the online Grants Management System (GMS). LEAs will submit application documents, including program assurances and allowable grant activities, through this software, enabling two-way communication and reimbursement of expenses.

The NHED will communicate allocations, guidance and regulations on allowable activities and expenditures. LEAs will submit program assurances and activities. NHDOE will review, approve or suggest edits, and LEAs will be allowed to spend available funds to be reimbursed through the reporting system.

ESSER II provides for a broad use of funds by LEAs to include items listed below:

- Any activities authorized under ESSA, IDEA, Perkins, Subtitle B of McKinney-Vento Homeless Assistance Act, Adult Education and Family Literacy Act
- Coordinate emergency response
- Support school teachers
- Ensure preparedness and coordination
- Purchase cleaning supplies
- Purchase education technology
- Mental health supports
- Remediating learning loss and providing summer learning opportunities
- Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve indoor air quality
- Other qualifying expenditures

In support of the objectives noted above, the Department commits to: adequately monitoring the formula subgrantees; assisting in the development of remote learning programming; providing technical assistance to understand new legislation and new flexibilities; supporting fiscal compliance guidance and support.

The Department has analyzed expenses accounts and based on the current rates of expenditures anticipates the need for a transfer of appropriation in some expense accounts such as personnel benefit lines and grants federal. Appropriations are available in the Intra-Agency Transfer line due to hiring challenges which have resulted in reduced costs for internal program support, as well as the DOIT and rent lines due to the housing of staff. The department will allocate those funds out for to the schools for allowable activities as well as to fund additional employee support to the grant.



Pursuant to RSA 14:30-a, VI, authorize the Department of Education (NHED) Division of Learner Support, to amend the Governor's emergency authorization granted under RSA 21-P:43; RSA 4:45; RSA 4:47; and Executive Order 2020-04, as extended by Executive Orders 2020-05, 2020-08, 2020-09, 2020-10, 2020-14, 2020-15, 2020-16, 2020-17, 2020-18, 2020-20, 2020-21, 2020-23, 2020-24, 2020-25, and 2021-01 approved by the Governor on January 30, 2021 to accept and expend Coronavirus Response and Relief and Supplemental Appropriations (CRSSA) Act, Elementary and Secondary School Emergency Relief Funds (ESSER II) in the amount of \$156,065,807 from the United States Department of Education. NHED seeks to reallocate funds between classes in the amount of \$429,525 for the purpose of allocating funds to NH public and chartered public schools for after school and summer programming opportunities, upon approval of the Fiscal Committee of the General Court and Governor and Council approvals through June 30, 2023. 100% Federal Funds.

EXPLANATION

The Department of Education obtained approval under the Governor's emergency order to receive funds from the Coronavirus Response and Relief and Supplemental Appropriations (CRRSA) Act, Elementary and Secondary School Emergency Relief Funds (ESSER II) in the amount of \$156,065,807 from the United States Department of Education to subgrant funds to local education agencies (LEAs) for allowable activities to respond to the COVID-19 pandemic. The purpose of the funding is to provide direct money to LEAs to assist in safely reopening schools, measuring and effectively addressing significant learning loss, and taking other actions to respond to the impact of COVID-19 on educators, students, and families.

The CRRSA Act ESSER II funding has the same allowable activities as the CARES Act ESSER I funds, but specifically identifies three (3) activities; these activities are marked with an asterisk (*). LEAs may use their CRRSA Act ESSER II funding on the following allowable activities:

1. Activities authorized under the federal Every Student Succeeds Act (ESSA), the Individuals with Disabilities Education Act (IDEA), the Carl D. Perkins Career and Technical Education Act of 2006, the McKinney-Vento Homeless Assistance Act, or the Adult Education and Family Literacy Act.
2. Coordination of preparedness and response efforts of local educational agencies with State, local, Tribal, and territorial public health departments, and other relevant agencies, to improve coordinated responses among such entities to prevent, prepare for, and respond to coronavirus.
3. Providing principals and other school leaders with the resources necessary to address the needs of their individual schools.
4. Activities to address the unique needs of low-income children or students, children with disabilities, English learners, racial and ethnic minorities, students experiencing homelessness, and foster care youth, including how outreach and service delivery will meet the needs of each population.
5. Developing and implementing procedures and systems to improve the preparedness and response efforts of local educational agencies.

6. Training and professional development for staff of the local educational agency on sanitation and minimizing the spread of infectious diseases.
7. Purchasing supplies to sanitize and clean the facilities of a local educational agency, including buildings operated by such agency.
8. Planning for and coordinating during long-term closures, including for how to provide meals to eligible students, how to provide technology for online learning to all students, how to provide guidance for carrying out requirements under the Individuals with Disabilities Education Act (20 U.S.C. 1401 et seq.) and how to ensure other educational services can continue to be provided consistent with all Federal, State, and local requirements.
9. Purchasing educational technology (including hardware, software, and connectivity) for students who are served by the local educational agency that aids in regular and substantive educational interaction between students and their classroom instructors, including low-income students and students with disabilities, which may include assistive technology or adaptive equipment.
10. Providing mental health services and supports.
11. Planning and implementing activities related to summer learning and supplemental afterschool programs, including providing classroom instruction or online learning during the summer months and addressing the needs of low-income students, students with disabilities, English learners, migrant students, students experiencing homelessness, and children in foster care.
12. Addressing learning loss among students, including low-income students, children with disabilities, English learners, racial and ethnic minorities, students experiencing homelessness, and children and youth in foster care, of the local educational agency, including by:
 - a. Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiating instruction.
 - b. Implementing evidence-based activities to meet the comprehensive needs of students.
 - c. Providing information and assistance to parents and families on how they can effectively support students, including in a distance learning environment.
 - d. Tracking student attendance and improving student engagement in distance education.
13. School facility repairs and improvements to enable operation of schools to reduce risk of virus transmission and exposure to environmental health hazards, and to support student health needs.
14. Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and non-mechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning, fans, control systems, and window and door repair and replacement.
15. Other activities that are necessary to maintain the operation of and continuity of services in local educational agencies and continuing to employ existing staff of the local educational agency.

Note that the USED generally does not consider the following to be an allowable use of ESSER funds:

- 1) *Subsidizing or offsetting executive salaries and benefits of individuals who are not employees of the SEA or LEAs; or*
- 2) *Expenditures related to state or local teacher or faculty unions or associations.*

NHED would like to be able to move funds from class 102 for contracted services to class 072 for grants federal so that the department can allocate funds, through a competitive grant application process, to NH public and public chartered schools for the Beyond School Enrichment Opportunity Grant. This grant is for schools to establish enrichment programming, including before, after school and summer enrichment programming opportunities for students in K-12 for the 2022-23 school year and 2023 summer. The purpose

of these grants is to provide students with the opportunity to participate in highly engaging, enrichment programming that supports students' social, emotional, and academic needs in a before, after or summer school setting. 


