REQUESTED ACTION

Authorize the Department of Education to amend an existing **sole source** contract with FACTS Education Solutions, LLC., Lincoln, NE, (Vendor Code 368095), by increasing the price limitation by \$1,029,078.70 from \$1,906,951.16 to \$2,936,029.86 with no change to the program end date, to continue providing educational programming and services for students to address the academic impacts of the COVID-19 pandemic at nonpublic entities, effective upon Governor and Council approval through September 30, 2024. The original contract was approved by Governor and Council on August 18, 2021, item #104, and amended on October 19, item #90. 100% Federal Funds.

Funds are available in the account titled EANS II-ARP Act (EANS II) for FY24 as follows:

EXPLANATION

This amendment is **sole source** because the original item was **sole source**, additional funds are being added and there are numerous changes to the scope of work. The purpose of the EANS I and EANS II programs is to provide services or assistance to eligible non-public schools to address the impact of the COVID-19 pandemic. As a part of the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSA Act) Public Law 116-260 and the American Rescue Plan Act, 2021, (ARP Act) Public Law 117-2, Congress collectively set aside \$5.5 billion of the Governor's Emergency Education Relief (GEER-II) fund to specifically provide emergency assistance to students and teacher in non-public schools through the EANS programs.

Services to the Diocesan Schools will include school year educational support services consisting of staffed educator positions ("Diocesan School Year Support") and summer school program instructional services ("Diocesan Summer School Program") and to support services qualified under EANS funds to support the following based on the New Hampshire Department of Education's (NHED) EANS guidance:

1. Expanding capacity to administer coronavirus testing to effectively monitor and suppress coronavirus, to conduct surveillance and contact tracing activities, and to support other

activities related to coronavirus testing for students, teachers, and staff at the non-public school;
and


2. Initiating and maintaining education and support services or assistance for remote learning, hybrid learning, and/or to address learning loss.

Services to the Other Non-Public Schools will include school year educational support services consisting of staffed educator positions ("Other School Year Support") and summer school support services consisting of staffed educator, administrator, and support positions ("Other Summer School Support") as qualified under GEER-II requirements to support the following based on NHED's Non-Public School Education Recovery Assistance program guidance:

1. Addressing the needs of children from low-income families, children with disabilities, English learners, racial and ethnic minorities, students experiencing homelessness, and foster care youth;
2. Initiating and maintaining education and support services or assistance for remote learning, hybrid learning, and/or to address learning loss; and
3. Planning and implementing activities related to summer learning and supplemental after-school programs.

This amendment will also allow FACTS Education Solutions, LLC to continue the Summer School Program with sessions that are conducted 5 days per week for 4 weeks. Consisting of robust instructional support and an academic enrichment course offering. The Summer School Program ensures students continue with instructional intervention and academic enrichment support to maintain the academic gains they experienced during the school year and assist in filling in academic gaps, while some need an intense focus on instruction in identified skills that they have missed during the additional onset of online learning brought on by the COVID-19 pandemic. The goal of the Summer School Program is that students will have a newfound sense of confidence when they return to school and the classroom environment. Sessions will be delivered remotely.



3. Remove Exhibit C-1 Method of Payment and replace with Exhibit C-2 Method of Payment.
4. All other provisions of this agreement shall remain in full force and effect as originally set forth; and
5. This amendment shall commence upon Governor and Council approval and shall terminate on September 30, 2024

This modification of an existing agreement is hereby incorporated by reference to the existing agreement by the parties and must be attached to the said agreement.



EXHIBIT B-2
Scope of Services

1. Responsibilities of FACTS Education Solutions, LLC. (FACTS) "Contractor":
 - a) The Contractor shall deliver educational programming and services to the Diocese of Manchester Schools (the "Diocesan Schools") in accordance with all requirements under the Emergency Assistance to Non-Public Schools (EANS) Program under the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 and ARP EANS Program under the American Rescue Plan Act of 2021, and to Ashuelot Valley Academy, Brewster Academy, Bishop Brady High school, St. Charles School, St. John Regional School, The Harkness House, Tri-City Christian Academy, and Saint Patrick Academy (the "Other Non-Public Schools") in accordance with all requirements under the Governor's Emergency Education Relief (GEER-II) Fund under the American Rescue Plan Act of 2021. The services shall, at all times, be secular, neutral, and non-ideological.
 - b) The Contractor will meet with Diocesan and Other Non-Public School officials and School leaders to design and implement the educational programs and services to ensure that all services are in compliance with Federal and State guidelines.

2. Services to the Diocesan Schools will include school year educational support services consisting of staffed educator positions ("Diocesan School Year Support") and a summer school program instructional services ("Diocesan Summer School Program") and to support services qualified under EANS funds to support the following based on NHED's EANS guidance:
 - a) Expanding capacity to administer coronavirus testing to effectively monitor and suppress coronavirus, to conduct surveillance and contact tracing activities, and to support other activities related to coronavirus testing for students, teachers, and staff at the non-public school; and
 - b) Initiating and maintaining education and support services or assistance for remote learning, hybrid learning, and/or to address learning loss.

3. Services to the Other Non-Public Schools will include school year educational support services consisting of staffed educator positions ("Other School Year Support") and summer school support services consisting of staffed educator, administrator, and support positions ("Other Summer School Support") as qualified under GEER-II requirements to support the following based on NHED's Non-Public School Education Recovery Assistance program guidance:
 - a) Addressing the needs of children from low-income families, children with disabilities, English learners, racial and ethnic minorities, students experiencing homelessness, and foster care youth;
 - b) Initiating and maintaining education and support services or assistance for remote learning, hybrid learning, and/or to address learning loss; and
 - c) Planning and implementing activities related to summer learning and supplemental after-school programs.

4. Diocesan School Year Support, Other School Year Support, and Other Summer School Support

Contractor will collaborate with the Diocesan Schools to recruit and engage staff/faculty positions for school year 2023-2024 and with the Other Non-Public Schools to recruit and engage staff/faculty positions for summer 2023 and school year 2023-2024.

- a) The Contractor will monitor the hiring of positions and invoices due under the agreement to ensure the Price Limitation is not exceeded.
- b) The Contractor will hire and engage staff/faculty positions in accordance with all requirements under the EANS program.
- c) In accordance with EANS program requirements, the following types of positions are allowable:
 1. General counseling services
 2. Social and emotional counseling services
 3. Resource teachers/Social workers
 4. Teachers addressing learning loss, including for summer school
 5. Teachers reducing class size
 6. Teachers to develop student learning plans
 7. Subject matter specialists (i.e., reading, writing, math)
 8. Paraprofessionals and teacher assistants
 9. Positions that initiate and maintain education and support services
 10. Positions that assist in remote learning, hybrid learning, or address learning loss
 11. Administrators and directors for summer programming

5. Diocesan Summer School Program

Diocesan Summer School Program sessions are conducted 5 days per week for 4 weeks (Morning Remediation is conducted Monday-Friday, while Afternoon Enrichment is Monday-Thursday). Consisting of robust instructional support and an academic enrichment course offering, the Program ensures students continue with instructional intervention and academic enrichment support to maintain the academic gains they experienced during the school year and assist in filling in academic gaps, while some need an intense focus on instruction in identified skills that they have missed during the additional onset of online learning brought on by the COVID19 pandemic. The goal of the Diocesan Summer School Program is that students have a newfound sense of confidence when they return to school and the classroom environment. Sessions will be delivered remotely.

- The Diocesan summer school program will be staffed with 10 teachers serving student remotely. Program cost include all expenses associated with remote teaching, time for teacher preparation, consultation with classroom teacher and school administrators, parental engagement, and community outreach to foster student academic achievement.
- Morning remediation program will provide services for up to 78 students per day grades K-8th grade. The teacher to student ratio will not exceed 12 students to every teacher.

- The afternoon enrichment classes will serve up to 52 students per day grades K-8th grade. The teachers to student ratio will not exceed 12 students to every teacher.
- Diocesan Summer School Program positions for summer school program years 2022, 2023, 2024, and 2025 must meet the above staff/faculty type requirements per EANS requirements.





 - b) Initiating and maintaining education and support services or assistance for remote learning, hybrid learning, and/or to address learning loss.
3. School Year Education Support

Contractor will provide recruitment of staff/faculty positions to Diocesan Schools for school years 2022-2023, and 2023-2024.

- a) The Contractor will monitor the hiring of positions and invoices due under the agreement to ensure the Price Limitation is not exceeded.
- b) The Contractor shall provide recruitment of staff/faculty positions in accordance with all requirements under the EANS program.
- c) In accordance with EANS program requirements, the following types of positions are allowable:

Summer School Program sessions are conducted 5 days per week for 4 weeks (Morning Remediation is conducted Monday-Friday, while Afternoon Enrichment is Monday-Thursday). Consisting of robust instructional support and an academic enrichment course offering, the Summer School ensures students continue with instructional intervention and academic enrichment support to maintain the academic gains they experienced during the school year and assist in filling in academic gaps, while some need an intense focus on instruction in identified skills that they have missed during the additional onset of online learning brought on by the COVID19 pandemic. The goal of the Summer School Program is that students have a newfound sense of confidence when they return to school and the classroom environment. Sessions will be delivered remotely.

- The summer school program will be staffed with ten (10) teachers serving student remotely. Program cost include all expenses associated with remote teaching, time for teacher preparation, consultation with classroom teacher and school administrators, parental engagement, and community outreach to foster student academic achievement.
- Morning remediation program will provide services for up to 78 students per day grades K-8th grade. The teacher to student ratio will not exceed twelve students to every teacher.
- The afternoon enrichment classes will serve up to 52 students per day grades K-8th grade. The teachers to student ratio will not exceed twelve students to every teacher.
- Summer School Program positions for summer school program years 2022, 2023, 2024, and 2025 must meet the above staff/faculty type requirements per EANS requirements.



The purpose of the EANS program is to provide services or assistance to eligible non-public schools to address the impact that the Coronavirus Disease 2019 (COVID-19) has had, and continues to have, on non-public school students and teachers in the state. As part of the Coronavirus Response and Relief Supplemental Appropriations Act, 2021, (CRRSA Act) Public Law 116-260, Congress set aside \$2.75 billion of the Governor's Emergency Education Relief Fund specifically to provide emergency assistance to students and teachers in non-public schools through the Emergency Assistance to Non-public Schools (EANS) program.


Services to the Diocesan Schools provided by FACTS Education Solutions will include school year educational support services consisting of staffed educator positions ("School Year Education Support") and a summer school program instructional services ("Summer School Program") and to support services qualified under EANS funds to support the following based on NHDOE's EANS guidance:

1. Expanding capacity to administer coronavirus testing to effectively monitor and suppress coronavirus, to conduct surveillance and contact tracing activities, and to support other activities related to coronavirus testing for students, teachers, and staff at the non-public school;
2. Initiating and maintaining education and support services or assistance for remote learning, hybrid learning, and/or to address learning loss.

FACTS Education Solutions will also provide a Summer School Program with sessions that are conducted 5 days per week for 4 weeks. Consisting of robust instructional support and an academic enrichment course offerings, the Summer School ensures students continue with instructional intervention and academic enrichment support to maintain the academic gains they experienced during the school year and assist in filling in academic gaps, while some need an intense focus on instruction in identified skills that they have missed during the additional onset of online learning brought on by the COVID19 pandemic. The goal of the Summer School Program is that students will have a newfound sense of confidence when they return to school and the classroom environment. Sessions will be delivered remotely.

In the event that Federal Funds become no longer available, General Funds will not be requested to support this program.





2. SERVICES TO BE PERFORMED. The State of New Hampshire, acting through the agency identified in block 1.1 ("State"), engages contractor identified in block 1.3 ("Contractor") to perform, and the Contractor shall perform, the work or sale of goods, or both, identified and more particularly described in the attached EXHIBIT B which is incorporated herein by reference ("Services").

3. EFFECTIVE DATE/COMPLETION OF SERVICES.

3.1 Notwithstanding any provision of this Agreement to the contrary, and subject to the approval of the Governor and Executive Council of the State of New Hampshire, if applicable, this Agreement, and all obligations of the parties hereunder, shall become effective on the date the Governor and Executive Council approve this Agreement as indicated in block 1.17, unless no such approval is required, in which case the Agreement shall become effective on the date the Agreement is signed by the State Agency as shown in block 1.13 ("Effective Date").

3.2 If the Contractor commences the Services prior to the Effective Date, all Services performed by the Contractor prior to the Effective Date shall be performed at the sole risk of the Contractor, and in the event that this Agreement does not become effective, the State shall have no liability to the Contractor, including without limitation, any obligation to pay the Contractor for any costs incurred or Services performed. Contractor must complete all Services by the Completion Date specified in block 1.7.

4. CONDITIONAL NATURE OF AGREEMENT.

Notwithstanding any provision of this Agreement to the contrary, all obligations of the State hereunder, including, without limitation, the continuance of payments hereunder, are contingent upon the availability and continued appropriation of funds affected by any state or federal legislative or executive action that reduces, eliminates or otherwise modifies the appropriation or availability of funding for this Agreement and the Scope for Services provided in EXHIBIT B, in whole or in part. In no event shall the State be liable for any payments hereunder in excess of such available appropriated funds. In the event of a reduction or termination of appropriated funds, the State shall have the right to withhold payment until such funds become available, if ever, and shall have the right to reduce or terminate the Services under this Agreement immediately upon giving the Contractor notice of such reduction or termination. The State shall not be required to transfer funds from any other account or source to the Account identified in block 1.6 in the event funds in that Account are reduced or unavailable.

5. CONTRACT PRICE/PRICE LIMITATION/ PAYMENT.

5.1 The contract price, method of payment, and terms of payment are identified and more particularly described in EXHIBIT C which is incorporated herein by reference.

5.2 The payment by the State of the contract price shall be the only and the complete reimbursement to the Contractor for all expenses, of whatever nature incurred by the Contractor in the performance hereof, and shall be the only and the complete

compensation to the Contractor for the Services. The State shall have no liability to the Contractor other than the contract price.

5.3 The State reserves the right to offset from any amounts otherwise payable to the Contractor under this Agreement those liquidated amounts required or permitted by N.H. RSA 80:7 through RSA 80:7-c or any other provision of law.

5.4 Notwithstanding any provision in this Agreement to the contrary, and notwithstanding unexpected circumstances, in no event shall the total of all payments authorized, or actually made hereunder, exceed the Price Limitation set forth in block 1.8.

6. COMPLIANCE BY CONTRACTOR WITH LAWS AND REGULATIONS/ EQUAL EMPLOYMENT OPPORTUNITY.

6.1 In connection with the performance of the Services, the Contractor shall comply with all applicable statutes, laws, regulations, and orders of federal, state, county or municipal authorities which impose any obligation or duty upon the Contractor, including, but not limited to, civil rights and equal employment opportunity laws. In addition, if this Agreement is funded in any part by monies of the United States, the Contractor shall comply with all federal executive orders, rules, regulations and statutes, and with any rules, regulations and guidelines as the State or the United States issue to implement these regulations. The Contractor shall also comply with all applicable intellectual property laws.

6.2 During the term of this Agreement, the Contractor shall not discriminate against employees or applicants for employment because of race, color, religion, creed, age, sex, handicap, sexual orientation, or national origin and will take affirmative action to prevent such discrimination.

6.3 The Contractor agrees to permit the State or United States access to any of the Contractor's books, records and accounts for the purpose of ascertaining compliance with all rules, regulations and orders, and the covenants, terms and conditions of this Agreement.

7. PERSONNEL.


7.1 The Contractor shall at its own expense provide all personnel necessary to perform the Services. The Contractor warrants that all personnel engaged in the Services shall be qualified to perform the Services, and shall be properly licensed and otherwise authorized to do so under all applicable laws.

7.2 Unless otherwise authorized in writing, during the term of this Agreement, and for a period of six (6) months after the Completion Date in block 1.7, the Contractor shall not hire, and shall not permit any subcontractor or other person, firm or corporation with whom it is engaged in a combined effort to perform the Services to hire, any person who is a State employee or official, who is materially involved in the procurement, administration or performance of this Agreement. This provision shall survive termination of this Agreement.

7.3 The Contracting Officer specified in block 1.9, or his or her successor, shall be the State's representative. In the event of any dispute concerning the interpretation of this Agreement, the Contracting Officer's decision shall be final for the State.

8. EVENT OF DEFAULT/REMEDIES.

8.1 Any one or more of the following acts or omissions of the Contractor shall constitute an event of default hereunder ("Event of Default"):

8.1.1 failure to perform the Services satisfactorily or on schedule;

8.1.2 failure to submit any report required hereunder; and/or

8.1.3 failure to perform any other covenant, term or condition of this Agreement.

8.2 Upon the occurrence of any Event of Default, the State may take any one, or more, or all, of the following actions:

8.2.1 give the Contractor a written notice specifying the Event of Default and requiring it to be remedied within, in the absence of a greater or lesser specification of time, thirty (30) days from the date of the notice; and if the Event of Default is not timely cured, terminate this Agreement, effective two (2) days after giving the Contractor notice of termination;

8.2.2 give the Contractor a written notice specifying the Event of Default and suspending all payments to be made under this Agreement and ordering that the portion of the contract price which would otherwise accrue to the Contractor during the period from the date of such notice until such time as the State determines that the Contractor has cured the Event of Default shall never be paid to the Contractor;

8.2.3 give the Contractor a written notice specifying the Event of Default and set off against any other obligations the State may owe to the Contractor any damages the State suffers by reason of any Event of Default; and/or

8.2.4 give the Contractor a written notice specifying the Event of Default, treat the Agreement as breached, terminate the Agreement and pursue any of its remedies at law or in equity, or both.

8.3. No failure by the State to enforce any provisions hereof after any Event of Default shall be deemed a waiver of its rights with regard to that Event of Default, or any subsequent Event of Default. No express failure to enforce any Event of Default shall be deemed a waiver of the right of the State to enforce each and all of the provisions hereof upon any further or other Event of Default on the part of the Contractor.

9. TERMINATION.

9.1 Notwithstanding paragraph 8, the State may, at its sole discretion, terminate the Agreement for any reason, in whole or in part, by thirty (30) days written notice to the Contractor that the State is exercising its option to terminate the Agreement.

9.2 In the event of an early termination of this Agreement for any reason other than the completion of the Services, the Contractor shall, at the State's discretion, deliver to the Contracting Officer, not later than fifteen (15) days after the date of termination, a report ("Termination Report") describing in detail all Services performed, and the contract price earned, to and including the date of termination. The form, subject matter, content, and number of copies of the Termination Report shall be identical to those of any Final Report described in the attached EXHIBIT B. In addition, at the State's discretion, the Contractor shall, within 15 days of notice of early termination, develop and

submit to the State a Transition Plan for services under the Agreement.

10. DATA/ACCESS/CONFIDENTIALITY/PRESERVATION.

10.1 As used in this Agreement, the word "data" shall mean all information and things developed or obtained during the performance of, or acquired or developed by reason of, this Agreement, including, but not limited to, all studies, reports, files, formulas, surveys, maps, charts, sound recordings, video recordings, pictorial reproductions, drawings, analyses, graphic representations, computer programs, computer printouts, notes, letters, memoranda, papers, and documents, all whether finished or unfinished.

10.2 All data and any property which has been received from the State or purchased with funds provided for that purpose under this Agreement, shall be the property of the State, and shall be returned to the State upon demand or upon termination of this Agreement for any reason.

10.3 Confidentiality of data shall be governed by N.H. RSA chapter 91-A or other existing law. Disclosure of data requires prior written approval of the State.

11. CONTRACTOR'S RELATION TO THE STATE. In the performance of this Agreement the Contractor is in all respects an independent contractor, and is neither an agent nor an employee of the State. Neither the Contractor nor any of its officers, employees, agents or members shall have authority to bind the State or receive any benefits, workers' compensation or other emoluments provided by the State to its employees.

12. ASSIGNMENT/DELEGATION/SUBCONTRACTS.

12.1 The Contractor shall not assign, or otherwise transfer any interest in this Agreement without the prior written notice, which shall be provided to the State at least fifteen (15) days prior to the assignment, and a written consent of the State. For purposes of this paragraph, a Change of Control shall constitute assignment. "Change of Control" means (a) merger, consolidation, or a transaction or series of related transactions in which a third party, together with its affiliates, becomes the direct or indirect owner of fifty percent (50%) or more of the voting shares or similar equity interests, or combined voting power of the Contractor, or (b) the sale of all or substantially all of the assets of the Contractor.

12.2 None of the Services shall be subcontracted by the Contractor without prior written notice and consent of the State. The State is entitled to copies of all subcontracts and assignment agreements and shall not be bound by any provisions contained in a subcontract or an assignment agreement to which it is not a party.

13. INDEMNIFICATION. Unless otherwise exempted by law, the Contractor shall indemnify and hold harmless the State, its officers and employees, from and against any and all claims, liabilities and costs for any personal injury or property damages, patent or copyright infringement, or other claims asserted against the State, its officers or employees, which arise out of (or which may be claimed to arise out of) the acts or omission of the

Contractor, or subcontractors, including but not limited to the negligence, reckless or intentional conduct. The State shall not be liable for any costs incurred by the Contractor arising under this paragraph 13. Notwithstanding the foregoing, nothing herein contained shall be deemed to constitute a waiver of the sovereign immunity of the State, which immunity is hereby reserved to the State. This covenant in paragraph 13 shall survive the termination of this Agreement.

14. INSURANCE.

14.1 The Contractor shall, at its sole expense, obtain and continuously maintain in force, and shall require any subcontractor or assignee to obtain and maintain in force, the following insurance:

14.1.1 commercial general liability insurance against all claims of bodily injury, death or property damage, in amounts of not less than \$1,000,000 per occurrence and \$2,000,000 aggregate or excess; and

14.1.2 special cause of loss coverage form covering all property subject to subparagraph 10.2 herein, in an amount not less than 80% of the whole replacement value of the property.

14.2 The policies described in subparagraph 14.1 herein shall be on policy forms and endorsements approved for use in the State of New Hampshire by the N.H. Department of Insurance, and issued by insurers licensed in the State of New Hampshire.

14.3 The Contractor shall furnish to the Contracting Officer identified in block 1.9, or his or her successor, a certificate(s) of insurance for all insurance required under this Agreement. Contractor shall also furnish to the Contracting Officer identified in block 1.9, or his or her successor, certificate(s) of insurance for all renewal(s) of insurance required under this Agreement no later than ten (10) days prior to the expiration date of each insurance policy. The certificate(s) of insurance and any renewals thereof shall be attached and are incorporated herein by reference.

15. WORKERS' COMPENSATION.

15.1 By signing this agreement, the Contractor agrees, certifies and warrants that the Contractor is in compliance with or exempt from, the requirements of N.H. RSA chapter 281-A ("*Workers' Compensation*").

15.2 To the extent the Contractor is subject to the requirements of N.H. RSA chapter 281-A, Contractor shall maintain, and require any subcontractor or assignee to secure and maintain, payment of Workers' Compensation in connection with activities which the person proposes to undertake pursuant to this Agreement. The Contractor shall furnish the Contracting Officer identified in block 1.9, or his or her successor, proof of Workers' Compensation in the manner described in N.H. RSA chapter 281-A and any applicable renewal(s) thereof, which shall be attached and are incorporated herein by reference. The State shall not be responsible for payment of any Workers' Compensation premiums or for any other claim or benefit for Contractor, or any subcontractor or employee of Contractor, which might arise under applicable State of New Hampshire Workers' Compensation laws in connection with the performance of the Services under this Agreement.

16. NOTICE. Any notice by a party hereto to the other party shall be deemed to have been duly delivered or given at the time of mailing by certified mail, postage prepaid, in a United States Post Office addressed to the parties at the addresses given in blocks 1.2 and 1.4, herein.

17. AMENDMENT. This Agreement may be amended, waived or discharged only by an instrument in writing signed by the parties hereto and only after approval of such amendment, waiver or discharge by the Governor and Executive Council of the State of New Hampshire unless no such approval is required under the circumstances pursuant to State law, rule or policy.

18. CHOICE OF LAW AND FORUM. This Agreement shall be governed, interpreted and construed in accordance with the laws of the State of New Hampshire, and is binding upon and inures to the benefit of the parties and their respective successors and assigns. The wording used in this Agreement is the wording chosen by the parties to express their mutual intent, and no rule of construction shall be applied against or in favor of any party. Any actions arising out of this Agreement shall be brought and maintained in New Hampshire Superior Court which shall have exclusive jurisdiction thereof.

19. CONFLICTING TERMS. In the event of a conflict between the terms of this P-37 form (as modified in EXHIBIT A) and/or attachments and amendment thereof, the terms of the P-37 (as modified in EXHIBIT A) shall control.

20. THIRD PARTIES. The parties hereto do not intend to benefit any third parties and this Agreement shall not be construed to confer any such benefit.

21. HEADINGS. The headings throughout the Agreement are for reference purposes only, and the words contained therein shall in no way be held to explain, modify, amplify or aid in the interpretation, construction or meaning of the provisions of this Agreement.

22. SPECIAL PROVISIONS. Additional or modifying provisions set forth in the attached EXHIBIT A are incorporated herein by reference.

23. SEVERABILITY. In the event any of the provisions of this Agreement are held by a court of competent jurisdiction to be contrary to any state or federal law, the remaining provisions of this Agreement will remain in full force and effect.

24. ENTIRE AGREEMENT. This Agreement, which may be executed in a number of counterparts, each of which shall be deemed an original, constitutes the entire agreement and understanding between the parties, and supersedes all prior agreements and understandings with respect to the subject matter hereof.

4. Summer School Program Instructional Services Summer School Program

Summer School Program sessions are conducted 5 days per week for 4 weeks. Consisting of robust instructional support and an academic enrichment course offerings, the Summer School ensures students continue with instructional intervention and academic enrichment support to maintain the academic gains they experienced during the school year and assist in filling in academic gaps, while some need an intense focus on instruction in identified skills that they have missed during the additional onset of online learning brought on by the COVID19 pandemic. The goal of the Summer School Program is that students have a newfound sense of confidence when they return to school and the classroom environment. Sessions will be delivered remotely.

- The summer school program will be staffed with ten (10) teachers serving student remotely. Program cost include all expenses associated with remote teaching, time for teacher preparation, consultation with classroom teacher and school administrators, parental engagement, and community outreach to foster student academic achievement.
- Morning remediation program will provide services for up to 78 students per day grades K-8th grade. The teacher to student ratio will not exceed twelve students to every teacher.
- The afternoon enrichment classes will serve up to 52 students per day grades K-8th grade. The teachers to student ratio will not exceed twelve students to every teacher.


