REQUESTED ACTION

That approval be and hereby is given to the Attorney General to reappoint Lynda W. Ruel, Position #9U314 (Appropriation #02-20-20-200510-2616-500134), as Director of the Office of Victim/Witness Assistance at a salary level of \$102,518 (LG FF, Step 7), effective upon Governor and Executive Council approval, or June 30, 2023, whichever is later, for a term ending June 30, 2028.

EXPLANATION

Ms. Ruel, a resident of Center Tuftonboro, graduated from Springfield College with a bachelor's degree in human services and a minor in Criminal Justice. She has more than 25 years of experience serving New Hampshire crime victims and witnesses. Prior to joining the Attorney General's Office in 2004, Ms. Ruel was a victim/witness advocate at the University of New Hampshire and a victim/witness specialist for State Police Major Crime Unit's Family Services Section. She was appointed to her current position as Director of the Office of Victim/Witness Assistance in 2014. Her assignment and salary will remain the same. A copy of her resume is attached.
