Dear Governor Sununu and Council:

I am pleased to present to you the 178th Annual Report of the Bank Commissioner. As required by RSA 383:15, this report contains information on each entity under the supervision of the Banking Department. Additionally, the report includes information about the Banking Department's operations, applications and notices filed with the Banking Department, and financial information about chartered entities.

The overall financial condition of New Hampshire-chartered banks and credit unions remained good and they continued to be managed by seasoned professionals. In 2022, the Banking Department issued a charter to the first mutual savings bank established in New Hampshire since the early 1900s, and in the country since the 1970s. Additionally, there was an overall net gain in the number of branch offices providing New Hampshire consumers with access to a wide variety of banking services.

The state-chartered non-depository trust companies continued to grow in number and in size with Assets Under Administration by this sector surpassing the \$1.1 trillion mark. The Trust Supervision Division sought opportunities to improve efficiency and effectiveness through a risk-focused examination process and advanced trust audit, compliance, and risk management training for examination staff.

Licensed consumer credit companies continue to expand in New Hampshire, which is consistent with nationwide trends. The Consumer Credit Division continued to transition all licensed entities to the Nationwide Multistate Licensing System and to conduct examinations through the State Examination System. Both national platforms have allowed the Banking Department to improve coordination with state and federal regulators and helped facilitate information sharing for enhanced regulation of licensees that operate in multiple states.



Foreword

The one hundred seventy-eighth annual report of the Bank Commissioner contains management, financial information and locations of banks, credit unions, and other financial institutions operating under state charter. This report also contains information concerning debt adjusters, money transmitters, mortgage bankers and brokers, mortgage servicers, retail sellers, sales finance companies, and small loan lenders.

Mission Statement

The New Hampshire Banking Department is committed to protecting the public's interest through the professional supervision of the financial services it regulates.

Functions of the Banking Department

The Bank Commissioner is responsible for the general supervision of all New Hampshire chartered and licensed financial institutions through the operation of the New Hampshire Banking Department. The Banking Department contains five divisions: Banking, Trust Supervision, Consumer Credit, Legal, and Operations.

The Banking and Trust Supervision Divisions charter, supervise, and examine all state-chartered banks, credit unions, trust companies, and family trust companies in New Hampshire.

The Consumer Credit Division licenses, examines, and regulates companies that provide consumer credit, such as mortgage bankers, mortgage brokers, mortgage servicers, retail auto sellers, sales finance companies, money transmitters, debt adjusters, and small loan lenders.

Working in conjunction with the Banking, Trust Supervision, and Consumer Credit Divisions, the Legal Division investigates consumer complaints and unlicensed or unchartered activity. The Legal Division may commence enforcement actions against financial entities that violate state or federal laws or regulations. The Bank Commissioner has the authority to order consumer restitution as part of those enforcement actions.

The Operations Division supports the daily functions of the Banking Department.

* On November 4, 2019, the federal banking agencies jointly issued a final rule that provides for an optional, simplified measure of capital adequacy, the community bank leverage ratio (CBLR) framework, for qualifying community banking organizations, consistent with Section 201 of the Economic Growth, Regulatory Relief, and Consumer Protection Act. The CBLR final rule effective on January 1, 2020 allows qualifying community banking organizations having less than \$10 Billion in total consolidated assets to calculate a leverage ratio to measure capital adequacy. Banks opting into the CBLR framework will not be required to calculate or report risk-based capital. The CBLR banks shall meet the criteria of a leverage ratio >8%, off-balance sheet exposures of ≤25% of total consolidated assets, trading assets/liabilities ≤5% of total consolidated assets, and cannot be an advanced approaches bank (>\$250 Billion in consolidated assets or balance sheet exposure >\$10 Billion). A CBLR bank may opt out of the framework (without restriction). A CBLR bank that ceases to meet any qualifying criteria in a future period and that has a leverage ratio >8% will be allowed a grace period of two reporting periods to satisfy the CBLR qualifying criteria. Refer to FIL-66-2019 November 4, 2019 for details.

On April 6, 2020, the federal banking agencies announced the issuance of two interim final rules to provide temporary relief to community banking organizations. The agencies are acting to implement Section 4012 of the Coronavirus Aid, Relief, and Economic Security Act, which requires the agencies to temporarily lower the CBLR to 8%. Under the interim final rules, the CBLR will be 8% beginning in the second quarter and for the remainder of calendar year 2020, 8.5% for calendar year 2021, and 9% thereafter. There is a two-quarter grace period for a qualifying community organization whose leverage ratio falls no more than 1% below the applicable CBLR.
