REQUESTED ACTION

That approval be and hereby is given to the Attorney General to appoint Caroline Brenner to Position # 9U732, (Appropriation #02-20-20-202010-1037-014-500134) as an Assistant Deputy Medical Examiner, at a salary level of \$69,127 (Labor Grade BB, Step 2), effective upon Governor and Executive Council approval, or December 29, 2023, whichever is later.
