REQUESTED ACTION

Authorize the Department of Natural and Cultural Resources (DNCR), Division of Parks and Recreation, Cannon Mountain Ski Area to make a payment to National Ski Patrol System, (VC #172974), Lakewood, CO, in the amount of \$3,264 for membership dues effective upon Governor and Council approval for the period January 1, 2024 through December 31, 2024. 100% Other Funds (Agency Income).

EXPLANATION

Cannon Mountain (Cannon) is seeking approval of membership dues for the National Ski Patrol System to give Cannon Ski Patrollers access to the most current educational support including providing mandatory outdoor emergency care training. Founded in 1938, the National Ski Patrol System effectively drives core values of service and safety with more than 300 Ski Patrol Departments in the United States. With almost a century of training experience, the National Ski Patrol System is the premier Ski Patrol safety education resource in the nation.

Listed below are the answers to the standard questions required for Governor and Executive Council organization dues and membership approval submissions:

How long has this organization been in existence and how long has this agency been a member of this organization? **The National Ski Patrollers System was founded in 1938 and Cannon Mountain Ski Patrollers have been ongoing members since its formation. The Franconia Notch Ski Patrol Association was formed in 2017 and has been continuing yearly memberships since its creation to sustain high level safety services.**

4. How are the dues' structure established? (Standard fee for all states, based on population, based on other criteria, etc.). **The dues are a flat rate per member.**


