REQUESTED ACTION

Pursuant to MOP 1200, I.D., authorize the New Hampshire Lottery Commission (Lottery) to pay the North American Association of State and Provincial Lotteries (NASPL) (VC #206566), Concord, Ohio, the amount of \$25,000 for Calendar Year 2024 membership dues effective upon Governor and Council approval for the period of January 1, 2024, through December 31, 2024. **100% Lottery Funds.**

EXPLANATION

Listed below are answers to standard questions required for Governor and Council organization dues and membership approval submissions:


1. How long has this organization been in existence and how long has this agency been a member of this organization? *The organization was formed in 1971, and we have been a member since 1990.*

They have developed robust resources and guidelines for responsible gambling.*
