**REQUESTED ACTION**

1. Authorize the Department of Transportation to enter into a contract with Continental Paving, Inc. (Vendor 155350) of Londonderry, NH, on the basis of a single bid of \$10,011,909.25 for roadway resurfacing of two (2) sections of Tier 2 roadways in five (5) towns (Epsom, Northwood, Nottingham, Barrington and Lee) in Districts 5 and 6 (Project: Lee/Epsom-Lee #44019), from the date of Governor and Council approval through September 26, 2025, unless amended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

Funding is available in State Fiscal Years 2024 and 2025, and are anticipated to be available in State Fiscal Year 2026, as follows, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

2. Further authorize that a contingency in the amount of \$500,595.46 be approved for payment of latent conditions, which may appear during the construction of the project. The contingency requested is 5% of the contract amount.

**EXPLANATION**

This project is part of the State's Ten-Year Transportation Improvement Plan, under the Pave-T2-Resurf Program. This project is part of the Tier 2 Federal Resurfacing program and involves 21.4 miles of pavement resurfacing on two (2) sections of Tier 2 roadways in five (5) towns in Maintenance Districts 5 and 6.

- **24602 – Epsom/Northwood/Nottingham/Barrington/Lee, US 4/US 202/NH 43/NH 125, 17.3 miles Tier 2, Preservation, Various Treatments:**

US 4: From a pavement joint roughly a quarter mile west of NH 107 in Epsom (MM 76.5) easterly to a pavement joint roughly 650 feet east of the Lee Roundabout (MM 92.8). This includes the Lee Roundabout. (16.3 miles)

US 202: From the intersection of US 4 easterly to a pavement joint 250 feet west of Church Street. (0.1 miles)

NH 43: From a pavement joint 200 feet south of US 4 north to US 4. (0.1 miles)

NH 125: From the Lee Roundabout northerly to a P/J 100 feet south of Pinkham Road. (0.9 miles)

- **23625 – Lee, NH 125/NH 152, 4.1 miles Tier 2, Preservation, Various Treatments:**

NH 125: From a pavement joint 1,000 feet south of NH 152 (MM 21.8) northerly to a pavement joint 1,000 feet south of the Lee roundabout (MM 25.9). This includes 250 feet of NH 152 at the intersection with NH 125 (4.1 miles)

NH 152: From NH 125 westerly roughly 250 feet to High Street

This project will extend the life of the existing pavement and delay costlier improvements in the near future. The sections will be resurfaced via full width high strength wearing course inlay, full width bonded wearing course, spot inlays, and full width high strength wearing course overlay. Additional work efforts include guardrail upgrades, ADA curb ramp upgrades, sign replacements, and drainage structure adjustments. All impacted towns and utilities will be notified.

The proposed contingency amount is 5% of the contract amount. This project was quantified based on field observations, aerial photos, and as-built plans. Field adjustments may be required due to varying field conditions. In addition, the sections will continue to deteriorate through the 2023-2024 winter.

Although the bid costs exceeded the Department's estimate by 7.72%, the sole bid received is felt to be reasonable for the work involved. The items that contributed to the higher than anticipated bid were Item 403.11942 Pavement \$320,040, Item 417 Cold Planing \$165,931, Item 419.13 Bonded Wearing Course Pavement \$123,495, and Item 618.7 Flaggers \$94,800. Re-advertising this project would result, in our opinion, in higher prices and prevent the completion of the work in a timely manner. The

Department considers it to be in the best interest of the State to accept this bid to accomplish these needed repairs.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval, will be on file at the Department of Transportation.

This project funding is: 80% Federal funds (Pave-T2-Resurf), with anticipated utilization of Turnpike Toll Credits for the State's 20% match, effectively using 100% Federal Funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

Your approval of this resolution is respectfully requested.

**DESCRIPTION:** This project is part of the Tier 2 Federal Resurfacing program and involves 21.4 miles of pavement resurfacing on two (2) sections of Tier 2 roadways in (5) towns in Maintenance Districts 5 & 6.

US 202: From the intersection of US 4 easterly to a pavement joint 250 feet west of Church Street. (0.1 miles)

NH 43: From a pavement joint 200 feet south of US 4 north to US 4. (0.1 miles)

NH 125: From the Lee Roundabout northerly to a P/J 100 feet south of Pinkham Road. (0.9 miles)

**23625 Lee, NH 125/NH 152, 4.1 miles



**PROJECT INITIATED:** The project was initiated through the State's Ten-Year Transportation Improvement Program, Paving-Tier-2-Resurfacing. The Pavement Management Section reviewed the road segments included in this project and identified both as Preservation.

**PROJECT EXPLANATION:** This project will extend the life of the existing pavement and delay costlier improvements in the near future. The sections will be resurfaced via full width high strength wearing course inlay, full width bonded wearing course, spot inlays, and full width high strength wearing course overlay. Additional work efforts include guardrail upgrades, ADA curb ramp upgrades, sign replacements, and drainage structure adjustments. All impacted towns and utilities will be notified.

**TRAFFIC IMPLICATION:** This project will use one-lane, alternating two-way traffic, lane shifts, and shoulder closures where necessary to complete the work, supplemented with flaggers and officers. Traffic will be restored to normal patterns at the end of each workday. Night work is required for both sections of this project. Work zone significance was determined to be non-significant at the August 17, 2023 TCC Meeting.




