**REQUESTED ACTION**

Authorize the Department of Natural and Cultural Resources, Division of the Arts, to award a Public Value Partnership grant to Winnepesaukee Playhouse (VC #172499) Meredith, NH in the amount of \$13,500 to strengthen their capacity for affordable diverse arts programs to New Hampshire residents and visitors effective upon Governor and Council approval through June 30, 2024. 100% Federal Funds.

Funds are available in account, Federal Arts Partnership Grant, as follows:

**EXPLANATION**

Public Value Partnerships are awarded to nonprofit arts organizations, with a minimum of five years of continuous arts programming and professional staffing, to strengthen their capacity for offering affordable, diverse arts program to New Hampshire's residents and visitors. Grant categories and deadlines are advertised through the divisions' website, social media, and electronic newsletters.

At the time of evaluation, the NH State Art Councilors unanimously voted to accept the Arts Division's Public Value Partnership Review Panel's recommendations for the partnerships based on its funding priority ranking within a competitive review. There were fifty-four applications received and fifty-three grants were awarded. The five-member peer panel considered seventeen criteria to arrive at a consensus ranking for each application. The evaluative criteria range from the administrative capacity of the organization to artistic quality, strategic planning, community impact, and accessibility.

The Attorney General's Office has reviewed and approved the grant agreement as to form, substance and execution.




2. **SCOPE OF WORK:** In exchange for grant funds provided by the State of New Hampshire, acting through the Agency identified in block 1.1 (hereinafter referred to as "the State"), the Grantee identified in block 1.3 (hereinafter referred to as "the Grantee"), shall perform that work identified and more particularly described in the scope of work attached hereto as EXHIBIT B (the scope of work being hereinafter referred to as "the Project").

3 AREA COVERED. Except as otherwise specifically provided for herein, the  
 4 Grantee shall perform the Project in, and with respect to, the State of New  
 5 Hampshire.

6 EFFECTIVE DATE, COMPLETION OF PROJECT.  
 7 This Agreement, and all obligations of the parties hereunder, shall become  
 8 effective on the date on the date of approval of this Agreement by the Governor  
 9 and Council of the State of New Hampshire if required (block 1.16), or upon  
 10 signature by the State Agency as shown in block 1.14 ("the Effective Date").

11 Except as otherwise specifically provided herein, the Project, including all reports  
 12 required by this Agreement, shall be completed in ITS entirety prior to the date in  
 13 block 1.7 (hereinafter referred to as "the Completion Date").

14 GRANT AMOUNT; LIMITATION ON AMOUNT; VOUCHERS; PAYMENT.  
 15 The Grant Amount is identified and more particularly described in EXHIBIT C,  
 16 attached hereto.

17 The manner of, and schedule of payment shall be as set forth in EXHIBIT C.  
 18 In accordance with the provisions set forth in EXHIBIT C, and in consideration  
 19 of the satisfactory performance of the Project, as determined by the State, and as  
 20 limited by subparagraph 5.5 of these general provisions, the State shall pay the  
 21 Grantee the Grant Amount. The State shall withhold from the amount otherwise  
 22 payable to the Grantee under this subparagraph 5.3 those sums required, or  
 23 permitted, to be withheld pursuant to N.H. RSA 80:7 through 7-e.

24 The payment by the State of the Grant amount shall be the only, and the complete  
 25 payment to the Grantee for all expenses, of whatever nature, incurred by the  
 26 Grantee in the performance hereof, and shall be the only, and the complete,  
 27 compensation to the Grantee for the Project. The State shall have no liabilities to  
 28 the Grantee other than the Grant Amount.

29 Notwithstanding anything in this Agreement to the contrary, and notwithstanding  
 30 unexpected circumstances, in no event shall the total of all payments authorized,  
 31 or actually made, hereunder exceed the Grant limitation set forth in block 1.8 of  
 32 these general provisions.

33 COMPLIANCE BY GRANTEE WITH LAWS AND REGULATIONS. In  
 34 connection with the performance of the Project the Grantee shall comply with all  
 35 statutes, laws, regulations, and orders of federal, state, county, or municipal  
 36 authorities which shall impose any obligations or duty upon the Grantee, including  
 37 the acquisition of any and all necessary permits and RSA 31-95-b.

38 RECORDS and ACCOUNTS.  
 39 Between the Effective Date and the date seven (7) years after the Completion  
 40 Date, unless otherwise required by the grant terms of the Agency, the Grantee  
 41 shall keep detailed accounts of all expenses incurred in connection with the  
 42 Project, including but not limited to, costs of administration, transportation,  
 43 insurance, telephone calls, and clerical materials and services. Such accounts  
 44 shall be supported by receipts, invoices, bills and other similar documents.

45 Between the Effective Date and the date seven (7) years after the Completion  
 46 Date, unless otherwise required by the grant terms of the Agency pursuant to  
 47 subparagraph 7.1, at any time during the Grantee's normal business hours, and as  
 48 often as the State shall demand, the Grantee shall make available to the State all  
 49 records pertaining to matters covered by this Agreement. The Grantee shall  
 50 permit the State to audit, examine, and reproduce such records, and to make audits  
 51 of all contracts, invoices, materials, payrolls, records of personnel data (as that  
 52 term is hereinafter defined), and other information relating to all matters covered  
 53 by this Agreement. As used in this paragraph, "Grantee" includes all persons,  
 54 natural or fictional, affiliated with, controlled by, or under common ownership  
 55 with, the entity identified as the Grantee in block 1.3 of these provisions.

56 PERSONNEL.  
 57 The Grantee shall, at its own expense, provide all personnel necessary to perform  
 58 the Project. The Grantee warrants that all personnel engaged in the Project shall  
 59 be qualified to perform such Project, and shall be properly licensed and authorized  
 60 to perform such Project under all applicable laws.

61 The Grantee shall not hire, and it shall not permit any subcontractor, subgrantee,  
 62 or other person, firm or corporation with whom it is engaged in a combined effort  
 63 to perform the Project, to hire any person who has a contractual relationship with  
 64 the State, or who is a State officer or employee, elected or appointed.

65 The Grant Officer shall be the representative of the State hereunder. In the event  
 66 of any dispute hereunder, the interpretation of this Agreement by the Grant  
 67 Officer, and his/her decision on any dispute, shall be final.

68 DATA; RETENTION OF DATA; ACCESS.  
 69 As used in this Agreement, the word "data" shall mean all information and things  
 70 developed or obtained during the performance of, or acquired or developed by  
 71 reason of, this Agreement, including, but not limited to, all studies, reports, files,  
 72 formulae, surveys, maps, charts, sound recordings, video recordings, pictorial  
 73 reproductions, drawings, analyses, graphics representations,

computer programs, computer printouts, notes, letters, memoranda, paper, and  
 documents, all whether finished or unfinished.

74 Between the Effective Date and the Completion Date the Grantee shall grant to  
 75 the State, or any person designated by it, unrestricted access to all data for  
 76 examination, duplication, publication, translation, sale, disposal, or for any other  
 77 purpose whatsoever.

78 No data shall be subject to copyright in the United States or any other country by  
 79 anyone other than the State.

80 On and after the Effective Date all data, and any property which has been received  
 81 from the State or purchased with funds provided for that purpose under this  
 82 Agreement, shall be the property of the State, and shall be returned to the State  
 83 upon demand or upon termination of this Agreement for any reason, whichever  
 84 shall first occur.

85 The State, and anyone it shall designate, shall have unrestricted authority to  
 86 publish, disclose, distribute and otherwise use, in whole or in part, all data.

87 CONDITIONAL NATURE OF AGREEMENT. Notwithstanding anything in  
 88 this Agreement to the contrary, all obligations of the State hereunder, including,  
 89 without limitation, the continuance of payments hereunder, are contingent upon  
 90 the availability or continued appropriation of funds, and in no event shall the State  
 91 be liable for any payments hereunder in excess of such available or appropriated  
 92 funds. In the event of a reduction or termination of those funds, the State shall  
 93 have the right to withhold payment until such funds become available, if ever, and  
 94 shall have the right to terminate this Agreement immediately upon giving the  
 95 Grantee notice of such termination.

96 EVENT OF DEFAULT; REMEDIES.  
 97 Any one or more of the following acts or omissions of the Grantee shall constitute  
 98 an event of default hereunder (hereinafter referred to as "Events of Default"):

99 Failure to perform the Project satisfactorily or on schedule, or  
 100 Failure to submit any report required hereunder, or  
 101 Failure to maintain, or permit access to, the records required hereunder, or  
 102 Failure to perform any of the other covenants and conditions of this Agreement.

103 Upon the occurrence of any Event of Default, the State may take any one, or more,  
 104 or all, of the following actions:

105 Give the Grantee a written notice specifying the Event of Default and requiring it  
 106 to be remedied within, in the absence of a greater or lesser specification of time,  
 107 thirty (30) days from the date of the notice; and if the Event of Default is not  
 108 timely remedied, terminate this Agreement, effective two (2) days after giving the  
 109 Grantee notice of termination; and

110 Give the Grantee a written notice specifying the Event of Default and suspending  
 111 all payments to be made under this Agreement and ordering that the portion of the  
 112 Grant Amount which would otherwise accrue to the Grantee during the period  
 113 from the date of such notice until such time as the State determines that the  
 114 Grantee has cured the Event of Default shall never be paid to the Grantee; and

115 Set off against any other obligation the State may owe to the Grantee any damages  
 116 the State suffers by reason of any Event of Default; and

117 Treat the agreement as breached and pursue any of its remedies at law or in equity,  
 118 or both.

119 TERMINATION.  
 120 In the event of any early termination of this Agreement for any reason other than  
 121 the completion of the Project, the Grantee shall deliver to the Grant Officer, not  
 122 later than fifteen (15) days after the date of termination, a report (hereinafter  
 123 referred to as the "Termination Report") describing in detail all Project Work  
 124 performed, and the Grant Amount earned to and including the date of termination.

125 In the event of Termination under paragraphs 10 or 12.4 of these general  
 126 provisions, the approval of such a Termination Report by the State shall entitle  
 127 the Grantee to receive that portion of the Grant amount earned to and including  
 128 the date of termination.

129 In the event of Termination under paragraphs 10 or 12.4 of these general  
 130 provisions, the approval of such a Termination Report by the State shall in no  
 131 event relieve the Grantee from any and all liability for damages sustained or  
 132 incurred by the State as a result of the Grantee's breach of its obligations  
 133 hereunder.

134 Notwithstanding anything in this Agreement to the contrary, either the State or,  
 135 except where notice default has been given to the Grantee hereunder, the Grantee,  
 136 may terminate this Agreement without cause upon thirty (30) days written notice.

137 CONFLICT OF INTEREST. No officer, member or employee of the Grantee,  
 138 and no representative, officer or employee of the State of New Hampshire or of  
 139 the governing body of the locality or localities in which the Project is to be  
 140 performed, who exercises any functions or responsibilities in the review of

- approval of the undertaking or carrying out of such Project, shall participate in any decision relating to this Agreement which affects his or her personal interest or the interest of any corporation, partnership, or association in which he or she is directly or indirectly interested, nor shall he or she have any personal or pecuniary interest, direct or indirect, in this Agreement or the proceeds thereof
- 14 GRANTEE'S RELATION TO THE STATE In the performance of this Agreement the Grantee, its employees, and any subcontractor or subgrantee of the Grantee are in all respects independent contractors, and are neither agents nor employees of the State. Neither the Grantee nor any of its officers, employees, agents, members, subcontractors or subgrantees, shall have authority to bind the State nor are they entitled to any of the benefits, workmen's compensation or emoluments provided by the State to its employees.
- 15 ASSIGNMENT AND SUBCONTRACTS The Grantee shall not assign, or otherwise transfer any interest in this Agreement without the prior written consent of the State. None of the Project Work shall be subcontracted or subgranted by the Grantee other than as set forth in Exhibit B without the prior written consent of the State.
- 16 INDEMNIFICATION The Grantee shall defend, indemnify and hold harmless the State, its officers and employees, from and against any and all losses suffered by the State, its officers and employees, and any and all claims, liabilities or penalties asserted against the State, its officers and employees, by or on behalf of any person, on account of, based on, resulting from, arising out of (or which may be claimed to arise out of) the acts or omissions of the Grantee or subcontractor, or subgrantee or other agent of the Grantee. Notwithstanding the foregoing, nothing herein contained shall be deemed to constitute a waiver of the sovereign immunity of the State, which immunity is hereby reserved to the State. This covenant shall survive the termination of this agreement.
- 17 INSURANCE
- 17.1 The Grantee shall, at its own expense, obtain and maintain in force, or shall require any subcontractor, subgrantee or assignee performing Project work to obtain and maintain in force, both for the benefit of the State, the following insurance:
- 17.1.1 Statutory workers compensation and employees liability insurance for all employees engaged in the performance of the Project, and
- 17.1.2 General liability insurance against all claims of bodily injuries, death or property damage, in amounts not less than \$1,000,000 per occurrence and \$2,000,000 aggregate for bodily injury at death any one incident, and \$500,000 for property damage in any one incident, and
- 17.2 The policies described in subparagraph 17.1 of this paragraph shall be the standard form employed in the State of New Hampshire, issued by underwriters acceptable to the State, and authorized to do business in the State of New Hampshire. Grantee shall furnish to the State, certificates of insurance for all renewal(s) of insurance required under this Agreement (no later than ten (10) days prior to the expiration date of each insurance policy).
- 18 WAIVER OF BREACH No failure by the State to enforce any provisions hereof after any Event of Default shall be deemed a waiver of its rights with regard to that Event, or any subsequent Event. No express waiver of any Event of Default shall be deemed a waiver of any provisions hereof. No such failure of waiver shall be deemed a waiver of the right of the State to enforce each and all of the provisions hereof upon any further or other default on the part of the Grantee.
- 19 NOTICE Any notice by a party hereto to the other party shall be deemed to have been duly delivered or given at the time of mailing by certified mail, postage prepaid, in a United States Post Office addressed to the parties at the addresses first above given.
- 20 AMENDMENT This Agreement may be amended, waived or discharged only by an instrument in writing signed by the parties hereto and only after approval of such amendment, waiver or discharge by the Governor and Council of the State of New Hampshire, if required or by the signing State Agency.
- 21 CONSTRUCTION OF AGREEMENT AND TERMS This Agreement shall be construed in accordance with the law of the State of New Hampshire, and is binding upon and inures to the benefit of the parties and their respective successors and assignees. The captions and contents of the "subject" blank are used only as a matter of convenience, and are not to be considered a part of this Agreement or to be used in determining the intent of the parties hereto.
- 22 THIRD PARTIES The parties hereto do not intend to benefit any third parties and this Agreement shall not be construed to confer any such benefit.
- 23 ENTIRE AGREEMENT This Agreement, which may be executed in a number of counterparts, each of which shall be deemed an original, constitutes the entire agreement and understanding between the parties, and supersedes all prior agreements and understandings relating hereto.
- 24 SPECIAL PROVISIONS The additional or modifying provisions set forth in Exhibit A hereto are incorporated as part of this agreement.
