REQUESTED ACTION

EXPLANATION

These funds will be used by the State Police to purchase ten (10) Livescan machines. These machines will be placed in the following locations: Lancaster PD, Weare PD, Swanzey PD, Amherst PD, State Police Concord- Headquarters- (Replacement of a machine that is at end of life), New Boston PD, Newport PD, Milford PD, State Police Troop D-

Concord, and the Department of Corrections- (Replacement of a machine that is at end of life). The State of New Hampshire, at present, utilizes an Automated Fingerprint Identification System (AFIS) that electronically receives arrest and applicant fingerprint impressions and demographic data from seventy-five Livescan stations located across the state. Fifty-six state-owned Livescans recently were replaced with funds awarded through a 2018 and 2019 NCHIP grant funding, while sixteen others were independently purchased by New Hampshire law enforcement agencies and put into circulation.

The State of New Hampshire has benefitted from Livescan technology since 1997. The then state-of-the-art Livescan capability was put in use throughout the State in our correctional facilities and larger municipal law enforcement agencies. The State of New Hampshire's goal is to expand its Livescan inventory and to strategically deploy the additional Livescans to areas within the State that will benefit the most. This plan is expected to increase the State's fingerprint-supported arrest percentage, thereby expanding the FBI and the Interstate Identification Index (III) fingerprint-supported record database. Currently, the State of New Hampshire is beginning discussions to participate in the National Fingerprint File program. The increase in electronic Livescan arrest submissions will only improve the quality of our records as we move toward this goal.

According to the III compliance granted by the Federal Bureau of Investigation in 1983, the New Hampshire State Police's Criminal Records Unit is the only agency authorized to submit all criminal ten-print impressions to the FBI. All ten-print impressions, submitted via inked or electronically, by the state, county, local law enforcement agencies, and correctional facilities, are forwarded to the state police Criminal Records Unit for processing and submission to the FBI. In addition, fingerprinting is also used as an identification technique for job applicants, particularly in those circumstances where identification is critical, and/or where a determination of criminal history (or more precisely, a lack of it) is needed.

Funds are to be budgeted as follows:

Class 030 funds, Equipment, are needed to purchase ten Livescan machines.

This grant was not budgeted in SFY 2024/2025 because these funds were not anticipated or available during the development of the Department's SFY 2024/2025 biennial budget.

In the event that federal pass-through funds become no longer available, General Funds and/or Highway Funds will not be requested to support this program.

State of New Hampshire
Interagency Memorandum of Understanding

Whereas, the New Hampshire Department of Justice ("DOJ") is a duly constituted agency of the State of New Hampshire;

Whereas, the New Hampshire Department of Safety (DOS) is a duly constituted agency of the State of New Hampshire;

Whereas, DOJ is responsible for providing funding through a subgrant to DOS as herein described;

Whereas, DOJ desires to enter into a subgrant with DOS for a term from Governor and Council approval through 9/30/2024, in an amount not to exceed \$198,250;

Whereas, DOS is responsible for adhering to all conditions as set forth in the federal financial rules and all applicable state rules and regulations of procurement;

Whereas, DOS desires to purchase LiveScan digital fingerprint machines with the objective of improving the ability to collect and share accurate criminal history among law enforcement entities throughout the State of New Hampshire and nationally.

NOW THEREFORE, the parties enter into this Memorandum of Understanding to their mutual benefit, the benefit of the State and in furtherance of constitutional or statutory authority and objectives.

1. DOJ agrees to pay DOS the amount of \$198,250 for the purposes described in the attached MOU Exhibit A, which is hereby incorporated by reference. Payment shall be provided from 020-20-20-201510-3426-085-588523. Vendor # 311206 (DOS).
2. DOS agrees to carry out the services described in the attached MOU Exhibit A, which is hereby incorporated by reference.
3. The method of payment and payment amount for the above-referenced services, if any is required, is described in the attached MOU Exhibit B, such exhibit being hereby incorporated by reference.
4. All obligations hereunder are contingent upon the availability and continued appropriation of funds. The agencies shall not be required to transfer funds from any other account in the event that funds are reduced or unavailable.
5. The Memorandum of Understanding is effective until 9/30/2024.
6. DOS agrees to provide a minimum total of \$25,256 in cash match and/or in-kind match prior to the conclusion of their award. If DOS is unable to provide the required match, DOS's total awarded funds will be reduced in accordance with federal statute 2 CFR 200.306.

7. This Memorandum of Understanding may be amended by an instrument in writing signed by both parties. Either party may terminate this agreement by providing written notice to the other party at least 30 days prior to termination.
8. The parties agree that the obligations, agreements and promises made under this Memorandum of Understanding are not intended to be legally binding on the parties and are not legally enforceable.
9. Disputes arising under this Memorandum of Understanding which cannot be resolved between the agencies shall be referred to the Department of Justice, Civil Bureau, for review and resolution.
10. This agreement shall be construed in accordance with the laws of the State of New Hampshire.
11. The parties hereto do not intend to benefit any third parties and this Memorandum of Understanding shall not be construed to confer any such benefit.
12. In the event any of the provisions of this Memorandum of Understanding are held to be contrary to any state or federal law, the remaining provisions of this Memorandum of Understanding will remain in full force and effect.
13. This Memorandum of Understanding, which may be executed in a number of counterparts, each of which shall be deemed an original, constitutes the entire Memorandum of Understanding and understandings between the parties, and supersedes all prior Memoranda of Understanding and understandings related hereto.
14. Nothing herein shall be construed as a waiver of sovereign immunity, such immunity being hereby specifically preserved.

New Hampshire Department of Safety as the Grantee (hereinafter referred to as "Subrecipient") shall be compliant at all times with the terms, conditions and specifications detailed below, which are subject to annual review.

1. The Subrecipient must certify that Limited English Proficiency persons have meaningful access to any services provided by this program. National origin discrimination includes discrimination on the basis of limited English proficiency (LEP). Meaningful access may entail providing language assistance services, including oral and written translation when necessary. The U.S. Department of Justice has issued guidance for grantees to help them comply with these requirements. The guidance document can be accessed on the Internet at www.lep.gov.
2. The Subrecipient assures that in the event a Federal or State court or Federal or State administrative agency makes a finding of discrimination within the three years prior to the receipt of the federal financial assistance and after a due process hearing against the Subrecipient on the grounds of race, color, religion, national origin, sex, age, or disability, a copy of the finding will be submitted to the New Hampshire Department of Justice, Grants Management Unit and to the U.S. Department of Justice, Office for Civil Rights, Office of Justice Programs, 810 7th Street, NW, Washington, D.C. 20531. It will also comply with Ex. Order 13279, Equal Protection of the Laws for Faith-Based and Community Organizations; Executive Order 13559, Fundamental Principles and Policymaking Criteria for Partnerships with Faith-Based and Other Neighborhood Organizations; and the DOJ implementing regulations at 28 C.F.R. Part 38.
4. Compensation for individual consultant services is to be reasonable and consistent with that paid for similar services in the marketplace. The current consultant limit is \$650 per day or \$81.25 per hour. When the rate exceeds the limit for an 8-hour day, or a proportionate hourly rate (excluding travel and subsistence costs), a written prior approval is required. Prior approval requests require additional justification.

5. The Subrecipient agency agrees that, should they employ a former member of the NH Department of Justice (NHDOJ), that employee or their relative shall not perform work on or be billed to any federal or state subgrant or monetary award that the employee directly managed or supervised while at the NHDOJ for the life of the subgrant without the express approval of the NH DOJ.
6. The Subrecipient understands that grants are funded for the grant award period noted on the grant award document. No guarantee is given or implied of subsequent funding in future years.

7. **Requirements of the award; remedies for non-compliance or for materially false statements**

The conditions of this award are material requirements of the award. Compliance with any assurances or certifications submitted by or on behalf of the subrecipient that relate to conduct during the period of performance also is a material requirement of this award.

Limited Exceptions. In certain special circumstances, the U.S. Department of Justice ("DOJ") may determine that it will not enforce, or enforce only in part, one or more requirements otherwise applicable to the award. 53. In order to ensure that the National Criminal History Improvement Program (NCHIP) and the NICS Act Record Improvement Program (NARIP) are realizing that objectives in the most productive manner, the recipient agrees to participate in a comprehensive evaluation effort. It is anticipated that the evaluation will take place during the course of the program and will likely involve each participating state. It is expected that the evaluation will have a minimal impact on state program personnel and resources.
54. This NCHIP/NARIP related project is to be funded as a cooperative agreement. The basis for using a cooperative agreement is the substantial involvement of the Bureau of Justice Statistics (BJS) in providing information, guidance, and direction relative to criminal history records improvements within the states. BJS will exercise general approval over the entire project. In addition, the substantial involvement of BJS will include, but not be limited to:
- a. Determining the types of criminal history record information that will be useful for Federal, state, and local agencies.
 - b. Identifying Federal information reporting standards and guidelines and making them available to the recipient for providing access to them.
 - c. Providing technical assistance to the subrecipient to enhance state criminal history records, identify convicted felons, and improve the quality and timeliness of criminal history information.

1. The New Hampshire Department of Safety (DOS) as Subrecipient shall receive a grant from the New Hampshire Department of Justice (DOJ) for expenses incurred for the FY2021 National Criminal History Improvement Program grant surrounding the purchase of LiveScan digital fingerprint machines.
2. The Subrecipient shall be reimbursed by the DOJ based on budgeted expenditures described in Exhibit B. The Subrecipient shall submit incurred expenses for reimbursement on the state approved expenditure reporting form as provided. Expenditure reports shall be submitted on a quarterly basis, within fifteen (15) days following the end of the current quarterly activities. Expenditure reports submitted later than thirty (30) days following the end of the quarter will be considered late and out of compliance. *For example, with an award that begins on January 1, the first quarterly report is due on April 15th or 15 days after the close of the first quarter ending on March 31.*
3. Subrecipient is required to maintain supporting documentation for all grant expenses both state funds and match if provided and to produce those documents upon request of this office or any other state or federal audit authority. 1. The Subrecipient shall receive reimbursement in exchange for approved expenditure reports as described in EXHIBIT B.
2. The Subrecipient shall be reimbursed within thirty (30) days following the DOJ's approval of expenditures. Said payment shall be made to the Subrecipient's account receivables address per the Financial System of the State of New Hampshire.
3. The State's obligation to compensate the Subrecipient under this Agreement shall not exceed the price limitation set forth in the Interagency Memorandum of Understanding.
 - 3a. The Subrecipient shall be awarded an amount not to exceed \$198,250 of the total Grant Limitation from Governor and Council approval or 7/31/2023, whichever is later, to 9/30/2024, with approved expenditure reports. This shall be contingent on continued federal funding and program performance.

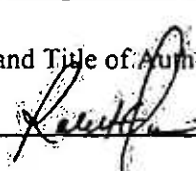

WHEREAS, the Department of Safety and the Department of Justice have agreed to amend the MOU in certain aspects;

WHEREAS, the Department of Safety and the Department of Justice have agreed an extension of time of this MOU is necessary to continue the original objectives of the MOU with no additional funding.

NOW THEREFORE, in consideration of the foregoing, and the covenants and conditions contained in the MOU, and set forth herein, the parties hereto do hereby agree as follows:

a. Amendment and Modification of MOU

- 1) Delete paragraph 4 in its entirety and replace therein as follows:
Whereas, DOJ desires to enter into a subgrant with DOS for a term from Governor and Executive Council approval through 09/30/2023 in an amount not to exceed \$157,485.
- 2) Delete #5 in its entirety and replace therein as follows:
The Memorandum of Understanding is effective until 09/30/2023.
- 3) Delete Exhibit B Paragraph 3a. in its entirety and replace therein as follows:
The Department of Safety shall be awarded an amount not to exceed \$157,485 of the total Grant Limitation from Governor and Council approval to 09/30/2023, with approved expenditure reports. This shall be contingent on continued federal funding and program performance.
 - i. Neither the DOS nor DOJ will be responsible for any expenses or costs incurred under this agreement prior to Governor and Council approval, nor after 09/30/2023.

b. Effective Date of Amendment

1) This Amendment shall take effect upon approval of the Governor and Executive Council.
