REQUESTED ACTION

Authorize the Department of Environmental Services (NHDES) to amend a grant agreement (PO #1094736) with the Plymouth Village Water and Sewer District (VC #159943-B001), NH, by increasing the award by \$428,781 from \$240,000 to \$668,781 for drinking water system improvements, effective upon Governor & Council approval through December 1, 2025. The grant was originally approved by Governor and Council on August 2, 2023, Item #51. 100% Drinking Water and Groundwater Trust Fund (DWGTF).

EXPLANATION

The purpose of this amendment is to authorize the Plymouth Village Water and Sewer District (District) to modify their grant agreement. The District had originally requested a total of \$2,160,000 in Drinking Water State Revolving Fund (DWSRF) loan and \$240,000 in American Rescue Plan Act (ARPA) grant funding, totaling \$2,400,000 from NHDES for needed water system improvements. This amendment adds \$428,781 to the project bringing the total to \$2,828,781.

The costs for the water system improvements which include the installation of well pumps and appurtenances, construction of a building to house electrical equipment, construction of raw watermain from the new Holderness wells to the District's existing facility, and construction of a finished watermain connecting the facility and existing distribution mains have increased and therefore additional funds are needed to complete the project. NHDES has sufficient funds to meet the District's request through the DWGTF program. To date, nothing has been expended from the original \$2,400,000 in funding.

The Drinking Water and Groundwater Trust Fund (DWGTF) was created in 2016 using \$276 million of MtBE trial judgement funds, as authorized by RSA 485:F. The purpose of the DWGTF is to provide sustainable long-term funding for the protection, preservation, and enhancement of the drinking water and

groundwater resources of the state. The Drinking Water and Groundwater Advisory Commission (Advisory Commission) was established to administer the DWGTF and to provide guidance to the State on the use of the DWGTF.

On November 20, 2023, the DWGTF Advisory Commission voted to authorize \$428,781 in grant funds to the Plymouth Village Water and Sewer District to fund the water system improvements project in combination with the previously approved funding.

In the event that these funds become no longer available, General Funds will not be requested to support this project. This agreement has been approved by the Attorney General's Office as to form, substance, and execution.

Amendment 1**

This Agreement (hereinafter called the Amendment) dated this ____ day of _____, 20____, is by and between the State of New Hampshire, acting by and through its Department of Environmental Services (hereinafter referred to as the State) and the Plymouth Village Water and Sewer District acting by and through the Chair, Christopher Woods (hereinafter referred to as the Grantee).

WHEREAS, pursuant to an Agreement (hereinafter called the Agreement) approved by the Governor and Council on August 2, 2023, the Grantee agreed to perform certain services upon the terms and conditions specified in the Agreement and in consideration of payment by the State of certain sums as specified therein; and

WHEREAS, The Grantee and the State have agreed to amend the Agreement in certain respects;

NOW THEREFORE, in consideration of the foregoing, and the covenants and conditions contained in the Agreement and set forth herein, the parties hereto do hereby agree as follows:

1. Amendment and Modification of Agreement: The Agreement is hereby amended as follows:
 - (A) The Grant Limitation as set forth in sub-paragraph 1.8 of the Agreement shall be changed from \$240,000 to \$668,781.
 - (B) The Account Number as set forth in sub-paragraph 1.6 of the Agreement shall include 03-44-44-444010-7428-073.
 - (C) Delete Exhibit B and C and replace with Exhibit B – Amendment 1 and Exhibit C – Amendment 1. Exhibit B – Amendment 1 and Exhibit C – Amendment 1 are attached hereto and incorporated into this amendment and agreement by reference.
3. Effective Date of Amendment: This Amendment shall take effect upon the date of approval of this Amendment by the Governor and Executive Council of the State of New Hampshire.
4. Continuance of Agreement: Except as specifically amended and modified by the terms and conditions of this Amendment, the Agreement, and the obligations of the parties thereunder, shall remain in full force and effect in accordance with the terms and conditions set forth therein.

Exhibit B- Amendment 1**

Plymouth Village Water and Sewer District will use the American Rescue Plan Act of 2021 (ARPA) grant funds and Drinking Water and Groundwater Trust Fund (DWGTF) grant funds for the installation of well pumps and appurtenances for two newly developed wells, construction of a building to house electrical and communication equipment, construction of a raw water main from the new Holderness wells to the District's existing Foster Street facility for treatment, upgrades to the Foster Street facility including to the metering and chemical feed systems, and construction of a finished watermain from the facility to a connection point with the existing water distribution mains.

Grant funds will be used in conjunction with Drinking Water State Revolving Funds (DWSRF) loan funds to complete the design, bidding, construction, and engineering oversight of the construction contract for the project.

As a requirement of this grant funding, the Plymouth Village Water and Sewer District is required to develop and adhere to an asset maintenance and renewal plan for the funded improvements and provide documentation supporting compliance with this requirement.

Exhibit C- Amendment 1**

The NHDES shall pay to the Grantee the total reimbursable program costs up to \$668,781 for eligible drinking water improvements costs not to exceed the total Grant limitation of \$668,781 in accordance with the following requirements:

Reimbursement requests for program costs shall be made no more than once per calendar month by the Grantee using the applicable Disbursement form as supplied by the NHDES, which shall be completed and signed by the Grantee. The disbursement form shall be accompanied by proper supporting documentation based upon direct costs. The Grantee will maintain adequate documentation to substantiate all Program related costs. All work shall be performed to the satisfaction of the NHDES before payment is made.

The funding is a combination of an ARPA grant of \$240,000, and a DWGTF grant of \$428,781. Each disbursement request will be paid 100% of eligible expenses as ARPA grant funds not to exceed \$240,000. To the greatest extent practicable, ARPA funds shall be fully disbursed prior to disbursing DWSRF funds, and DWSRF loan funds shall be fully disbursed prior to disbursing DWGTF funds. Each DWGTF disbursement request will be paid 100% of eligible expenses as DWGTF grant funds not to exceed \$428,781.

Project-related changes to the Scope of Services outlined in Exhibit B require NHDES approval in advance and if applicable as determined by NHDES, may require approval by the Drinking Water and Groundwater Advisory Commission and a grant amendment subject to approval by the Governor and Executive Council. All work must be completed prior to the completion date (section 1.7) in this Grant Agreement to be eligible for reimbursement.

EXPLANATION

NHDES, through the American Rescue Plan Act funds (ARPA) and the Drinking Water State Revolving Loan Fund (DWSRF) has offered the Plymouth Village Water & Sewer District \$2,400,000 in a combination of grant and loan funds for needed water system improvements. The District will use the grant and loan funding to install well pumps for two new wells, construct a building for associated equipment and install a raw water main from the new well to the existing distribution system. The project will result in improved water quality and resiliency.

ARPA of 2021 is a \$1.9 trillion economic stimulus bill passed by the 117th United States Congress and signed into law by President Biden on March 11, 2021, to speed up the United States' recovery from the economic and health effects of the COVID-19 pandemic and the resultant recession. The Act defines eligible uses of the state and local funding, including responding to public health emergencies, responding to workers performing essential work during the COVID-19 emergency, providing revenue relief to states and making investments in water, sewer, and broadband infrastructure. This is an allowable use of ARP FRF funds under Section 602 (c)(1)(D) to make necessary investments in water, sewer, or broadband infrastructure.

In accordance with the final rule from the US Treasury Department for water and wastewater infrastructure investments, project eligibility is aligned with the Environmental Protection Agency's Clean Water State Revolving Fund (CWSRF) and Drinking Water State Revolving Fund (DWSRF). This project is an eligible DWSRF infrastructure project.

The final DWSRF loan amount will be based on the total DWSRF funds disbursed and may be less than \$2,160,000. The loan interest rate may be adjusted downward if the DWSRF loan rate in effect upon project completion is less than the current rate of 2.536% for 20 years. The District is eligible for principal forgiveness under the 2022 DWSRF Intended Use Plan. The final amount of principal forgiveness will be determined when the aggregate principal amount is established, and the project is complete. There is currently a balance of \$12,000,000 in the DWSRF available for new loans.

In the event these funds become no longer available, general funds will not be requested to support this program. This grant agreement has been approved by the Attorney General's Office as to form, substance, and execution.



2. **SCOPE OF WORK:** In exchange for grant funds provided by the State of New Hampshire, acting through the Agency identified in block 1.1 (hereinafter referred to as "the State"), the Grantee identified in block 1.3 (hereinafter referred to as "the Grantee"), shall perform that work identified and more particularly described in the scope of work attached hereto as EXHIBIT B (the scope of work being hereinafter referred to as "the Project").

3. **AREA COVERED.** Except as otherwise specifically provided for herein, the Grantee shall perform the Project in, and with respect to, the State of New Hampshire.

EFFECTIVE DATE: COMPLETION OF PROJECT.

4.1. This Agreement, and all obligations of the parties hereunder, shall become effective on the date of approval of this Agreement by the Governor and Council of the State of New Hampshire if required (block 1.16), or upon signature by the State Agency as shown in block 1.14 ("the Effective Date").

4.2. Except as otherwise specifically provided herein, the Project, including all reports required by this Agreement, shall be completed in ITS entirety prior to the date in block 1.7 (hereinafter referred to as "the Completion Date").

5. **GRANT AMOUNT: LIMITATION ON AMOUNT: VOUCHERS: PAYMENT.**

5.1. The Grant Amount is identified and more particularly described in EXHIBIT C, attached hereto.

5.2. The manner of, and schedule of payment shall be as set forth in EXHIBIT C.

5.3. In accordance with the provisions set forth in EXHIBIT C, and in consideration of the satisfactory performance of the Project, as determined by the State, and as limited by subparagraph 5.5 of these general provisions, the State shall pay the Grantee the Grant Amount. The State shall withhold from the amount otherwise payable to the Grantee under this subparagraph 5.3 those sums required, or permitted, to be withheld pursuant to N.H. RSA 80:7 through 7-c.

5.4. The payment by the State of the Grant amount shall be the only, and the complete payment to the Grantee for all expenses, of whatever nature, incurred by the Grantee in the performance hereof, and shall be the only, and the complete, compensation to the Grantee for the Project. The State shall have no liabilities to the Grantee other than the Grant Amount.

5.5. Notwithstanding anything in this Agreement to the contrary, and notwithstanding unexpected circumstances, in no event shall the total of all payments authorized, or actually made, hereunder exceed the Grant limitation set forth in block 1.8 of these general provisions.

6. **COMPLIANCE BY GRANTEE WITH LAWS AND REGULATIONS.** In connection with the performance of the Project, the Grantee shall comply with all statutes, laws, regulations, and orders of federal, state, county, or municipal authorities which shall impose any obligations or duty upon the Grantee, including the acquisition of any and all necessary permits and RSA 31-95-b.

7. **RECORDS and ACCOUNTS.**

7.1. Between the Effective Date and the date seven (7) years after the Completion Date, unless otherwise required by the grant terms or the Agency, the Grantee shall keep detailed accounts of all expenses incurred in connection with the Project, including, but not limited to, costs of administration, transportation, insurance, telephone calls, and clerical materials and services. Such accounts shall be supported by receipts, invoices, bills and other similar documents.

7.2. Between the Effective Date and the date seven (7) years after the Completion Date, unless otherwise required by the grant terms or the Agency pursuant to subparagraph 7.1, at any time during the Grantee's normal business hours, and as often as the State shall demand, the Grantee shall make available to the State all records pertaining to matters covered by this Agreement. The Grantee shall permit the State to audit, examine, and reproduce such records, and to make audits of all contracts, invoices, materials, payrolls, records of personnel, data (as that term is hereinafter defined), and other information relating to all matters covered by this Agreement. As used in this paragraph, "Grantee" includes all persons, natural or fictional, affiliated with, controlled by, or under common ownership with, the entity identified as the Grantee in block 1.3 of these provisions.

8. **PERSONNEL.**

8.1. The Grantee shall, at its own expense, provide all personnel necessary to perform the Project. The Grantee warrants that all personnel engaged in the Project shall be qualified to perform such Project, and shall be properly licensed and authorized to perform such Project under all applicable laws.

8.2. The Grantee shall not hire, and it shall not permit any subcontractor, subgrantee, or other person, firm or corporation with whom it is engaged in a combined effort to perform the Project, to hire any person who has a contractual relationship with the State, or who is a State officer or employee, elected or appointed.

8.3. The Grant Officer shall be the representative of the State hereunder. In the event of any dispute hereunder, the interpretation of this Agreement by the Grant Officer, and his/her decision on any dispute, shall be final.

9. **DATA: RETENTION OF DATA: ACCESS.**

9.1. As used in this Agreement, the word "data" shall mean all information and things developed or obtained during the performance of, or acquired or developed by reason of, this Agreement, including, but not limited to, all studies, reports, files, formulae, surveys, maps, charts, sound recordings, video recordings, pictorial reproductions, drawings, analyses, graphic representations,

computer programs, computer printouts, notes, letters, memoranda, paper, and documents, all whether finished or unfinished.

9.2. Between the Effective Date and the Completion Date the Grantee shall grant to the State, or any person designated by it, unrestricted access to all data for examination, duplication, publication, translation, sale, disposal, or for any other purpose whatsoever.

9.3. No data shall be subject to copyright in the United States or any other country by anyone other than the State.

9.4. On and after the Effective Date all data, and any property which has been received from the State or purchased with funds provided for that purpose under this Agreement, shall be the property of the State, and shall be returned to the State upon demand or upon termination of this Agreement for any reason, whichever shall first occur.

9.5. The State, and anyone it shall designate, shall have unrestricted authority to publish, disclose, distribute and otherwise use, in whole or in part, all data.

10. **CONDITIONAL NATURE OR AGREEMENT.** Notwithstanding anything in this Agreement to the contrary, all obligations of the State hereunder, including, without limitation, the continuance of payments hereunder, are contingent upon the availability or continued appropriation of funds, and in no event shall the State be liable for any payments hereunder in excess of such available or appropriated funds. In the event of a reduction or termination of those funds, the State shall have the right to withhold payment until such funds become available, if ever, and shall have the right to terminate this Agreement immediately upon giving the Grantee notice of such termination.

11. **EVENT OF DEFAULT: REMEDIES.**

11.1. Any one or more of the following acts or omissions of the Grantee shall constitute an event of default hereunder (hereinafter referred to as "Events of Default"):

11.1.1 Failure to perform the Project satisfactorily or on schedule; or

11.1.2 Failure to submit any report required hereunder; or

11.1.3 Failure to maintain, or permit access to, the records required hereunder; or

11.1.4 Failure to perform any of the other covenants and conditions of this Agreement.

11.2. Upon the occurrence of any Event of Default, the State may take any one, or more, or all, of the following actions:

11.2.1 Give the Grantee a written notice specifying the Event of Default and requiring it to be remedied within, in the absence of a greater or lesser specification of time, thirty (30) days from the date of the notice; and if the Event of Default is not timely remedied, terminate this Agreement, effective two (2) days after giving the Grantee notice of termination; and

11.2.2 Give the Grantee a written notice specifying the Event of Default and suspending all payments to be made under this Agreement and ordering that the portion of the Grant Amount which would otherwise accrue to the Grantee during the period from the date of such notice until such time as the State determines that the Grantee has cured the Event of Default shall never be paid to the Grantee; and

11.2.3 Set off against any other obligation the State may owe to the Grantee any damages the State suffers by reason of any Event of Default; and

11.2.4 Treat the agreement as breached and pursue any of its remedies at law or in equity, or both.

12. **TERMINATION.**

12.1. In the event of any early termination of this Agreement for any reason other than the completion of the Project, the Grantee shall deliver to the Grant Officer, not later than fifteen (15) days after the date of termination, a report (hereinafter referred to as the "Termination Report") describing in detail all Project Work performed, and the Grant Amount earned, to and including the date of termination. In the event of Termination under paragraphs 10 or 12.4 of these general provisions, the approval of such a Termination Report by the State shall entitle the Grantee to receive that portion of the Grant amount earned to and including the date of termination.

12.2. In the event of Termination under paragraphs 10 or 12.4 of these general provisions, the approval of such a Termination Report by the State shall in no event relieve the Grantee from any and all liability for damages sustained or incurred by the State as a result of the Grantee's breach of its obligations hereunder.

12.3. Notwithstanding anything in this Agreement to the contrary, either the State or, except where notice default has been given to the Grantee hereunder, the Grantee, may terminate this Agreement without cause upon thirty (30) days written notice.

12.4. **CONFLICT OF INTEREST.** No officer, member of employee of the Grantee, and no representative, officer or employee of the State of New Hampshire or of the governing body of the locality or localities in which the Project is to be performed, who exercises any functions or responsibilities in the review or

- approval of the undertaking or carrying out of such Project, shall participate in any decision relating to this Agreement which affects his or her personal interest or the interest of any corporation, partnership, or association in which he or she is directly or indirectly interested, nor shall he or she have any personal or pecuniary interest, direct or indirect, in this Agreement or the proceeds thereof.
- GRANTEE'S RELATION TO THE STATE** In the performance of this Agreement the Grantee, its employees, and any subcontractor or subgrantee of the Grantee are in all respects independent contractors, and are neither agents nor employees of the State. Neither the Grantee nor any of its officers, employees, agents, members, subcontractors or subgrantees, shall have authority to bind the State nor are they entitled to any of the benefits, workmen's compensation or emoluments provided by the State to its employees.
15. **ASSIGNMENT AND SUBCONTRACTS.** The Grantee shall not assign, or otherwise transfer any interest in this Agreement without the prior written consent of the State. None of the Project Work shall be subcontracted or subgranted by the Grantee other than as set forth in Exhibit B without the prior written consent of the State.
16. **INDEMNIFICATION.** The Grantee shall defend, indemnify and hold harmless the State, its officers and employees, from and against any and all losses suffered by the State, its officers and employees, and any and all claims, liabilities or penalties asserted against the State, its officers and employees, by or on behalf of any person, on account of, based on, resulting from, arising out of (or which may be claimed to arise out of) the acts or omissions of the Grantee or subcontractor, or subgrantee or other agent of the Grantee. Notwithstanding the foregoing, nothing herein contained shall be deemed to constitute a waiver of the sovereign immunity of the State, which immunity is hereby reserved to the State. This covenant shall survive the termination of this agreement.
17. **INSURANCE.**
- 17.1 The Grantee shall, at its own expense, obtain and maintain in force, or shall require any subcontractor, subgrantee or assignee performing Project work to obtain and maintain in force, both for the benefit of the State, the following insurance:
- 17.1.1 Statutory workers' compensation and employees liability insurance for all employees engaged in the performance of the Project, and
- 17.1.2 General liability insurance against all claims of bodily injuries, death or property damage, in amounts not less than \$1,000,000 per occurrence and \$2,000,000 aggregate for bodily injury or death any one incident, and \$500,000 for property damage in any one incident; and
- 17.2. The policies described in subparagraph 17.1 of this paragraph shall be the standard form employed in the State of New Hampshire, issued by underwriters acceptable to the State, and authorized to do business in the State of New Hampshire. Grantee shall furnish to the State, certificates of insurance for all renewal(s) of insurance required under this Agreement no later than ten (10) days prior to the expiration date of each insurance policy.
18. **WAIVER OF BREACH.** No failure by the State to enforce any provisions hereof after any Event of Default shall be deemed a waiver of its rights with regard to that Event, or any subsequent Event. No express waiver of any Event of Default shall be deemed a waiver of any provisions hereof. No such failure of waiver shall be deemed a waiver of the right of the State to enforce each and all of the provisions hereof upon any further or other default on the part of the Grantee.
19. **NOTICE.** Any notice by a party hereto to the other party shall be deemed to have been duly delivered or given at the time of mailing by certified mail, postage prepaid, in a United States Post Office addressed to the parties at the addresses first above given.
20. **AMENDMENT.** This Agreement may be amended, waived or discharged only by an instrument in writing signed by the parties hereto and only after approval of such amendment, waiver or discharge by the Governor and Council of the State of New Hampshire, if required or by the signing State Agency.
21. **CONSTRUCTION OF AGREEMENT AND TERMS.** This Agreement shall be construed in accordance with the law of the State of New Hampshire, and is binding upon and inures to the benefit of the parties and their respective successors and assignees. The captions and contents of the "subject" blank are used only as a matter of convenience, and are not to be considered a part of this Agreement or to be used in determining the intent of the parties hereto.
22. **THIRD PARTIES.** The parties hereto do not intend to benefit any third parties and this Agreement shall not be construed to confer any such benefit.
23. **ENTIRE AGREEMENT.** This Agreement, which may be executed in a number of counterparts, each of which shall be deemed an original, constitutes the entire agreement and understanding between the parties, and supersedes all prior agreements and understandings relating hereto.
24. **SPECIAL PROVISIONS.** The additional or modifying provisions set forth in Exhibit A hereto are incorporated as part of this agreement.

RECORDKEEPING REQUIREMENTS: The Subrecipient must maintain records and financial documents for five years after all funds have been expended or returned to the State and/or Treasury. The NHDES shall pay to the Grantee the total reimbursable program costs up to \$240,000 for eligible drinking water improvements costs not to exceed the total Grant Limitation of \$240,000 in accordance with the following requirements:

Reimbursement requests for program costs shall be made no more than once per calendar month by the Grantee using the ARPA Disbursement form as supplied by the NHDES, which shall be completed and signed by the Grantee. The disbursement form shall be accompanied by proper supporting documentation based upon direct costs. The Grantee will maintain adequate documentation to substantiate all Program related costs. All work shall be performed to the satisfaction of the NHDES before payment is made.

The funding is a combination of an ARPA grant of \$240,000 and a DWSRF loan of \$2,160,000. Each disbursement request will be paid 100% of eligible expenses as ARPA grant funds not to exceed \$240,000. To the greatest extent practicable, ARPA funds shall be fully disbursed prior to disbursing DWSRF funds.

Changes to the Scope of Services require NHDES approval in advance. All work must be completed prior to the completion date (section 1.7) in this Grant Agreement to be eligible for reimbursement.

ORIGINAL LOAN AGREEMENT

I. This Agreement is between the State of New Hampshire Drinking Water State Revolving Loan Fund Program (State) and the Plymouth Village Water & Sewer District, New Hampshire (Loan Recipient) in accordance with RSA 486:14 and New Hampshire Code of Administrative Rules Env-Dw 1100 (Rules) for the purpose of financing, to the extent of the aggregate amount of funds transferred (Disbursements) to the Loan Recipient made hereunder, the Holderness Well Treatment Project (Project) now being undertaken by the Loan Recipient. The Project is described in Exhibit A. The Loan Recipient shall abide by all of the requirements of RSA 486:14 and the Rules.

II. The State agrees to loan to the Loan Recipient, and the Loan Recipient agrees to repay to the State, in accordance with the terms of this Agreement, the principal sum of **Two Million One Hundred Sixty Thousand and 00/100 Dollars (\$2,160,000)** (Principal Sum) or such lesser amount as shall equal the aggregate of Disbursements made hereunder by the State to the Loan Recipient. Pursuant to federal capitalization grant requirements and/or other allowances, additional financial assistance in the form of principal forgiveness will be applied to the loan upon the initial repayment as follows: A portion of the principal sum, not to exceed **One Million Two Hundred Thousand and 00/100 Dollars (\$1,200,000)** or up to 100% of the total Disbursements relating to the approved emerging contaminants scope, whichever is less, and a portion of the principal sum in the amount of 40% of the remaining Disbursements. The total amount of principal forgives applied to the loan will not exceed **One Million Five Hundred Eighty-Four Thousand and 00/100 Dollars (\$1,584,000)**. In addition to the principal sum, the Loan Recipient agrees to pay the applicable interest accrued as described in Paragraphs III, V, and VII. Federal financial assistance

1 provided through the Drinking Water State Revolving Loan Fund Program (CFDA #66.468) may comprise
2 all or a portion of the Principal Sum. Any Disbursement or other payment from the State to the Loan
3 Recipient is contingent upon the availability of funds.

4
5 III. Disbursements shall be made on a periodic basis, as requested by the Loan Recipient, but not more
6 frequently than monthly, subject to the approval of the amount of each Disbursement by the State. The
7 State shall approve the amount requested if it determines that the costs covered by the request are
8 eligible under Env-Dw 1104.01, as applicable. Interest on each Disbursement shall accrue on the
9 outstanding principal balance from the date of the Disbursement at the rate of 1% per annum computed
10 on the basis of 30-day months and 360-day years until the date of Substantial Completion of the Project
11 or the date of Scheduled Completion, whichever is earlier. At the option of the Loan Recipient, such
12 interest may be paid (1) prior to the commencement of Loan repayment, (2) at the time of the first Loan
13 repayment, or (3) by adding the charges to the outstanding principal Loan balance so long as the Loan
14 Recipient's authority to borrow is not exceeded.

15
16 IV. The aggregate of the Disbursements shall be consolidated by a Promissory Note (Note) of the Loan
17 Recipient in a Supplemental Loan Agreement issued under and in accordance with the applicable
18 provisions of this Agreement and the Municipal Finance Act, RSA 33, as amended and supplemented,
19 including the provisions of RSA 486:14. The Note shall be substantially in the form of Exhibit B.

20
21 V. The interest rate applicable to the Note will be 2.536%, as determined in accordance with RSA 486:14
22 and Env-Dw 1100 et seq.

23
24 VI. The Loan Recipient hereby authorizes the State to compute the payments of principal and interest on
25 the Note. The principal shall be paid in full within twenty (20) years from the date of the Note. Note

1 payments shall commence within one year of the Substantial Completion date of the Project or the
2 Scheduled Completion date of the project, whichever is earlier. The Scheduled Completion date is hereby
3 determined to be December 1, 2025; however, should the project experience an excusable delay, an
4 extension may be granted by the Commissioner of the Department of Environmental Services upon
5 request in writing by the Loan Recipient. In no event shall Note payments commence later than ten years
6 from the effective date of this Agreement.

7
8 VII. The Loan Recipient reserves the right to prepay, at any time and without penalty, all or any part of
9 the outstanding principal or interest of the Note.

10
11 VIII. In the event of a default in the full and timely remittance of any Note payment, any State Aid Grant
12 funds payable to the Loan Recipient under RSA 486:A may be offset against and applied to the payment
13 of any obligations that are due hereunder. The Loan Recipient agrees to be liable for all costs of collection,
14 legal expenses, and attorney's fees incurred or paid by the State in enforcing this Agreement or in
15 collecting any delinquent payments due hereunder.

16
17 IX. No delay or omission on the part of the State in exercising any right hereunder shall operate as a
18 waiver of such right or of any other right under this Agreement. A waiver on any one occasion shall not
19 be construed as bar to any right and/or remedy on any future occasion.

20
21 X. The Loan Recipient agrees to comply, and to require all of its contractors to comply, with all
22 applicable state and federal requirements contained in the Rules and applicable state and federal laws,
23 including those specific requirements outlined in Exhibit C.

1 XI. The Loan Recipient is required to develop an asset maintenance and renewal plan for the assets(s)
2 being funded under the loan or incorporate the funded asset(s) into an existing asset management plan.
3 At a minimum the plan must include a commitment to asset management, financing and
4 implementation strategy and an inventory of the funded asset(s).

5
6 XII. The Loan Recipient agrees to permit the Comptroller General of the United States, an appropriate
7 Inspector General appointed under section 3 or 8G of the Inspector General Act of 1978 (5 U.S.C. App.),
8 or an authorized representative of either of the foregoing officials, or of the State of New Hampshire to
9 have access to and the right to:

10
11 (i) Examine any of the Loan Recipient's, the contractor's or any subcontractor's records
12 that pertain to and involve transactions relating to this Agreement, the Construction Contract,
13 the Engineering Contract or a subcontract thereunder; and

14
15 (ii) Interview any officer or employee regarding such transactions.

16
17 The Loan Recipient shall insert subparagraphs (i). and (ii). in the Construction Contract and require the
18 Contractor to insert subparagraphs (i). and (ii). in all subcontracts thereunder.

19
20 XIII. The effective date of this Agreement shall be the date of its approval by the Governor and Executive
21 Council. This Agreement may be amended, waived, or discharged only by a written instrument signed by
22 the parties hereto and only after approval of such amendment, waiver, or discharge by the Governor and
23 Executive Council.


1 XIV. This Agreement shall be construed in accordance with the laws of the State of New Hampshire and

3 hereto do not intend to benefit any third parties and, consequently, the Agreement shall not be
4 construed to confer any such benefit.



10 This term and condition implements 2 CFR 200.216 and is effective for obligations and expenditures of
11 EPA financial assistance funding on or after 8/13/2020. As required by 2 CFR 200.216, EPA recipients and
12 subrecipients, including borrowers under EPA funded revolving loan fund programs, are prohibited from
13 obligating or expending loan or grant funds to procure or obtain; extend or renew a contract to procure
14 or obtain; or enter into a contract (or extend or renew a contract) to procure or obtain equipment,
15 services, or systems that use covered telecommunications equipment or services as a substantial or
16 essential component of any system, or as critical technology as part of any system. As described in
17 Public Law 115-232, section 889, covered telecommunications equipment is telecommunications
18 equipment produced by Huawei Technologies Company or ZTE Corporation (or any subsidiary or affiliate
19 of such entities). Recipients, subrecipients, and borrowers also may not use EPA funds to purchase: a.
20 For the purpose of public safety, security of government facilities, physical security surveillance of
21 critical Page 4 of 29 infrastructure, and other national security purposes, video surveillance and
22 telecommunications equipment produced by Hytera Communications Corporation, Hangzhou Hikvision
23 Digital Technology Company, or Dahua Technology Company (or any subsidiary or affiliate of such
24 entities). b. Telecommunications or video surveillance services provided by such entities or using such
25 equipment. c. Telecommunications or video surveillance equipment or services produced or provided by

1 an entity that the Secretary of Defense, in consultation with the Director of the National Intelligence or
2 the Director of the Federal Bureau of Investigation, reasonably believes to be an entity owned or
3 controlled by, or otherwise connected to, the government of a covered foreign country. Consistent with
4 2 CFR 200.471, costs incurred for telecommunications and video surveillance services or equipment such
5 as phones, internet, video surveillance, and cloud servers are allowable except for the following
6 circumstances: a. Obligating or expending EPA funds for covered telecommunications and video
7 surveillance services or equipment or services as described in 2 CFR 200.216 to: (1) Procure or obtain,
8 extend or renew a contract to procure or obtain; (2) Enter into a contract (or extend or renew a
9 contract) to procure; or (3) Obtain the equipment, services, or systems. Certain prohibited equipment,
10 systems, or services, including equipment, systems, or services produced or provided by entities
11 identified in section 889, are recorded in the System for Award Management exclusion list.
