**REQUESTED ACTION**

Authorize the Department of Transportation to enter into a contract with Continental Paving, Inc. (Vendor 155350) of Londonderry, NH, on the basis of a low bid of \$5,486,208.91, for roadway resurfacing in fourteen (14) Towns in District 3 (Project: District 3, #16163M), effective upon Governor and Council approval through September 27, 2024, unless amended by the Department in accordance with the Standard Specifications. 100% Other Funds.

Funding is available in State Fiscal Years 2024 and 2025 as follows, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

**EXPLANATION**

This project is part of the CY 2024 State Funded Tier 2, 3 and 4 Resurfacing Program (Pave-T2-Resurf, Pave-T3/4-Resurf, and Pave-T3/4-Rehab). This project resurfaces eleven (11) sections of various Tier 2, 3 and 4 roadways throughout fourteen (14) towns in District 3. These sections total approximately 54.2 miles in length. Incidental work includes curb ramp reconstruction, pavement striping, and drainage work.

This project will improve roadway ride quality, extend the life of the pavement, improve curb ramps, and drainage, and delay costlier improvements. The sections will be resurfaced via paver shim, inlay, PMRAP and leveling. One (1) sidewalk curb ramps will be updated to comply with ADA and striping is included in this Contract. All impacted towns and utilities will be notified.

Although the bid costs exceeded the Department's estimate by 1.95% the low bid of two bids received is felt to be reasonable for the work involved. There was one Item 411.3 Paver Shim \$265,985 that resulted in the bid being higher than anticipated. Re-advertising this project would result, in our opinion, in higher prices and prevent the completion of the work in a timely manner. The Department considers it to be in the best interest of the State to accept this bid to accomplish these needed repairs.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is: 0% Federal funds (38.6% BETTERMENT, 61.4% SB-367).

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

**DESCRIPTION:** This project resurfaces eleven (11) sections of various Tier 2, 3 and 4 roadways throughout fourteen (14) towns in District 3. These sections total approximately 54.2 miles in length. Incidental work includes curb ramp reconstruction, pavement striping, and drainage work.

**FEDERAL FUNDING:** 0% (38.6% BETTERMENT, 61.4% SB-367)

**CONTINGENCY:** There is no contingency for this project.



**PROJECT INITIATED:** This project is part of the CY 2024 State Funded Tier 2, 3 and 4 resurfacing program (Pave-T2-Resurf, Pave-T3/4-Resurf, and Pave-T3/4-Rehab). The Pavement Management Section reviewed the road segments included in this project. They identified eight (8) sections for Light Capital Paving totaling 38.5 miles, one (1) for Major Rehab totaling 0.3 miles, and two (2) sections for Roughness totaling 15.4 miles.

**PROJECT EXPLANATION:** This project will improve roadway ride quality, extend the life of the pavement, improve curb ramps, and drainage, and delay costlier improvements. The section will be resurfaced via paver shim, inlay, PMRAP and leveling. One (1) sidewalk curb ramps will be updated to comply with ADA and striping is included in this Contract. All impacted towns and utilities will be notified.

**TRAFFIC IMPLICATION:** Only one (1) section will be paved at a time. One-lane, alternating two-way traffic will be required to complete the work. Unless otherwise noted in segment specific requirements, lane closer lengths will be limited to one (1) mile with a two (2) mile separation required between work zones. Traffic will be restored to normal patterns during non-work hours. Work zone significance was determined to be non-significant at the December 21, 2023 TCC meeting.




