REQUESTED ACTION

That approval be and hereby is given to the Attorney General to reappoint James J. Hodgdon (Position #9U638, Appropriation #02-20-20-200510-2610-014-500134) as a Criminal Justice Investigator at a salary level of \$90,291 (LG BB, Step 7) effective July 1, 2024 upon Governor and Executive Council approval for a term ending June 30, 2029.

EXPLANATION


Mr. Hodgdon, a resident of Dracut, Massachusetts, earned a Bachelor of Science in Human Services from Springfield College and a Master of Arts in Criminal Justice from Anna Maria College. After working as a Corrections Officer at the Massachusetts Department of Corrections—M.C.I. Shirley (1986 to 1987), he served as a Police Officer with the Tewksbury Police Department (1988 to 1995). He joined the Lowell Police Department in 1995 and served with them until retiring at the rank of Captain in 2021. During his 27-year career with the Lowell Police Department, he was assigned a variety of duties and responsibilities including patrol officer, field training officer, detective, Patrol Division supervisor, officer-in-charge of the Special Investigations Section, officer-in-charge of the Professional Standards Division, and commanding officer of the Patrol Division. At the time of his retirement, he was commanding officer of the Professional Standards Division, where he led the Training Division, Internal Affairs, and was the Public Information Officer. Since retiring in 2021, he has remained a Special Police Officer for the Lowell Police Department. Between 2018 and 2022, he also worked as an instructor and investigator for APD Management in which capacity he conducted new hire, internal, and background investigations. Mr. Hodgdon is assigned to the Criminal Bureau. His primary duty has been to investigate incidents involving use of force by law enforcement officers which result in serious bodily injury or death. His salary will remain the
