REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract with C.W. Sliter & Sons, LLC d/b/a CWS Fence & Guardrail Co. (Vendor 155763) of Andover, NH, on the basis of a low bid of \$1,446,755 for guardrail removal and replacement on I-293 through the Millyard in Manchester (Project: Manchester #44501), from the date of Governor and Council approval through May 16, 2025, unless amended by the Department in accordance with the Standard Specifications. 100% Turnpike Funds.

2. Further authorize that a contingency in the amount of \$72,337.75 be approved for payment of latent conditions, which may appear during the construction of the project. The contingency requested is 5% of the contract amount.

EXPLANATION

This project is part of the Turnpike's Renewal and Replacement Program. This project is located in the median of I-293 through the Millyard in Manchester, starting 500 ft north of the Bridge Street bridge continuing north to 1,000 ft south of Exit 7 northbound off ramp. Approximately 7,150 feet of box beam guardrail will be removed and replaced with double faced thrie beam guardrail. Concrete barrier pier protection will be constructed at the two bridges located within the project area.

The box beam guardrail located within the median has been in service since approximately 1970. This rail does not perform well, and routine maintenance is difficult. Potential delays in Manchester 16099 project have made replacement of the box beam a higher priority. The project will remove the box beam guardrail

and will replace it with double faced thrie beam. Concrete barrier pier protection will be constructed at the two bridges located within the project area to protect the piers from potential impacts.

The proposed contingency amount is 5% of the contract amount. This project was quantified based on field observations, aerial photos, and as-built plans. Field adjustments may be required due to varying field conditions and unforeseen conditions.

Although the bid costs exceeded the Department's estimate by 39.09%, the low bid of two bids received is felt to be reasonable for the work involved. The items that resulted in the higher than anticipated bid were, Item 606.21203 Double Faced Guardrail \$141,900, Item 646.41 Turf Establishment \$102,000 and Item 203.382 Rehandling LRS \$57,500. Readvertising this project would result, in our opinion, in higher prices and prevent the completion of the work in a timely manner. The Department considers it to be in the best interest of the State to accept this bid to accomplish these needed repairs.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is: 0% Federal funds (100% Turnpike Renewal and Replacement Program).

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.


PROJECT INITIATED: Bureau of Turnpikes Renewal and Replacement (TRR) Program

MANCHESTER - FE EVERETT TURNPIKE




