Your Excellency and Members of the Council:

REQUESTED ACTION

That approval be and hereby is given to the Attorney General to appoint Susan Watkins, Position #9U331 (Appropriation #02-20-20-202010-1033-014-500134), as Chief Forensic Investigator at a salary level of \$91,980 (LG DD, Step 5), effective upon Governor and Executive Council approval or July 26, 2024, whichever is later, for a term ending January 24, 2026.

EXPLANATION

Pursuant to RSA 21-M:3,XV, the Attorney General, subject to the approval of the Governor and Executive Council, may appoint a permanent Chief Forensic Investigator. The Chief Forensic Investigator serves under the Chief Medical Examiner.

Ms. Watkins, a Sanbornville resident, began working with the Department of Justice, Office of the Chief Medical Examiner in 2012 and was promoted to Planning Analyst/Data Systems in 2013. While serving in that role, Ms. Watkins assisted in hiring and training Assistant Deputy Medical Examiners, and was responsible for the inventory, control, and chain of custody for all specimens and physical evidence from autopsy and external exam cases. In 2023, Ms. Watkins was promoted to Deputy Chief Forensic Investigator. Given her years of service, relevant experience, and subject-matter expertise, a salary of \$91,980 is requested. Her resume is attached for your consideration.

Summary of Current Position: Assists in hiring and training of Assistant Deputy Medical Examiners. Responsible for the inventory, control, and chain of custody for all specimens and physical evidence of the Office of the Chief Medical Examiner (OCME) autopsy and external exam cases. Oversees and analyzes statistical data and the methods of collection, processing, and dissemination of such data necessary to implement and coordinate all aspects of the ProLaw, MDI Log and toxicology databases for the OCME.

Responsibilities:

- Assists in hiring, training, scheduling, and supervising of Assistant Deputy Medical Examiners, (ADMEs) who investigate death scene in New Hampshire. Available 24/7 for case questions from ADMEs.
- Responsible for training OCME staff and ADME investigators on MDI Log case management system. Create NH OCME custom reports, mapping of ProLaw data to MDI Log and custom searches for specific data requests.
- Established monthly drug data documentation for publication. Tracks overdose death data, identifies trends, and creates monthly publication in conjunction with Chief Forensic Investigator.
- Assists in the hiring and training of OCME staff and interns on various data collection and data entry systems within the office.
- Establishes and maintains chain of custody and proper storage for all specimens and physical evidence from external exam and autopsy cases. Oversees the proper and safe shipping of biological specimens to various labs throughout the country.
- Assisted in the design and implementation of the electronic death certification system (eCOD) as it relates to the OCME and ADMEs. Trains ADMEs on using the eCOD system.
- Creates and implements training programs for ADME investigators on all toxicology related matters as well as on evidence and digital image procedures.
- Evaluates toxicology, and data collection systems regularly, to ensure proper procedures, including proper chain of evidence entry and reporting.
- Shares information regarding OCME operations, the ADME role and death investigation processes, through presentations to high schools, colleges and other agencies.
- Communicates with decedents' families, Police, funeral homes, and other state agencies regarding death certification, toxicology, identification and policies of the OCME.
- Responsible for sudden infant death and sudden unexplained infant death case toxicology and submission to the biorepository for testing.

Assistant Deputy Medical Examiner, NH Office of Chief Medical Examiner, 2012 to present

- Responsible for the forensic death investigations of medicolegal deaths within several counties throughout the state of NH.
- Document and photograph death scenes and perform external examinations on decedents.

- Gather medical information, scene and social history from multiple sources and communicate findings with on-call doctor to determine cases requiring autopsy or death certificate certification on scene.
- Work closely with decedent's family, police, fire, EMS and state agencies to collect and interpret information to assist in determination of the cause and manner of death.
- Complete ADME Investigation reports on autopsy, external exam and decline cases. Draws blood, vitreous and Covid swabs for toxicology studies on all cases deemed appropriate.
