Your Excellency and Members of the Council:

REQUESTED ACTION

That approval be and hereby is given to the Attorney General to appoint Jared W. Davis (Position #9U632, Appropriation #02-20-20-201010-2621-013-500132) as an Attorney at a salary level of \$95,000, effective upon Governor and Council approval or August 26, 2024, whichever is later.

EXPLANATION

Mr. Davis, a Loudon resident, is licensed to practice law in New Hampshire and Massachusetts. He graduated, *cum laude*, from University of Connecticut in 2011 with a Bachelor of Arts in Economics. He earned his Juris Doctor in 2015 from Vanderbilt University Law School where he was *Vanderbilt Law Review* Articles Editor. Following graduation, he served as a Staff Attorney at the U.S. Court of Appeals, Eleventh Circuit (2015-2017) and Judicial Law Clerk for the Hon. Karon O. Bowdre at the U.S. District Court for the Northern District of Alabama (2017-2018). He returned home to New Hampshire in 2018 and has been serving as a Judicial Law Clerk at the U.S. District Court for the District of New Hampshire since that time—first for the Hon. Joseph A. DiClerico, Jr. (2018 to 2021), then the Hon. Landya B. McCafferty (2021 to 2023), and, most recently, the Hon. Talesha L. Saint-Marc and the Hon. Andrea K. Johnson (2023 to present). Considering Mr. Davis' experience, I request he be appointed as an Attorney at a salary of \$95,000. He will be assigned to the Charitable Trust Unit as Assistant Director. His resume is attached.

RSA 21-M:3 and RSA 94:1-a(I)(c)(3) provide that designation of positions, salary levels, and salary increases for attorneys at the Department of Justice shall be determined by the
