Your Excellency and Members of the Council:

REQUESTED ACTION

That approval be and hereby is given to the Attorney General to reappoint Christopher G. Bond to Position #9U224 (Appropriation #02-20-20-201010-2620-013-500132) as an Assistant Attorney General at a salary level of \$125,000, effective upon Governor and Executive Council approval or August 31, 2024, whichever is later, for a term ending August 31, 2029.

EXPLANATION

Mr. Bond, a Bedford resident, earned his Bachelor of Science, *cum laude*, from Washington and Lee University in 1999, and his Juris Doctor, with high honors, from University of Connecticut School of Law in 2002. In law school, he was Commentary Editor of the *Connecticut Law Review*. Following graduation, he did a judicial clerkship with the Hon. Christopher F. Droney at the U.S. District Court for the District of Connecticut (2002-2004). After a year with Paul, Hastings, Janofsky & Walker in Stamford, Connecticut (2004-2005), he joined Bond Auto Parts, Inc. - a closely held retailer/wholesaler with 48 branches in four states - as General Counsel/Senior Vice President of Human Resources (2005-2017). He returned to private practice with Primmer, Piper, Eggleston & Cramer, PC (2017-2019), focusing on employment, corporate, and commercial law. Mr. Bond was Legal Counsel to the New Hampshire Commissioner of Education (2020-2022), where, among other duties, he served as liaison between that Department and the Department of Justice. He joined the Department in 2022 and was initially appointed Chief of the Client Counseling Unit. In 2023, he was designated an Associate Attorney General and assigned as General Counsel. His assignment and salary will remain the same. A copy of his resume is attached.
