Your Excellency and Members of the Council:

REQUESTED ACTION

That approval be and hereby is given to the Attorney General to reappoint Peter Hinckley to Position #9U045 (Appropriation #02-20-20-200510-2610-013-500132) as an Assistant Attorney General at a salary level of \$120,000, effective upon Governor and Executive Council approval, or October 15, 2024, whichever is later, for a term ending October 14, 2029.

EXPLANATION

Mr. Hinckley is a resident of Mont Vernon and a member of the New Hampshire Bar. He received a Bachelor of Arts from Utica College of Syracuse University in 1991 and his Juris Doctor from Boston College Law School in 1995. Immediately after law school he clerked for the Hon. Ellen Ash Peters, Chief Justice, Connecticut Supreme Court, before joining the New York County District Attorney's Office in 1996. He served in its Appeals Division from 1996 to 2000 and its Trial Division from 2000 to 2008. Mr. Hinckley joined the New Hampshire Department of Justice Criminal Bureau as an Attorney in April 2008. He was appointed as an Assistant Attorney General in September 2008 and designated a Senior Assistant Attorney General in January 2019. He serves in the Homicide Unit where he has successfully prosecuted numerous murder cases. His assignment and salary will remain the same. His resume is attached for your consideration.

RSA 21-M:3 and RSA 94:1-a(I)(c)(3) provide that designation of positions, salary levels, and salary increases for attorneys at the Department of Justice shall be determined by the Attorney General, subject to approval of the Governor and Council, within appropriations made to the Department of Justice.
