EXPLANATION

This request is **retroactive** due to the timing of the receipt of the extension award notification. The Department is submitting this item to the first possible meeting following the finalization of the documentation needed.

This request is being made to extend grant funds available through June 30, 2025, to administer Adult Protective Services (APS) Elder Justice American Rescue Plan (ARP) grant funds from the Administration for Community Living. The Department received approval for a no cost extension of the performance period of the available grant funds through September 30, 2025. Funds will be used for enhancing Information Technology, staff training, for direct client services, and public awareness. Funds are being used to enhance and improve adult protective services provided by the State by continuing the development and implementation of an online reporting system for APS and for the automation of the Bureau of Aging and Adult Services (BAAS) State Registry. The online reporting system will be accessible 24 hours a day and information submitted will be immediately uploaded into the APS investigation management system, making it immediately accessible to APS staff. State Registry checks will be submitted online to the BAAS and employers will be able to log in and view State Registry check results. System enhancement will also be implemented to ensure APS staff have access to the information needed to streamline access, communication and coordination with Choices for Independence Waiver participants working with APS.

In addition to improvements in the APS technology system, funds will further enhance APS operations by providing training to staff which may include attending the National Adult Protective Services Association's annual conference, specialized focus areas such as forensic interviewing, and other training opportunities relevant to APS work and competencies.

Funds are also targeted for direct client services for emergent situations and circumstances that need to be addressed while long term supports and services are put in place. These services would include immediate help for food, shelter, utilities, and other basic needs.



EXPLANATION

This request is being made to accept and expend grant funds available through September 30, 2024, to administer Adult Protective Services (APS) Elder Justice American Rescue Plan (ARP) grant funds from the Administration for Community Living. Funds are being used to enhance and improve adult protective services provided by continuing the development and implementation of an online reporting system for APS and for the automation of the Bureau of Elderly and Adult Services (BEAS) State Registry. The online reporting system will be accessible 24 hours a day and information submitted will be immediately uploaded into the APS investigation management system, making it immediately accessible to APS staff. State Registry checks will be submitted online to the BEAS State Registry and employers will be able to log in and view State Registry check results. System enhancement will also be implemented to ensure APS staff have access to the information needed to streamline access, communication and coordination with Choices for Independence Waiver participants working with APS.

In addition to improvements in the APS technology system, funds will further enhance APS operations by providing training to staff which will include sending APS staff to the National Adult Protective Services Association's annual conference, and other training opportunities relevant to APS work and competencies, including specialized focus areas such as forensic interviewing. Funds are also targeted for direct client services for emergent situations and circumstances that need to be addressed as a transition to long term supports and services. These services would include immediate help for food, shelter, utilities, and other basic needs. Some of the funds will be used to purchase equipment for APS staff and for the public awareness activities such as updating printed and other outreach materials.

Lastly, some funds will be used to further the work in process with Evident Change, formerly the National Council on Crime & Delinquency and the Children's Research Center to review and revise the Structured Decision-Making® assessments used in Adult Protective Services. These tools were implemented in 2008 through a contract with the National Council on Crime & Delinquency and the Children's Research Center and had a minor revision in 2011. We are currently updating these systems. The Structured Decision-Making model for adult protection services assists New Hampshire APS to make decisions, based on a standardized tool, for and with vulnerable adults. This evidence and research-based system, which Evident Change created, identifies the key points in an APS case and uses structured assessments to improve the consistency and validity of each decision. The Structured Decision-Making model for adult protection seeks to reduce subsequent harm to vulnerable adults and to improve the delivery of appropriate services.

- Class 041 Audit costs per state requirements.
- Class 066 Provides funding for APS staff training.
- Class 069 Funding for updating and developing public awareness and educational material.

- Class 102 Information technology development and implementation of an on-line reporting platform, automation of the BEAS State Registry and the Structured Decision-Making model.


