EXPLANATION

Position #9T3108, 11-9110 MED-HLTH SVS MGRS-2, was previously extended through May 31, 2024, on Fiscal Committee Item FIS #23-167 approved on May 19, 2023, and Governor and Executive Council Item #161 approved on May 31, 2023. At the time of that approval, the position was funded with Health Disparities grant funding from the Centers for Disease Control and Prevention (CDC). This position has since been reassigned to be supported with federal Public Health Infrastructure Grant funding from the CDC to strengthen emergency preparedness capabilities. This request is **retroactive** due to the need to extend the end date of the position being overlooked when it was reassigned.

This position is needed beyond the current end date to deliver vital functions in the Division's Bureau of Emergency Preparedness, Response, and Recovery. This position will communicate with hospitals, collect and analyze hospital census and supply data, and support public communication campaigns during emergencies. The communications specialist serves as a liaison between the Division, partners in the New Hampshire healthcare system, the state healthcare coalition, and public health agencies to support information sharing needs. In addition, the data collection and analysis conducted by this position informs, guides, and directs resources to help reduce inefficiencies and increase coordination and communication between healthcare and public health agencies and state agencies.

The following information is provided in accordance with the Comptroller's instructional memorandum dated September 21, 1981.

1. List of personnel involved: One full-time temporary 11-9110 MED-HLTH SVS MGRS-2, 9T3108.
2. Nature, Need, and Duration: This position will provide program administration, conduct training and education on information sharing platforms that support the healthcare system during emergencies, and develop strategies to support effective communications during an emergency impacting the healthcare system.
3. Relationship to existing agency programs: This position is part of programs executed by the Bureau of Emergency Preparedness, Response, and Recovery and is vital to the communication between state agencies and our healthcare partners.

5. Why wasn't funding included in the agency's budget request? The funding that will be utilized to pay for this position is included in the agency's budget request for FY 2026 and FY 2027.

This position is needed beyond the current end date to deliver vital functions to three programs in the Department's Bureau of Protection and Wellness: Oral Health, Asthma, and Tobacco Control and Cessation Programs. The Program Planner III coordinates, plans, develops, and evaluates activities that ensure children and adults who do not have access to dental care receive preventative and reparative dental services. In addition, the data collection and analysis conducted by this position informs, guides, and directs resources and programming to help reduce emergency department visits and hospitalizations due to asthma, as well as increase access to tobacco cessation services that reduce tobacco-related death and disease.



EXPLANATION

This request is being made to transfer funds out of class 066 Employee Training and class 074 Grants for Pub Asst and Relief within the COVID-19 Health Disparities program to cover the costs for the ongoing support to the New Hampshire Division of Fire Standards and Training and Emergency Medical Services (FSTEMS), Bureau of Emergency Medical Services. This transfer will allow for the continuation of program service contracts through the end of the grant period and is in alignment with the goals of the funding source to improve access to health care in rural communities and among other individuals that experience barriers to care.

The following appropriation adjustments are being requested:

- Class 066 Funding is being transferred out of Class 066 due to a change in activities of this grant. Initially, specific funding had been designated for workforce support. The need has now decreased because of other grant funds that were received specific to workforce development. Since funding is now needed in other class lines, these funds are being moved into Class 102.
- Class 074 Funding is being transferred out of Class 074 due to a change in activities of this grant and the funding is no longer needed in this class. These funds are being transferred to class 085.
- Class 085 Funding is being transferred into Class 085 due to the ongoing support to the New Hampshire Division of Fire Standards and Training and Emergency Medical Services, Bureau of Emergency Medical Services. The funding supports training for more effective inter-facility transfers and Mobile Integrated Healthcare. Mobile Integrated Healthcare utilizes community paramedics and others to deliver care and services to patients in an out-of-hospital environment in coordination with healthcare facilities or other healthcare providers. This reduces the burden of preventable emergency department visits or re-admission to care. Inter-

facility transport supports the more efficient movement of patients between hospitals as well as reducing wait times for patients to receive care.

Class 102 Funding is being transferred into Class 102 in order to provide additional funding to contractors to complete the 12-month extension of activities and to fully fund cost allocation through the end of the grant period.

This transfer involves a one-time project. This is a temporary grant program that is funded through May 31, 2024.

100% Federal funds from the Centers for Disease Control and Prevention (CDC).

No, Federal program funds are carried forward each year.

7. Are personnel services involved?

REQUESTED ACTION

Pursuant to RSA 14:30-a, VI and RSA 124:15, the Department of Administrative Services (DAS) is seeking approval on behalf of State Agencies to amend the accept and expend of American Rescue Plan (ARP), the Bipartisan Infrastructure Law (BIL) and other previously enacted federal relief bills related to the COVID-19 pandemic funded requests by extending the end date for funding, new positions, and/or new Class 046-Consultants, created in relation to the acceptance of these funds, to the dates listed in Attachment A, but no later than June 30, 2025, effective upon approval of the Fiscal Committee and the Governor and Executive Council. 100% Federal Funds.

EXPLANATION

The Department of Administrative Services is seeking approval, on behalf of the State Agencies listed in Attachment A, to extend the effective date of the attached items from June 30, 2023 to the dates listed, but no later than June 30, 2025. This extension is allowable under the "procedural rules amendment" approved at the Fiscal Committee meeting held on April 21, 2023. Attachment A excludes programs approved with the acceptance of ARP State Fiscal Recovery Funds which are being presented via a separate request. All items included in Attachment A have been previously submitted by the respective state agency responsible for the program; and approved by both the Fiscal Committee and Governor and Executive Council.

This request only serves to authorize agencies' program balances that are unspent as of June 30, 2023, as well as positions and consultants created pursuant to RSA 124:15, to carry forward into FY24. This will align programs with the completion dates authorized in the award notices. Any request to reallocate an existing budget or repurpose funds for new or existing projects will require future Fiscal Committee and Governor and Council approvals.



If this item is not approved, the State would need to issue layoff notices to employees hired into these federally funded positions, created under the original request, and agencies would halt time sensitive projects. Further, each agency would then need to submit a retroactive request to July 1, 2023 for approval to reauthorize the positions and funding; however, the retroactive requests would not eliminate the need to issue layoff notices in June 2023.

Typically, agencies budget for known federal grants in the upcoming biennial budget; however, the budget guidance issued in August 2022 instructed agencies to exclude all COVID-related funding from their FY24-FY25 budget submissions. Although the funding is authorized by the federal government beyond June 30, 2023, including this one-time funding would have erroneously inflated the FY24-FY25 State budget.

In the event that Federal Funds are no longer available, General Funds will not be requested to support these programs. The Department of Administrative Services seeks approval of this request.



Public Health Equity Policy Manager - Administrator who will be hired to oversee the daily operations and provide supervisory oversight of the COVID Health Disparity Grant within Division of Public Health Services. This position will also have oversight over the DPHS Bureau of Public Health Policy and Equity. The role responsibilities include programmatic and technical aspects of the project, administrative oversight and supervision, budget management, and assuring that the program meets its project goals. This position is also responsible for planning, implementing and completing project tasks, developing and monitoring the work plan activities, preparing reports, and developing and maintaining partnerships with key stakeholders.


