**REQUESTED ACTION**

That approval be and hereby is given to the Attorney General to appoint Colin Carroll to Position #9U584 (Appropriation #02-20-20-201010-2623-013-500132) as an Assistant Attorney General at a salary level of \$81,000, effective upon Governor and Executive Council approval or February 7, 2025, whichever is later, for a term ending August 15, 2028.

**EXPLANATION**

Mr. Carroll, a resident of Manchester, is a member of the New Hampshire Bar. He earned his Bachelor of Arts in Political Science from Providence College in 2016, with a focus in Economics and a Minor in English. He graduated from the University of New Hampshire, Franklin Pierce School of Law with a Juris Doctor in 2022; in addition to that degree, he also received Certificates in Intellectual Property and Entertainment Law. He was a Student Bar Association Governor during his first year of law school and a Public Safety Intern at the Connecticut Attorney General's Office following his first and second years. He began his legal career as an Associate at Feniger, Uliasz & Stacey, PLLC, in Manchester. He joined the Department in 2024 and was assigned to the Public Safety and Infrastructure Bureau. I plan to continue his current assignment. His salary will increase by \$3,000 from \$78,000 to \$81,000. A copy of his resume is attached.

RSA 21-M:3 and RSA 94:1-a(I)(c)(3) provide that the designation of positions, salary levels, and salary increases for attorneys at the Department of Justice shall be determined by the Attorney General, subject to approval of the Governor and Council, within appropriations made to the Department of Justice.
