

REQUESTED ACTION

Authorize the Department of Natural and Cultural Resources, Division of Parks and Recreation to make a payment to the Mount Washington Summit Road Company d/b/a Mount Washington Auto Road (VC #154040), Gorham, NH in the amount of \$24,000 for a portion of road repairs to the auto road for wear and tear caused by DNCR's snow cats during the 2024-2025 winter season upon Governor and Council approval. 100% Other Funds (Revolving Funds).

Funding is available in account, Mt. Washington Commission, as follows:

EXPLANATION

The Department of Natural and Cultural Resources (DNCR) and the Mount Washington Auto Road (Auto Road) have had an agreement since 1975, when Auto Road expanded and improved the summit parking areas at Mount Washington State Park. The 2004 agreement continued to provide Auto Road with use of DNCR's summit parking areas and granted DNCR access to the summit via the auto road, but also provided reimbursement to Auto Road to cover damages to the auto road from the snow cat equipment used by DNCR to access the summit in the winter.

The DNCR and the Auto Road entered into a Non-Disturbance Agreement (NDA) in 2016, in order to allow Auto Road to secure financing for its hotel project located at the base of Mount Washington (approved by the Governor and Executive Council on August 24, 2016, Item #46B). The NDA provided Auto Road rights to use the summit parking areas and DNCR rights to access the summit via the auto road through August 2, 2033. Reimbursement for yearly winter damage costs to the auto road was not included in the NDA. For this reason, costs are assessed yearly once the winter season has ended and an evaluation of repairs and associated costs can be determined.

Current estimated road repair and maintenance needs relative to the length of the auto road particularly where it is now paved is assessed to be \$24,000 for DNCR. A copy of the invoice from the Auto Road is attached.
