REQUESTED ACTION

Authorize the Department of Education to enter into an amendment to an existing contract with Roxanne Vallee (VC#306571) Center Harbor, New Hampshire, as a Master Educational Surrogate Parent, to provide management and support for trained and certified volunteer educational surrogate parents, by increasing the price limitation by \$5,000 from \$75,000 to \$80,000 with no change to the scope of services or contract end date effective upon Governor and Council approval through June 30, 2025. The original item was approved by Governor and Council on September 7, 2022, Item 94 and amended on December 21, 2022, Item 110. 100% Federal Funds

EXPLANATION

The NH Department of Education (NHED) would like to amend the contract with Roxanne Vallee as the number of hours needed to support her assigned caseload of students is considerably higher than previously expected. Therefore, Ms. Vallee is spending through her balance faster than anticipated, and there is a pattern showing that she will require additional funds in order to adequately support her assigned students through the springtime months until her contract ends in June 2025.

According to IDEA (34 CFR 300.322) each public agency must take steps to ensure that the parent of a student with a disability can participate in the special education process. The surrogate must participate in the special education process the same as a parent would and must be available for meetings and for

providing consent. IDEA stipulates a set timeframe for various steps in the special education process, and these timelines cannot be extended or stopped because a parent is unavailable to participate. In the event that a child's parents are unable to be located, are unknown or the child is a ward of the state, a court has issued a written order for an educational surrogate parent. Furthermore, if a child is found to be homeless in accordance with the McKinney-Vento Act, IDEA further calls for the appointment of a surrogate parent (34 CFR 300.519) to act as a parent for the child in the special education process. The appointment of an educational surrogate parent can terminate when the child turns 18, is otherwise adopted, or is discharged from the special education process. In some circumstances, a student may request that an educational surrogate parent be appointed past the age of 18 if the student continues to receive special education.


To abide by these requirements, NHED maintains a network of volunteer educational surrogate parents, as well as four (4) contracted Master Educational Surrogate Parents (MESPs). MESPs complete similar work as volunteers; however, they are assigned a higher quantity of cases, typically with greater complexity, and have more experience in special education. Additionally, MESPs may coach or provide advice to volunteer educational surrogate parents and assist NHED in developing resources for volunteers.

All requests and application materials for educational surrogate parents undergo a referral process based on the Rules prescribed in the New Hampshire Standards for the Education of Children with Disabilities.

Ms. Vallee's contract is one of four to provide services as part of a Request for Proposal (RFP) titled Educational Surrogate Parent Program: Master Surrogate Parents. She has currently over 25 students on her caseload, some of which have requested that she remain appointed to them past the age of 18. This larger, older caseload, coupled with the complexity of her cases requiring participation in multiple special education team meetings per school year, has led to Ms. Vallee billing for more hours than her MESP colleagues.

NHED would like to amend the contract with Ms. Vallee because she has served as an educational surrogate parent for a cumulative total of 16 years (10 as a volunteer and 6 as a master), during which time she has been seen as an asset and essential team member by both the students that she serves, as well as the school districts she collaborates with to ensure that these vulnerable children receive a free appropriate public education.

EXPLANATION

This request is retroactive due to the federal requirement that all contracted vendors must obtain a Unique Entity Identification Number (UEI). The New Hampshire Department of Education is responsible for training and appointing Master Educational Surrogate Parents as well as volunteer educational surrogate parents for those educationally disabled students whose parents are unable to be located, are unknown, the child is under legal guardianship of DCYF, a court has issued a written order for an educational surrogate parent, or a child is found to be homeless in accordance with the McKinney Vento Act. The Educational Surrogate Parent Program serves students up to the age of 21 years. Master Educational Surrogate Parents complete the same work as volunteers however have more cases, usually more complex cases and have more experience in special education.

All requests and application materials for educational surrogate parents undergo a referral process based on the Rules prescribed in the New Hampshire Standards for the Education of Children with Disabilities.


A Request for Proposals (RFP) was advertised in the Manchester Union Leader for the period March 18, 20 & 21, 2022, advertised in the Concord Monitor for the period of March 17, 18 & 19, 2022. The Bureau of Special Education Support received four (4) proposals from the issuance of the Request for Proposals "Educational Surrogate Parent Program: Master Surrogate Parents."

A review committee met on April 28, 2022. The review panel consisted of the following employees from the Department of Education Bureau of Special Education Support; Brandy P, Educational Consultant, Mary L, Educational Consultant, Mary S, Educational Consultant, and Daniellé P, as facilitator. All four proposals submitted met the criteria of the Request for Proposals (Attachment A).

This contract is one of four to provide services as a Master Educational Surrogate Parent who will be responsible for providing management and support to trained and certified volunteer educational surrogate parents. In addition, these Master Educational Surrogate Parents will be responsible for temporary educational surrogate parent appointments in situations that are viewed by the Department of Education, Bureau of Special Education Support to need a Master Educational Surrogate Parent level of expertise, or a child is found to be homeless in accordance with the McKinney Vento Act.

The Department of Education would like to contract with Ms. Vignola because she is an experienced educational surrogate parent, has extensive knowledge in special education, has a passion for ensuring that children with disabilities receive a free appropriate public education, and is especially focused on the needs of underserved children.

Funds are available in the following account for FY23 and are anticipated to be available in FY24 and FY25, upon the availability and continued appropriation of funds in the future operating budget, with the authority to adjust encumbrances between fiscal years within the price limitation through the Budget Office, without further Governor and Council approval, if needed and justified.

EXPLANATION

The New Hampshire Department of Education is responsible for training and appointing Master Educational Surrogate Parents as well as volunteer educational surrogate parents for those educationally disabled students whose parents are unable to be located, are unknown, the child is under legal guardianship of DCYF, a court has issued a written order for an educational surrogate parent, or a child is found to be homeless in accordance with the McKinney Vento Act. The Educational Surrogate Parent Program serves students up to the age of 21 years. Master Educational Surrogate Parents complete the same work as volunteers however have more cases, usually more complex cases and have more experience in special education.

A Request for Proposals (RFP) was advertised in the Manchester Union Leader for the period March 18, 20 & 21, 2022, advertised in the Concord Monitor for the period of March 17, 18 & 19, 2022. The Bureau of Special Education Support received four (4) proposals from the issuance of the Request for Proposals "Educational Surrogate Parent Program: Master Surrogate Parents."



2. SERVICES TO BE PERFORMED. The State of New Hampshire, acting through the agency identified in block 1.1 ("State"), engages contractor identified in block 1.3 ("Contractor") to perform, and the Contractor shall perform, the work or sale of goods, or both, identified and more particularly described in the attached EXHIBIT B which is incorporated herein by reference ("Services").

3. EFFECTIVE DATE/COMPLETION OF SERVICES.

3.1 Notwithstanding any provision of this Agreement to the contrary, and subject to the approval of the Governor and Executive Council of the State of New Hampshire, if applicable, this Agreement, and all obligations of the parties hereunder, shall become effective on the date the Governor and Executive Council approve this Agreement as indicated in block 1.17, unless no such approval is required, in which case the Agreement shall become effective on the date the Agreement is signed by the State Agency as shown in block 1.13 ("Effective Date").

3.2 If the Contractor commences the Services prior to the Effective Date, all Services performed by the Contractor prior to the Effective Date shall be performed at the sole risk of the Contractor, and in the event that this Agreement does not become effective, the State shall have no liability to the Contractor, including without limitation, any obligation to pay the Contractor for any costs incurred or Services performed. Contractor must complete all Services by the Completion Date specified in block 1.7.

4. CONDITIONAL NATURE OF AGREEMENT.

Notwithstanding any provision of this Agreement to the contrary, all obligations of the State hereunder, including, without limitation, the continuance of payments hereunder, are contingent upon the availability and continued appropriation of funds affected by any state or federal legislative or executive action that reduces, eliminates or otherwise modifies the appropriation or availability of funding for this Agreement and the Scope for Services provided in EXHIBIT B, in whole or in part. In no event shall the State be liable for any payments hereunder in excess of such available appropriated funds. In the event of a reduction or termination of appropriated funds, the State shall have the right to withhold payment until such funds become available, if ever, and shall have the right to reduce or terminate the Services under this Agreement immediately upon giving the Contractor notice of such reduction or termination. The State shall not be required to transfer funds from any other account or source to the Account identified in block 1.6 in the event funds in that Account are reduced or unavailable.

5. CONTRACT PRICE/PRICE LIMITATION/ PAYMENT.

5.1 The contract price, method of payment, and terms of payment are identified and more particularly described in EXHIBIT C which is incorporated herein by reference.

5.2 The payment by the State of the contract price shall be the only and the complete reimbursement to the Contractor for all expenses, of whatever nature, incurred by the Contractor in the performance hereof, and shall be the only and the complete

compensation to the Contractor for the Services. The State shall have no liability to the Contractor other than the contract price.

5.3 The State reserves the right to offset from any amounts otherwise payable to the Contractor under this Agreement those liquidated amounts required or permitted by N.H. RSA 80:7 through RSA 80:7-e or any other provision of law.

5.4 Notwithstanding any provision in this Agreement to the contrary, and notwithstanding unexpected circumstances, in no event shall the total of all payments authorized, or actually made hereunder, exceed the Price Limitation set forth in block 1.8.

6. COMPLIANCE BY CONTRACTOR WITH LAWS AND REGULATIONS/ EQUAL EMPLOYMENT OPPORTUNITY.

6.1 In connection with the performance of the Services, the Contractor shall comply with all applicable statutes, laws, regulations, and orders of federal, state, county or municipal authorities which impose any obligation or duty upon the Contractor, including, but not limited to, civil rights and equal employment opportunity laws. In addition, if this Agreement is funded in any part by monies of the United States, the Contractor shall comply with all federal executive orders, rules, regulations and statutes, and with any rules, regulations and guidelines as the State or the United States issue to implement these regulations. The Contractor shall also comply with all applicable intellectual property laws.

6.2 During the term of this Agreement, the Contractor shall not discriminate against employees or applicants for employment because of race, color, religion, creed, age, sex, handicap, sexual orientation, or national origin and will take affirmative action to prevent such discrimination.

6.3 The Contractor agrees to permit the State or United States access to any of the Contractor's books, records and accounts for the purpose of ascertaining compliance with all rules, regulations and orders, and the covenants, terms and conditions of this Agreement.

7. PERSONNEL.

7.1 The Contractor shall at its own expense provide all personnel necessary to perform the Services. The Contractor warrants that all personnel engaged in the Services shall be qualified to perform the Services, and shall be properly licensed and otherwise authorized to do so under all applicable laws.

7.2 Unless otherwise authorized in writing, during the term of this Agreement, and for a period of six (6) months after the Completion Date in block 1.7, the Contractor shall not hire, and shall not permit any subcontractor or other person, firm or corporation with whom it is engaged in a combined effort to perform the Services to hire, any person who is a State employee or official, who is materially involved in the procurement, administration or performance of this Agreement. This provision shall survive termination of this Agreement.

7.3 The Contracting Officer specified in block 1.9, or his or her successor, shall be the State's representative. In the event of any dispute concerning the interpretation of this Agreement, the Contracting Officer's decision shall be final for the State.

10. DATA ACCESS/CONFIDENTIALITY

10.1 As used in this Agreement the word "data" shall mean all information and things developed or obtained during the performance of, or acquired or developed by reason of, this Agreement, including, but not limited to, all studies, reports, files, formulas, surveys, maps, charts, sound recordings, video recordings, pictorial reproductions, drawings, analyses, graphic representations, computer programs, computer printouts, notes, letters, memoranda, papers, and documents, all of which shall be included or unfinished.

10.2 All data and any property which has been received from the State or purchased with funds provided for that purpose under this Agreement, shall be the property of the State, and shall be returned to the State upon demand or upon termination of this Agreement for any reason.

10.3 Confidentiality of data shall be governed by N.H. RSA Chapter 91-A or other, existing law. Disclosure of data requires prior written approval of the State.

11. CONTRACTOR'S RELATION TO THE STATE. In the performance of this Agreement the Contractor is in all respects an independent contractor, and is neither an agent, nor an employee of the State. Neither the Contractor nor any of its officers, employees, agents or members shall have authority to bind the State or receive any benefits, workers' compensation or other compensation provided by the State to its employees.

12. ASSIGNMENT/DELEGATION/SUBCONTRACTS.

12.1 The Contractor shall not assign, or otherwise transfer any portion in this Agreement without the prior written notice, which shall be provided to the State at least fifteen (15) days prior to the assignment, and a written consent of the State. For purposes of this paragraph, a Change of Control shall constitute assignment. "Change of Control" means (a) merger, consolidation, or a transaction or series of related transactions in which a third party, together with its affiliates, becomes the direct or indirect owner of fifty percent (50%) or more of the voting shares or similar equity interests or combined voting power of the Contractor; or (b) the sale of all or substantially all of the assets of the Contractor.

12.2 None of the Services shall be subcontracted by the Contractor without prior written notice and consent of the State. The State is entitled to copies of all subcontracts and assignment agreements and shall not be bound by any provisions contained in a subcontract or an assignment agreement to which it is not a party.

13. INDEMNIFICATION. Unless otherwise exempted by law, the Contractor shall indemnify and hold harmless the State, its officers and employees, from and against any and all claims, liabilities and costs (including attorneys' fees and all other expenses) for any personal injury or property damage, or other claims asserted against the State, its officers or employees, which arise out of or which may be claimed to arise out of) the acts or omissions of the

8. EVENT OF DEFAULT/REMEDIES.

8.1 Any one or more of the following acts or omissions of the Contractor shall constitute an event of default hereunder ("Event of Default"):

- 8.1.1 Failure to perform the Services substantially or on schedule;
 - 8.1.2 Failure to submit any report required hereunder; and/or
 - 8.1.3 Failure to perform any other covenant, term or condition of this Agreement.
- 8.2 Upon the occurrence of any Event of Default, the State may take any one, or more, or all of the following actions:
- 8.2.1 Give the Contractor a written notice specifying the Event of Default and requiring it to be remedied within, in the absence of a prior or lesser specification of that, thirty (30) days from the date of the notice; and if the Event of Default is not timely cured, terminate this Agreement, effective two (2) days after giving the Contractor notice of termination;

14.3 The Contractor shall furnish to the Contracting Officer identified in block 1.9, or his or her successor, a certificate(s) of insurance for all insurance required under this Agreement. Contractor shall also furnish to the Contracting Officer identified in block 1.9, or his or her successor, certificate(s) of insurance for all renewal(s) of insurance required under this Agreement no later than ten (10) days prior to the expiration date of each insurance policy. The certificate(s) of insurance and any renewals thereof shall be attached and are incorporated herein by reference.

15. WORKERS' COMPENSATION.

15.1 By signing this agreement, the Contractor agrees, certifies and warrants that the Contractor is in compliance with or exempt from, the requirements of N.H. RSA chapter 281-A ("Workers' Compensation").

15.2 To the extent the Contractor is subject to the requirements of N.H. RSA chapter 281-A, Contractor shall maintain, and require any subcontractor or assignee to secure and maintain, payment of Workers' Compensation in connection with activities which the person proposes to undertake pursuant to this Agreement. The Contractor shall furnish the Contracting Officer identified in block 1.9, or his or her successor, proof of Workers' Compensation in the manner described in N.H. RSA chapter 281-A and any applicable renewal(s) thereof, which shall be attached and are incorporated herein by reference. The State shall not be responsible for payment of any Workers' Compensation premiums or for any other claim or benefit for Contractor, or any subcontractor or employee of Contractor, which might arise under applicable State of New Hampshire Workers' Compensation laws in connection with the performance of the Services under this Agreement.

16. NOTICE. Any notice by a party hereto to the other party shall be deemed to have been duly delivered or given at the time of mailing by certified mail, postage prepaid, in a United States Post Office addressed to the parties at the addresses given in blocks 1.2 and 1.4, herein.

17. AMENDMENT. This Agreement may be amended, waived or discharged only by an instrument in writing signed by the parties hereto and only after approval of such amendment, waiver or discharge by the Governor and Executive Council of the State of New Hampshire unless no such approval is required under the circumstances pursuant to State law, rule or policy.

18. CHOICE OF LAW AND FORUM. This Agreement shall be governed, interpreted and construed in accordance with the laws of the State of New Hampshire, and is binding upon and inures to the benefit of the parties and their respective successors and assigns. The wording used in this Agreement is the wording chosen by the parties to express their mutual intent, and no rule of construction shall be applied against or in favor of any party. Any actions arising out of this Agreement shall be brought and maintained in New Hampshire Superior Court which shall have exclusive jurisdiction thereof.

19. CONFLICTING TERMS. In the event of a conflict between the terms of this P-37 form (as modified in EXHIBIT A) and/or attachments and amendments thereof, the terms of the P-37 (as modified in EXHIBIT A) shall control.

20. THIRD PARTIES. The parties hereto do not intend to benefit any third parties and this Agreement shall not be construed to confer any such benefit.

21. HEADINGS. The headings throughout the Agreement are for reference purposes only, and the words contained therein shall in no way be held to explain, modify, amplify or aid in the interpretation, construction or meaning of the provisions of this Agreement.

22. SPECIAL PROVISIONS. Additional or modifying provisions set forth in the attached EXHIBIT A are incorporated herein by reference.

23. SEVERABILITY. In the event any of the provisions of this Agreement are held by a court of competent jurisdiction to be contrary to any state or federal law, the remaining provisions of this Agreement will remain in full force and effect.

24. ENTIRE AGREEMENT. This Agreement, which may be executed in a number of counterparts, each of which shall be deemed an original, constitutes the entire agreement and understanding between the parties, and supersedes all prior agreements and understandings with respect to the subject matter hereof.
