**EXPLANATION**

The Department of Safety, Division of State Police, requests authorization to transfer funds between accounts to address anticipated shortages and maintain current service levels in the Traffic Bureau detailed below. This request is being sought because this accounting unit has exceeded the \$100,000 year-to-date transfer authority of \$100,000.

**Traffic Bureau (4003)**

- Class 039, Telecommunications - \$48,000 is available due to lower than budgeted usage.
- Class 103, Contracts for Op Services - \$48,000 is needed due to an unplanned expense for installation of a chain link fence at 108 Clinton Street.

The following information is provided in accordance with the Budget Officer's instructional memorandum dated April 17, 1985 to support the above requested actions:

- 1) *Does transfer involve continuing programs or one-time projects?* The transfer involves continuing programs.
- 2) *Is this transfer required to maintain existing program level or will it increase the program level?* This transfer is required to maintain existing program levels.
- 3) *Cite any requirements which make this program mandatory.* RSA 21-P
- 4) *Identify the source of funds on all accounts listed on this transfer.* The source of funds for accounts listed on this transfer is 34% General Funds, 41% Highway Funds and 25% Turnpike Funds.
- 5) *Will there be any effect on revenue if this transfer is approved or disapproved?* There will be no effect on revenue.
