REQUESTED ACTION

Authorize the Department of Health and Human Services, Office of the Commissioner, to enter into a **Sole Source** amendment to an existing contract with Alvarez & Marsal Public Sector Services, LLC (VC# 333545-P001), Washington, DC, for services to support long-term strategic efforts to improve the quality of services delivered to New Hampshire citizens and increase operational efficiencies, by increasing the price limitation by \$9,847,800 from \$27,640,000 to \$37,487,800 and by extending the completion date from June 30, 2025, to June 30, 2027, effective July 1, 2025, upon Governor and Council approval. 79% Federal Funds. 21% General Funds.

The original contract was approved by Governor and Council on June 16, 2021 (Tabled Item #7A), amended on October 27, 2021 (Item #5A), and most recently amended on May 31, 2023 (Item #8).

Funds are anticipated to be available in the following accounts for State Fiscal Years 2026 and 2027, upon the availability and continued appropriation of funds in the future operating budget, with the authority to adjust budget line items within the price limitation and encumbrances between state fiscal years through the Budget Office, if needed and justified.

EXPLANATION

The Department initially entered into this agreement with the Contractor in 2021 and focused on three (3) targeted areas:

- 1) Strengthening Developmental Disabilities System services and assisting the Department with coming into compliance with a Centers for Medicare & Medicaid (CMS) corrective action plan, enabling the Department to maintain the federal match for these services;
- 2) Initiating the multi-year Medicaid Enterprise System procurement strategy to modernize the State's Medicaid Management Information System; and
- 3) Obtaining federal approval on the Institutions for Mental Disease (IMD) waiver for behavioral health initiatives that aim to decrease hospital readmissions.

The Contractor helped ensure the Department achieve completion of the IMD waiver outcomes. However, additional time is needed to complete the Medicaid Enterprise Strategy and Developmental Disability Systems Strengthening work. Given the Contractor's experience these last four years of working with NH systems coupled with their highly specialized expertise and knowledge of the Developmental Disabilities Systems and Medicaid Enterprise System strategy, the Department is seeking to extend the contract to continue working with the Contractor to complete the remaining scope of work. Additionally, the Contractor will support the roll out of a new community reentry program, which leverages additional federal Medicaid money to support incarcerated people with behavioral health needs as they prepare to return to the community. This request is **Sole Source** because MOP 150 requires all amendments to agreements originally approved as sole source to be identified as sole source.

Should the Governor and Council not authorize this request, the Department will be unable to continue critical elements of the work initiated over the last four (4) years and move initiatives forward to completion. Time and resources invested by the State in these critical service areas since 2021 would fail to achieve the targeted outcomes, putting at risk efforts related to the Developmental Disability System and the State's Medicaid Enterprise System and resulting in the loss of the Department's ability to address these areas in the long term.

The purpose of this request is for the Contractor to continue to provide support on the following specific areas:

- **Developmental Disability Systems Strengthening:** The Contractor will support the Department with continuing to expand its use of data-driven program management and decision-making to guide the phase-in of assessment-informed rates; transitioning to an approved monthly rate for Financial Management Services (FMS); and continuing to provide budget analysis, projections and targeted technical assistance to the Department and partner agencies.
- **Medicaid Enterprise System Modernization:** Over the last four (4) years, the Contractor has supported the Department with creating a 10-year strategy to modularly procure, design, develop, and implement a scalable Medicaid Enterprise System (MES); securing over \$54 million dollars in federal funding in support of eight (8) components of the 10-year strategy; and conducting research and analysis to create the requirements, scope, procurement documents, federal reporting, and business process management needed for the Medicaid Enterprise System. The Contractor will continue to support the Department, in collaboration

with the NH Department of Information Technology, with MES implementation across multiple modules supporting Advanced Planning Document (APD) development and updates as needed to leverage 90% federal matching funds; supporting solicitation development; and achieving Centers for Medicare & Medicaid Services (CMS) approvals. Additionally, the Contractor will support key elements of project and change management, including simultaneous efforts to implement execution strategy recommendations and enhance the governance structure to manage multiple vendors as well as Design, Development, and Implementation (DDI) approaches; and preliminarily assessing the procurement process for large-scale projects in anticipation of multiple modular contracts and RFP processes over the next biennium.

- **Supporting 1115 Waiver Demonstration:** The Contractor will support the Department with the continued roll out of the new community reentry program, which leverages additional federal Medicaid money to support incarcerated people with behavioral health needs as they prepare to return to the community. This program was approved by the federal government in mid-2024, and the State's implementation plan was approved in early 2025. NH launched the first phase of reentry services in state prisons in January 2025 and will expand the program to county jails over the coming years. The Contractor will continue to support the state to monitor and improve quality of a program that provides federal Medicaid reimbursement for short-term stays in psychiatric hospitals for people with mental illness and/or substance use disorder (IMD reimbursement). The Contractor will also support the process of securing federal approval for a new program that would allow NH to collect additional federal Medicaid reimbursement for certain types of children's behavioral health care not currently covered by Medicaid.

Since this agreement began in 2021, the services and support provided by the Contractor have enabled the Department to:

- Come into compliance with a Corrective Action Plan focused on Direct Bill and Conflict of Interest for Developmental Services.
- Support Area Agencies and provider agencies with the transition to Direct Bill by providing data analytics for Medicaid claims and billing.
- Develop and implement a communication strategy and plan for engaging Developmental Services stakeholders and conducting more than 506 stakeholder sessions.
- Engage with stakeholders using a national subject matter expert to receive input from families and service providers on what is working well and identify areas for improvement for Self-Directed Services for Developmental Services.
- Coordinate CMS approval of 1115 amendment for Nursing Facility Dentures Benefit.
- Create a 10-year Medicaid Enterprise System implementation plan based on multiple states' directions and Centers for Medicare & Medicaid Services direction to establish a competitive marketplace for the Department to modularly implement a system based on enterprise architecture that leverages technology that may adapt to the changes needed by federal and state requirements.
- Create requirements and scope based on research involving several states across the country as well as discussions with Centers for Medicare & Medicaid Services partners for seven (7) modules (Electronic Visit Verification, Enterprise Business Intelligence, System Integrator, Care Coordination, Event Notification, Pharmacy Benefits Management, and Project Management Managed Services of the 10-year MES plan).
- Secure 90% enhanced federal funding equating to over \$54 million dollars to support eight (8) MES contracts.

- Secure approval for new federal Medicaid reimbursement for types of hospital stays not typically covered by Medicaid, such as short-term stays in psychiatric hospitals for people with mental illness and/or substance use disorder (IMD reimbursement).
- Launch operational changes to allow the State to begin collecting new federal Medicaid reimbursement for qualifying psychiatric hospital stays.
- Lead a cross-agency initiative with the NH Department of Corrections to secure federal authority for a new reentry component of the 1115 demonstration to support individuals with behavioral health needs as they reenter the community following incarceration.
- Implement a new community reentry program in NH Department of Corrections state prisons in January 2025.

The Department will continue to monitor Contractor services through the required bi-weekly status reports, which will include:

- Progress against the work plans established in the previous contract phase.
- Detailed accomplishments for each bi-weekly cycle.
- Identification of any risks and issues, as applicable.
- Additional detailed documentation related to work plans, stakeholder engagement planning, and budget impact by work stream upon the Department's request.

This Amendment to the Strategic Vision & Operational Efficiencies contract is by and between the State of New Hampshire, Department of Health and Human Services ("State" or "Department") and Alvarez & Marsal Public Sector Services, LLC ("the Contractor").

WHEREAS, pursuant to an agreement (the "Contract") approved by the Governor and Executive Council on June 16, 2021 (Tabled Item #7), as amended on October 27, 2021 (Item #5A) and on May 31, 2023 (Item #8), the Contractor agreed to perform certain services based upon the terms and conditions specified in the Contract as amended and in consideration of certain sums specified; and

WHEREAS, pursuant to Form P-37, General Provisions, Paragraph 17, the Contract may be amended upon written agreement of the parties and approval from the Governor and Executive Council; and

NOW THEREFORE, in consideration of the foregoing and the mutual covenants and conditions contained in the Contract and set forth herein, the parties hereto agree to amend as follows:

1. Form P-37 General Provisions, Block 1.7., Completion Date, to read:
June 30, 2027
2. Form P-37, General Provisions, Block 1.8., Price Limitation, to read:
\$37,487,800
3. Add Exhibit B-1, Amendment #3, Scope of Services, which is attached hereto and incorporated by reference herein.
4. Modify Exhibit C, Payment Terms, Section 1, to read:
 1. This Agreement is funded by 74% Federal Funds for Medicaid Entitlement by the US Department for Health and Human Services, Centers for Medicare and Medicaid Services. ALN 93.778, FAIN 2105NH5ADM and FAIN 2305NH5ADM, FAIN 2505NH5ADM and 26% General Funds.
5. Modify Exhibit C, Payment Terms, Section 3, to read:
 3. The Department shall pay the Contractor at a rate of \$410,325 per month, for the period of July 1, 2025, through June 30, 2027, to provide services as specified in Exhibit B-1, Amendment #3, Scope of Services.
6. Modify Exhibit C, Payment Terms, Section 8, to read:
 8. The Contractor shall maintain and provide the Department upon request, a summary of all hours collectively worked by the team providing services under this Agreement.
7. Modify Exhibit C, Payment Terms, Section 9, to read:
 9. The Contractor must provide the services under this Agreement in compliance with funding requirements.

All terms and conditions of the Contract and prior amendments not modified by this Amendment remain in full force and effect. This Amendment shall be effective July 1, 2025, upon Governor and Council approval.



Scope of Services

1. Background

1.1. Extension of Prior Work: The Department and Contractor entered into two Agreements previously as follows:

- 1.1.1. The first agreement was approved by the Governor on August 31, 2020, retroactively effective to August 24, 2020, and amended with Governor approval on December 29, 2020, retroactively effective to October 30, 2020, and expired December 30, 2020.
- 1.1.2. In accordance with the requirements of the first agreement, the Contractor provided a strategic assessment of the Department's operations that:
 - 1.1.2.1. Quantified the impact of the COVID-19 pandemic;
 - 1.1.2.2. Identified programmatic improvements to increase operational efficiency and effectiveness;
 - 1.1.2.3. Assessed opportunities to improve the delivery of services during and after the public health emergency; and
 - 1.1.2.4. Provided the Department with specific recommendations for operations system enhancements.
- 1.1.3. Further, under the first agreement, the Contractor assessed the impact of the COVID-19 pandemic, identified vulnerabilities that may impede recovery, and provided recommendations to the Department. Through the second agreement, the Department and Contractor pursued two high-impact opportunities stemming from the pandemic related to the programmatic areas of Behavioral Health and Developmental Disabilities.
- 1.1.4. Through the second (2nd) Agreement approved by the Governor on March 11, 2021, retroactively effective to March 4, 2021, with a completion date of June 30, 2021, the Department and Contractor pursued the implementation of the recommendations made under the prior agreement, related to Behavioral Health and Developmental Disabilities. Additionally, the Contractor: (1) assisted the Bureau of Information Services (BIS) with Medicaid Management Information System (MMIS) modernization and implementation efforts; and (2) supported the Department's Senior Executive Team (SET) with an Organizational Change Management effort specific to the work in the second (2nd) Agreement.

2. Ongoing and New Initiatives

2.1. Through this Exhibit B-1 – Amendment #3 for Contract Year 5 (July 1, 2025 – June 30, 2026) and Year 6 (July 1, 2026 – June 30, 2027) of this Agreement, the Contractor will provide continued support related to the ongoing initiatives:

2.1.1. 1115 Demonstration Support.

2.1.2. Strengthening Developmental Disabilities (DD) Systems.

2.1.3. MES Modernization.

2.2. **Strategic Relevance:** The Contractor will continue acting as a strategic partner to the Department supporting the transition and completion of the short-term initiatives, and continued implementation support for the long-term initiatives, including completion of any initiatives and deliverables specified in Exhibit B – Amendment #2, as needed and mutually agreed upon by the parties. The Contractor will continue to provide status updates and advisory to the SET as well as Organizational Change Management support specific to the work identified in Paragraphs 2.1.1, 2.1.2, and 2.1.3 above.

2. **1115 Demonstration Support:** The Contractor shall support the Department with the continued implementation of the authority granted by CMS to reimburse prerelease community reentry services provided to New Hampshire's incarcerated population, which is governed by the Special Terms and Conditions (STCs) approved by CMS in July 2024 and State of New Hampshire's implementation plan approved by CMS in January 2025; continuing to operate and monitor the Substance Use Disorder (SUD) and Severe Mental Illness (SMI) components of the 1115 demonstration pursuant to the same approved STCs; continuing to pursue approval of an implementation plan to expand 1115 authority to cover services provided in certain Qualified Residential Treatment Programs (QRTPs) considered to be Institutes for Mental Diseases (IMDs). The Contractor shall continue to provide the Senior Director and Manager to support the 1115 Demonstration Support workstreams for a duration of four (4) months (16 weeks) in Year 5 at the same level of support provided in Year 4. The Contractor shall develop and submit a detailed transition plan to the Department with a clear understanding of where resources will be needed to transfer responsibility and to understand where areas of risk lie should work continue after the end of the four (4) month period with the Contractor's Senior Director and Manager support.

2.3. **Community Reentry Component – NH DOC:** The Contractor shall:

2.3.1. Continue providing operational support for implementing the demonstration authority within DOC, including through:

2.3.1.1. Bi-weekly operational huddles.

2.3.1.2. Weekly MCO touchpoints.

2.3.1.3. Bi-monthly eligibility summits.

2.3.1.4. Monthly steering committee meetings.

- 2.3.1.5. Ad hoc training and provider engagement forums.
- 2.3.2. Assist with responding to CMS feedback on the draft evaluation design to finalize the Department response within the timeline allowed by CMS.
- 2.3.3. Coordinate translation of CMS-provided monitoring protocol into available data measures and document assignment of tasks for ongoing monitoring.
- 2.3.4. Transition operational, advisory / strategic, and project management responsibilities described above to alternate resources as directed by Department leadership.
- 2.4. **SUD and SMI IMD Component:** The Contractor shall:
 - 2.4.1. Continue providing operational support for ongoing monitoring of the IMD demonstration, including through:
 - 2.4.1.1. Quarterly steering committee meetings.
 - 2.4.1.2. Ad hoc follow-up meetings to address open questions from quarterly steering committee meetings.
 - 2.4.2. Coordinate analytical support for custom reporting on average length of stay and budget neutrality.
 - 2.4.3. Provide ad hoc strategic advice related to demonstration evaluation and quarterly monitoring reports.
 - 2.4.4. Transition operational, analytical, and advisory and strategic responsibilities described above to alternate resources as directed by Department leadership.
- 2.5. **Qualified Residential Treatment Programs (QRTP) Component:** The Contractor shall:
 - 2.5.1. Assist with responding to CMS feedback on the draft QRTP implementation plan.
 - 2.5.2. Provide ad hoc strategic advice related to securing approval by CMS of the QRTP implementation plan.
 - 2.5.3. Assist with creation of structured workplan and timeline for implementing the demonstration authority in QRTPs (that are also considered to be IMDs).
 - 2.5.4. Transition advisory and strategic responsibilities described above to alternate resources as directed by Department leadership.
- 3. **DD Systems Strengthening:** The Contractor shall support the Department with continuing to strengthen its investment in stakeholder engagement and expanding its use of data-driven program management and decision-making to guide the phase-in of assessment-informed rates; transition to an approved monthly rate for Financial

3.3. Rate Implementation Planning: The Contractor shall:

 - 4.4.1.1. Developing a structure for management of multiple vendors.
 - 4.4.1.2. Defining roles and escalation structure.
- 4.4.2. Develop and support refinements to governance structure for new project phases.
- 4.4.3. Support Execution Strategy Implementation, including:
 - 4.4.3.1. Developing a structure for determining prioritization.

EXPLANATION

This request is **Sole Source** because MOP 150 requires all amendments to agreements previously approved as sole source be identified as sole source. The Contractor is uniquely qualified to continue working with the Department to collaborate and deliver valuable solutions to support long-term strategic efforts designed to improve the quality of services delivered statewide, and increase operational efficiencies within the required timeframes. Additionally, as a prominent global professional services firm, the Contractor specializes in identifying and supporting organizations to implement impactful, cost-saving, and service-improving recommendations.

The purpose of this request is for the Contractor to continue to provide support on short and long-term Department initiatives that include:

- **Critical Time Intervention Program (CTI):** Providing the Department with expert technical support and consultation services to continue to support the CTI program, which aims to diminish hospital readmission rates, curtail hospital readmission expenses for the State, and enhance community-based services.

One of the ways this will be achieved is by reviewing and updating the §1915(c) Developmental Disability Waiver structure, devising a revised methodology for the Developmental Disability waiver services, identifying the specifications for a new information technology management system to align operations with the waiver and rate redesign, and establishing in-state capacity to serve individuals requiring intensive treatment services.
- **Medicaid Management Information System (MMIS) Modernization:** Collaborating with the Bureau of Information Services to upgrade the present outdated MMIS with a certified modern and modular system, approved by the Centers for Medicare and Medicaid Services. This involves aiding in the formulation and implementation of a long-term procurement plan and offering project management assistance to ensure the successful implementation of new systems.

- **Organizational Change Management Support:** Collaborating on the development of performance metrics for each long-term initiative listed above to enable management to assess internal performance. The Department will monitor Contractor services through the required bi-weekly status reports, which will include, but are not limited to:

- Progress against the work plans established in the previous contract phase.
- Detailed accomplishments for each bi-weekly cycle.
- Risks and issues, as applicable.
- Additional detailed documentation related to work plans, stakeholder engagement planning, and budget impact by work stream upon the Department's request.

Scope of Services

1. Background

1.1. **Extension of Prior Work:** The Department and Contractor entered into two Agreements previously as follows:

1.1.1. The first agreement was approved by the Governor on August 31, 2020, retroactively effective to August 24, 2020, and amended with Governor approval on December 29, 2020, retroactively effective to October 30, 2020, and expired December 30, 2020.

1.1.2. In accordance with the requirements of the first agreement, the Contractor provided a strategic assessment of the Department's operations that:

1.1.2.1. Quantified the impact of the COVID-19 pandemic;

1.1.2.2. Identified programmatic improvements to increase operational efficiency and effectiveness;

1.1.2.3. Assessed opportunities to improve the delivery of services during and after the public health emergency; and

1.1.2.4. Provided the Department with specific recommendations for operations system enhancements.

1.1.3. Further, under the first agreement, the Contractor assessed the impact of the COVID-19 pandemic, identified vulnerabilities that may impede recovery, and provided recommendations to the Department. Through the second agreement, the Department and Contractor pursued two high-impact opportunities stemming from the pandemic related to the programmatic areas of Behavioral Health and Developmental Disabilities.

1.1.4. Through the second (2nd) Agreement approved by the Governor on March 11, 2021, retroactively effective to March 4, 2021, with a completion date of June 30, 2021, the Department and Contractor pursued the implementation of the recommendations made under the prior agreement, related to Behavioral Health and Developmental Disabilities. Additionally, the Contractor: (1) assisted the Bureau of Information Services (BIS) with Medicaid Management Information System (MMIS) modernization and implementation efforts; and (2) supported the Department's Senior Executive Team (SET) with an Organizational Change Management effort specific to the work in the second (2nd) Agreement.

2. Ongoing and New Initiatives

- 2.1. Through this third (3rd) Agreement, Exhibit B – Amendment #2, Scope of Services, for Contract Years 3 and 4, approved by the Governor and Executive Council on June 16, 2021, effective July 1, 2021, as amended, the Contractor will provide continued implementation support related to the ongoing initiatives, including:
- 2.1.1. Implementation support for the Critical Time Intervention (CTI) program, which will include transitioning of activities currently performed by the Contractor to Department staff as, agreed upon by the Contractor and Department.
 - 2.1.2. Implementation support for the Institute for Mental Disease (IMD) Waiver initiative, which will include ongoing implementation efforts as well as expanding the scope of the Demonstration as, specified in Section 4.
 - 2.1.3. Continuing implementation support for the Developmental Disabilities Systems Redesign and MMIS Modernization will continue.
- 2.2. **Strategic Relevance:** The Contractor will continue acting as a strategic partner to the Department supporting the transition and completion of the short-term initiatives, and continued implementation support for the long-term initiatives. The Contractor will continue to provide status updates and advisory to the SET as well as Organizational Change Management support specific to the work identified in Paragraphs 2.1.1, 2.1.2, and 2.1.3 above.
- 2.3. **Behavioral Health:** The COVID-19 Pandemic exacerbated the incidence of behavioral health crises in New Hampshire. Nationally, record increases in mental health issues are being reported, while studies show that individuals with serious mental illness are at increased rate of suicide due to the pandemic. New Hampshire Hospital has seen its waiting list increase to its highest levels since 2015, including a record number of children. These developments, among others, have increased stress on an already taxed health system that may not be able to meet the heightened demand in a timely or safe manner. To address these challenges, the Contractor assisted the Department with implementing two major initiatives to increase positive mental health outcomes for New Hampshire citizens that include: (1) a Critical Time Intervention Program; and (2) Institutions for Mental Disease (IMD) Waiver. The Contractor will continue to support these initiatives as described in additional detail within this Exhibit B – Amendment #2, Scope of Services. Additionally, the Contractor will (3) transition its scope of support to the Department for the Critical Time Intervention Program and (4) expand the scope of the IMD Waiver through an initiative that will impact incarcerated individuals preparing to re-enter the community who utilize services through the Mental and Behavioral Health system.

3. Critical Time Intervention (CTI) Program: The Contractor shall continue its work started in State Fiscal Year (SFY) 2021, with the Department to implement a CTI Program with the concurrent goals of: (1) lowering hospital readmission rates; (2) decreasing hospital readmission costs to the State; and (3) better addressing the needs of the community. Under the current Agreement and through SFY 2023, the Contractor supported the Department in successfully standing-up the CTI program, facilitating data collection and reporting, and supporting the administration of ongoing operations. The Contractor shall transition its support to internal Department staff in Year 3 of the contract, as well as provide strategy advisory and documentation, as requested by the Department, through Year 4 for the pursuit of a sustainable funding strategy.

3.1. Contract Year 3 - CTI Program: The Contractor shall continue providing operational support and program analytics for the CTI Program and facilitate a transition of those functions in Year 3 of the Agreement by:

3.1.1. Assisting with the development of a process for centralized reporting of CTI data to enable Department management to make data-informed decisions and measure performance on an ongoing basis and create a strong body of evidence for future program evaluation; working with the Department to design and implement analytics and reporting as part of the A&M transition of its support to the Department.

3.1.1.1. Produce documentation that outlines the sources, outputs, and uses of various program-related data.

3.1.1.2. Work with program staff to determine a feasible process and related tool for continuing the collection of key data (CMHC weekly ops data).

3.1.1.3. Consult with the data team on the above-mentioned documentation to determine a feasible means and cadence of program reporting; provide dashboard overlay for select metrics.

3.1.1.4. Extend operational support and transition to internal CTI program staff; examples of operational support include (but not exclusive to):

3.1.1.5. Maintain CTI program budget model.

3.1.1.6. Design, support and troubleshoot CTI invoicing process (e.g., invoice review; validation against process metrics).

3.1.1.7. Project manage against key program milestones (e.g., program launch; SFY24/25 contracting process).

3.1.1.8. Provide project management oversight, as needed by the Department, for each of the specific items listed above.

3.2. Contract Years 3 and 4 – CTI Program: The Contractor will provide strategy and advisory throughout SFY 2024 and SFY 2025 regarding the attainment of a sustainable funding model for the program by:

3.2.1. Assisting the Department with the identification and development of methods to attain long-term CTI funding opportunities to attain program sustainability. Support may continue in Contract Years 3 and 4 of the Agreement depending on the Department's express level of desire and priority to place on this aspect of the initiative.

3.2.2. Document a strategic approach as necessary and requested by the Department related to potential funding and sustainability mechanisms, including the stakeholders and resources required to pursue the strategy from across the Department and the level of effort estimated, and estimate timeframes for achieving the strategy.

3.3. Assumptions: Transition of operational support and analysis from the Contractor to the Department will require a dedicated resource internal to the Department working with the Contractor. The Contractor will work with the Department to provide training, documentation, coaching, and advisory throughout the course of that transition, and will demonstrate flexibility with the timeline to execute this transition within the first year of this extended Agreement (Contract Year 3).

4. IMD Waiver: The Contractor shall continue working with the Department in Agreement Years 3 and 4 to develop, write, and submit an IMD Waiver to address the concurrent goals of: (1) increasing diversion from hospital emergency departments towards community care when appropriate; (2) decreasing the average length of stay at New Hampshire Hospital; (3) enhancing the reimbursement for services at New Hampshire Hospital; and (4) increasing the available options for step-down care once inpatient treatment is no longer medically necessary by:

4.1. Contract Year 3 – IMD Waiver: The Contractor shall support the Department with Year 1 IMD Waiver efforts by:

All records must be maintained in accordance with accounting procedures and practices, which sufficiently and properly reflect all such costs and expenses, and which are acceptable to the Department, and to include, without limitation, all ledgers, books, records, and original evidence of costs such as purchase requisitions and orders, vouchers, requisitions for materials, inventories, valuations of in-kind contributions, labor time cards, payrolls, and other records requested or required by the Department.

12.2. During the term of this Agreement and the period for retention hereunder, the

EXPLANATION

The purpose of this request is to add enhanced information protection provisions to the existing agreement. Under the current agreement, A&M Public Sector Services is required to support the Department with five (5) different strategic initiatives, which includes assisting with the development and execution of a long-term procurement strategy to replace the current legacy Medicaid Management Information (MMIS) system. The Department recently learned that A&M

Public Sector Services' parent company has indirect control of a significant interest in the general partner of A&M Capital, which has a private equity investment in Client Network Services (CNSI). CNSI is a company that offers products and services in the health and human services field and is engaging with the Medicaid agencies in other states across the country.

This amendment establishes an information screen between A&M Public Sector Services employees working on the current contract and its parent company and other affiliates and subsidiaries to ensure no information is shared relative to the MMIS reprocurement work in order to protect the interests of the State. This amendment includes a provision that allows the Department to recoup funds or withhold payment in the event the terms of the amendment are violated. This amendment is being requested in advance of any potential conflict of interest. Further, this amendment adds a clause to ensure the information screen protections survive for a period of three years after the contract completion date.

As referenced in Exhibit A, Revisions to Standard Agreement Provisions of the original contract, the parties have the option to extend the agreement for up to two (2) additional years, contingent upon satisfactory delivery of services, available funding, agreement of the parties and Governor and Council approval. The Department is not exercising its option to renew at this time.

Should the Governor and Council not authorize this request, the Department would plan a subsequent amendment to remove the MMIS work stream from the contract. A&M Public Sector Services has two primary individuals assigned to this project containing the project management expertise and the specific knowledge of the Medicaid systems providing the state with unique insights necessary to streamline the process of creating a comprehensive strategy and procurement process. This would directly impact the project management resources needed to move the five (5) year modular re-procurement effort to replace the MMIS. Additionally, these services are an integral part of the strategy to maintain compliance with Centers for Medicare and Medicaid Services requirements for certification and federal financial participation. Ultimately if this amendment is not approved it would delay the efforts to replace the existing solution by up to one year which would have downstream impacts to the timeline of extending the procurement timeframe by at least an additional year to accommodate a procurement of another contract for these services and put the State in jeopardy of losing federal financial participation based on certification requirements in the amount of \$6 million dollars per year minimum.


WHEREAS, the parties agree to modify the scope of services to support continued delivery of these services and to address certain disclosures; and

1. PURPOSE

- 1.1. Whereas, Alvarez & Marsal Public Sector Services, LLC ("A&M Public Sector"), and the State of New Hampshire, Department of Health and Human Services (Department) entered into an agreement (Agreement) approved by the Governor and Executive Council on June 16, 2021;
- 1.2. Whereas, A&M Public Sector, is wholly owned by Alvarez & Marsal Holdings, LLC ("A&M Holdings"). A&M Public Sector and other A&M Holdings subsidiaries constitute the global consulting firm known as 'Alvarez & Marsal' ("A&M Consulting"). Bryan P. Marsal and Antonio C. Alvarez II comprise the Board of Managers of A&M Holdings and are two of the three Board of Managers of A&M Public Sector. Alvarez & Marsal Inc. ("A&M Inc."), an entity controlled by Messrs. Marsal and Alvarez, is the majority owner of A&M Holdings;
- 1.3. Whereas, Mr. Marsal and Mr. Alvarez, together with A&M Inc., indirectly control a significant interest in the general partner of A&M Capital, a private equity investment firm (affiliated with A&M Holdings through its common control) that manages various funds (collectively, the "A&M Capital Funds");
- 1.4. Whereas, certain A&M Consulting employees have invested in limited partnership interests in the A&M Capital Funds and, indirectly, their general partners and, Alvarez & Marsal Holdings through its professional service provider affiliates, provide services to the A&M Capital Funds and their investees. The investments of the A&M Capital Funds are private equity investments in companies;
- 1.5. Whereas, one private equity investment of the A&M Capital Funds is Client Network Services, Inc. ("CNSI") which offers products and services in the Health and Human Services ("HHS") field and is engaging with the Medicaid agencies in multiple states;
- 1.6. Whereas, A&M Public Sector, pursuant to the Agreement, agreed to, among other things, provide consulting services to the Department in connection with its replacement of the current legacy Medicaid Management Information System (MMIS) with a modern modular system, which includes supporting the Department's development of the architecture, standards, and procurement strategy for the new MMIS, assisting with the development of solicitations and advance planning documents (APD), assisting with the management of projects individually and as an enterprise, leading the development of an overall management and governance structure of the new MMIS, and leading the research of applicable APD opportunities for federal funding and the communications of APDs to the Centers for Medicare & Medicaid Services for approval; and

Whereas, it is the Department's and A&M Public Sector's intention that any solicitations issued by the Department are devoid of any terms or content that could provide an unfair advantage to a potential vendor. To that end, the Parties agree to establish adequate control measures as further described herein to (a)

address any conflict of interest or perceived conflict of interest with respect to A&M Public Sector's involvement in the architecture redesign and the future procurement of a new MMIS, and all other services provided under the Agreement, as CNSI may respond to future MMIS solicitations issued by the Department and (b) ensure A&M is in a position to provide the Department with unbiased and impartial advice, assistance, or support, under this Agreement.

2. INFORMATION SCREEN

2.1. A&M Public Sector shall ensure that all information related to the services provided under the Agreement is treated as confidential and shall not provide access to this information to any employees of A&M Consulting, other than the A&M Public Sector employees working on this engagement, unless approved by the Department. A&M Public Sector shall not share any information relating to the services provided to the Department, with A&M Consulting's or A&M Capital's representatives or any other affiliates or subsidiaries (other than the A&M Public Sector employees working on this engagement), and CNSI unless approved by the Department. To achieve this end A&M Public Sector shall:

2.1.1. Establish an "information screen" between the A&M Public Sector employees who have any participation, now or in the future, with the Agreement and those individuals within A&M Consulting who provide services to CNSI or to A&M Capital as it relates to CNSI;

2.1.2. Ensure any future staffing of personnel involved in performing the services required under the Agreement does not include any individual who is listed within the information screen who has been part of any engagement to serve CNSI;


2.1.3. Obtain signed acknowledgements from A&M Public Sector personnel involved in the performance of the Agreement that recognize the information screen is in place and that no form of communication is permitted between these two groups concerning the Agreement or work performed thereunder. Signed acknowledgements shall be provided to the Department within 10 days following a written request to A&M Public Sector.

2.1.4. A&M Public Sector shall provide the Department with objective and impartial advice, assistance, or support, under this Agreement.

2.1.5. In the event A&M Public Sector violates the terms of Exhibit B-1, the Department may withhold future payments and/or recoup funds already paid to the extent of the monetary and non-monetary damages caused.

3. Recusal

3.1. A&M Public Sector shall, in an abundance of caution, recuse itself from any activities related directly to CNSI's participation in the Department's solicitations and/or contracts, such as evaluating CNSI's responses to RFP's or engaging in oversight for projects that involve CNSI. A&M and the Department agree that it



shall not be necessary for A&M to recuse itself from assisting with the development of the Department's architecture, standards, and procurement strategy simply because CNSI may participate in future solicitations so long as A&M continues to abide with the information screening procedures described in Section 2 above.

4. Acknowledgement

4.1. The Department acknowledges the connections described above between A&M Public Sector and CNSI and seeks for A&M Public Sector to proceed with the services under the Agreement notwithstanding such connections, provided that A&M Public Sector successfully implements and maintains the information screening and recusal procedures described in Exhibit B-1. Subject to A&M Public Sector complying with such procedures, the Department hereby waives any and all conflicts of interest that may exist or arise associated with A&M's connections, as disclosed, to CNSI and the services that A&M Public Sector is providing to the Department with respect to the MMIS workstream(s). For the avoidance of doubt, this provision does not apply to workstreams unrelated to MMIS as it has not been contemplated by the parties that CNSI would have any connection to such workstreams. If such connections do arise then the parties will meet and address at that time.

global professional services firm that specializes in identifying and assisting organizations with the implementation of meaningful, cost-saving, and service enhancing recommendations.

The purpose of this request is to enter into a new contract to support new and continue to support ongoing initiatives started under an existing contract that will expire June 30, 2021. The Contractor will act as a strategic partner to support short and long-term initiatives with the planning and implementation of strategic initiatives that include:

- **Critical Time Intervention Program (CTI):** The Contractor will provide the Department with direct technical assistance and consulting services to stand up a CTI program designed to lower hospital readmission rates, decrease hospital readmission costs to the State, and better address community needs.





2. SERVICES TO BE PERFORMED. The State of New Hampshire, acting through the agency identified in block 1.1 ("State"), engages contractor identified in block 1.3 ("Contractor") to perform, and the Contractor shall perform, the work or sale of goods, or both, identified and more particularly described in the attached EXHIBIT B which is incorporated herein by reference ("Services").

3. EFFECTIVE DATE/COMPLETION OF SERVICES.

3.1 Notwithstanding any provision of this Agreement to the contrary, and subject to the approval of the Governor and Executive Council of the State of New Hampshire, if applicable, this Agreement, and all obligations of the parties hereunder, shall become effective on the date the Governor and Executive Council approve this Agreement as indicated in block 1.17, unless no such approval is required, in which case the Agreement shall become effective on the date the Agreement is signed by the State Agency as shown in block 1.13 ("Effective Date").

3.2 If the Contractor commences the Services prior to the Effective Date, all Services performed by the Contractor prior to the Effective Date shall be performed at the sole risk of the Contractor, and in the event that this Agreement does not become effective, the State shall have no liability to the Contractor, including without limitation, any obligation to pay the Contractor for any costs incurred or Services performed. Contractor must complete all Services by the Completion Date specified in block 1.7.

4. CONDITIONAL NATURE OF AGREEMENT.

Notwithstanding any provision of this Agreement to the contrary, all obligations of the State hereunder, including, without limitation, the continuance of payments hereunder, are contingent upon the availability and continued appropriation of funds affected by any state or federal legislative or executive action that reduces, eliminates or otherwise modifies the appropriation or availability of funding for this Agreement and the Scope for Services provided in EXHIBIT B, in whole or in part. In no event shall the State be liable for any payments hereunder in excess of such available appropriated funds. In the event of a reduction or termination of appropriated funds, the State shall have the right to withhold payment until such funds become available, if ever, and shall have the right to reduce or terminate the Services under this Agreement immediately upon giving the Contractor notice of such reduction or termination. The State shall not be required to transfer funds from any other account or source to the Account identified in block 1.6 in the event funds in that Account are reduced or unavailable.

5. CONTRACT PRICE/PRICE LIMITATION/PAYMENT.

5.1 The contract price, method of payment, and terms of payment are identified and more particularly described in EXHIBIT C which is incorporated herein by reference.

5.2 The payment by the State of the contract price shall be the only and the complete reimbursement to the Contractor for all expenses, of whatever nature incurred by the Contractor in the performance hereof, and shall be the only and the complete

compensation to the Contractor for the Services. The State shall have no liability to the Contractor other than the contract price.

5.3 The State reserves the right to offset from any amounts otherwise payable to the Contractor under this Agreement those liquidated amounts required or permitted by N.H. RSA 80:7 through RSA 80:7-c or any other provision of law.

5.4 Notwithstanding any provision in this Agreement to the contrary, and notwithstanding unexpected circumstances, in no event shall the total of all payments authorized, or actually made hereunder, exceed the Price Limitation set forth in block 1.8.

6. COMPLIANCE BY CONTRACTOR WITH LAWS AND REGULATIONS/EQUAL EMPLOYMENT OPPORTUNITY.

6.1 In connection with the performance of the Services, the Contractor shall comply with all applicable statutes, laws, regulations, and orders of federal, state, county or municipal authorities which impose any obligation or duty upon the Contractor, including, but not limited to, civil rights and equal employment opportunity laws. In addition, if this Agreement is funded in any part by monies of the United States, the Contractor shall comply with all federal executive orders, rules, regulations and statutes, and with any rules, regulations and guidelines as the State or the United States issue to implement these regulations. The Contractor shall also comply with all applicable intellectual property laws.


7. PERSONNEL.

8.2 Upon the occurrence of any Event of Default, the State may take any one, or more, or all, of the following actions:

8.2.1 give the Contractor a written notice specifying the Event of Default and requiring it to be remedied within, in the absence of a greater or lesser specification of time, thirty (30) days from the date of the notice; and if the Event of Default is not timely cured, terminate this Agreement, effective two (2) days after giving the Contractor notice of termination;

8.2.2 give the Contractor a written notice specifying the Event of Default and suspending all payments to be made under this Agreement and ordering that the portion of the contract price which would otherwise accrue to the Contractor during the period from the date of such notice until such time as the State determines that the Contractor has cured the Event of Default shall never be paid to the Contractor;

8.2.3 give the Contractor a written notice specifying the Event of Default and set off against any other obligations the State may owe to the Contractor any damages the State suffers by reason of any Event of Default; and/or

8.2.4 give the Contractor a written notice specifying the Event of Default, treat the Agreement as breached, terminate the Agreement and pursue any of its remedies at law or in equity, or both.

8.3. No failure by the State to enforce any provisions hereof after any Event of Default shall be deemed a waiver of its rights with regard to that Event of Default, or any subsequent Event of Default. No express failure to enforce any Event of Default shall be deemed a waiver of the right of the State to enforce each and all of the provisions hereof upon any further or other Event of Default on the part of the Contractor.

9. TERMINATION.

9.1 Notwithstanding paragraph 8, the State may, at its sole discretion, terminate the Agreement for any reason, in whole or in part, by thirty (30) days written notice to the Contractor that the State is exercising its option to terminate the Agreement.

9.2 In the event of an early termination of this Agreement for any reason other than the completion of the Services, the Contractor shall, at the State's discretion, deliver to the Contracting Officer, not later than fifteen (15) days after the date of termination, a report ("Termination Report") describing in detail all Services performed, and the contract price earned, to and including the date of termination. The form, subject matter, content, and number of copies of the Termination Report shall be identical to those of any Final Report described in the attached EXHIBIT B. In addition, at the State's discretion, the Contractor shall, within 15 days of notice of early termination, develop and

submit to the State a Transition Plan for services under the Agreement.

10. DATA/ACCESS/CONFIDENTIALITY/PRESERVATION.

10.1 As used in this Agreement, the word "data" shall mean all information and things developed or obtained during the performance of, or acquired or developed by reason of, this Agreement, including, but not limited to, all studies, reports, files, formulae, surveys, maps, charts, sound recordings, video recordings, pictorial reproductions, drawings, analyses, graphic representations, computer programs, computer printouts, notes, letters, memoranda, papers, and documents, all whether finished or unfinished.

10.2 All data and any property which has been received from the State or purchased with funds provided for that purpose under this Agreement, shall be the property of the State, and shall be returned to the State upon demand or upon termination of this Agreement for any reason.

10.3 Confidentiality of data shall be governed by N.H. RSA chapter 91-A or other existing law. Disclosure of data requires prior written approval of the State.

11. CONTRACTOR'S RELATION TO THE STATE. In the performance of this Agreement the Contractor is in all respects an independent contractor, and is neither an agent nor an employee of the State. Neither the Contractor nor any of its officers, employees, agents or members shall have authority to bind the State or receive any benefits, workers' compensation or other emoluments provided by the State to its employees.

12. ASSIGNMENT/DELEGATION/SUBCONTRACTS.

12.1 The Contractor shall not assign, or otherwise transfer any interest in this Agreement without the prior written notice, which shall be provided to the State at least fifteen (15) days prior to the assignment, and a written consent of the State. For purposes of this paragraph, a Change of Control shall constitute assignment. "Change of Control" means (a) merger, consolidation, or a transaction or series of related transactions in which a third party, together with its affiliates, becomes the direct or indirect owner of fifty percent (50%) or more of the voting shares or similar equity interests, or combined voting power of the Contractor, or (b) the sale of all or substantially all of the assets of the Contractor.

12.2 None of the Services shall be subcontracted by the Contractor without prior written notice and consent of the State. The State is entitled to copies of all subcontracts and assignment agreements and shall not be bound by any provisions contained in a subcontract or an assignment agreement to which it is not a party.

13. INDEMNIFICATION. Unless otherwise exempted by law, the Contractor shall indemnify and hold harmless the State, its officers and employees, from and against any and all claims, liabilities and costs for any personal injury or property damages, patent or copyright infringement, or other claims asserted against the State, its officers or employees, which arise out of (or which may be claimed to arise out of) the acts or omissions of the

Contractor, or subcontractors, including but not limited to the negligence, reckless or intentional conduct. The State shall not be liable for any costs incurred by the Contractor arising under this paragraph 13. Notwithstanding the foregoing, nothing herein contained shall be deemed to constitute a waiver of the sovereign immunity of the State, which immunity is hereby reserved to the State. This covenant in paragraph 13 shall survive the termination of this Agreement.

14. INSURANCE.

14.1 The Contractor shall, at its sole expense, obtain and continuously maintain in force, and shall require any subcontractor or assignee to obtain and maintain in force, the following insurance:

14.1.1 commercial general liability insurance against all claims of bodily injury, death or property damage, in amounts of not less than \$1,000,000 per occurrence and \$2,000,000 aggregate or excess; and

14.1.2 special cause of loss coverage form covering all property subject to subparagraph 10.2 herein, in an amount not less than 80% of the whole replacement value of the property.

14.2 The policies described in subparagraph 14.1 herein shall be on policy forms and endorsements approved for use in the State of New Hampshire by the N.H. Department of Insurance, and issued by insurers licensed in the State of New Hampshire.

14.3 The Contractor shall furnish to the Contracting Officer identified in block 1.9, or his or her successor, a certificate(s) of insurance for all insurance required under this Agreement. Contractor shall also furnish to the Contracting Officer identified in block 1.9, or his or her successor, certificate(s) of insurance for all renewal(s) of insurance required under this Agreement no later than ten (10) days prior to the expiration date of each insurance policy. The certificate(s) of insurance and any renewals thereof shall be attached and are incorporated herein by reference.

15. WORKERS' COMPENSATION.

15.1 By signing this agreement, the Contractor agrees, certifies and warrants that the Contractor is in compliance with or exempt from, the requirements of N.H. RSA chapter 281-A ("Workers' Compensation").

15.2 To the extent the Contractor is subject to the requirements of N.H. RSA chapter 281-A, Contractor shall maintain, and require any subcontractor or assignee to secure and maintain, payment of Workers' Compensation in connection with activities which the person proposes to undertake pursuant to this Agreement. The Contractor shall furnish the Contracting Officer identified in block 1.9, or his or her successor, proof of Workers' Compensation in the manner described in N.H. RSA chapter 281-A and any applicable renewal(s) thereof, which shall be attached and are incorporated herein by reference. The State shall not be responsible for payment of any Workers' Compensation premiums or for any other claim or benefit for Contractor, or any subcontractor or employee of Contractor, which might arise under applicable State of New Hampshire Workers' Compensation laws in connection with the performance of the Services under this Agreement.

16. NOTICE. Any notice by a party hereto to the other party shall be deemed to have been duly delivered or given at the time of mailing by certified mail, postage prepaid, in a United States Post Office addressed to the parties at the addresses given in blocks 1.2 and 1.4, herein.

17. AMENDMENT. This Agreement may be amended, waived or discharged only by an instrument in writing signed by the parties hereto and only after approval of such amendment, waiver or discharge by the Governor and Executive Council of the State of New Hampshire unless no such approval is required under the circumstances pursuant to State law, rule or policy.

18. CHOICE OF LAW AND FORUM. This Agreement shall be governed, interpreted and construed in accordance with the laws of the State of New Hampshire, and is binding upon and inures to the benefit of the parties and their respective successors and assigns. The wording used in this Agreement is the wording chosen by the parties to express their mutual intent, and no rule of construction shall be applied against or in favor of any party. Any actions arising out of this Agreement shall be brought and maintained in New Hampshire Superior Court which shall have exclusive jurisdiction thereof.

19. CONFLICTING TERMS. In the event of a conflict between the terms of this P-37 form (as modified in EXHIBIT A) and/or attachments and amendment thereof, the terms of the P-37 (as modified in EXHIBIT A) shall control.

20. THIRD PARTIES. The parties hereto do not intend to benefit any third parties and this Agreement shall not be construed to confer any such benefit.

21. HEADINGS. The headings throughout the Agreement are for reference purposes only, and the words contained therein shall in no way be held to explain, modify, amplify or aid in the interpretation, construction or meaning of the provisions of this Agreement.

22. SPECIAL PROVISIONS. Additional or modifying provisions set forth in the attached EXHIBIT A are incorporated herein by reference.

23. SEVERABILITY. In the event any of the provisions of this Agreement are held by a court of competent jurisdiction to be contrary to any state or federal law, the remaining provisions of this Agreement will remain in full force and effect.

24. ENTIRE AGREEMENT. This Agreement, which may be executed in a number of counterparts, each of which shall be deemed an original, constitutes the entire agreement and understanding between the parties, and supersedes all prior agreements and understandings with respect to the subject matter hereof.

Revisions to Standard Agreement Provisions

1. Revisions to Form P-37, General Provisions

1.1. Paragraph 3, Subparagraph 3.1, Effective Date/Completion of Services, is amended as follows:

3.1... Notwithstanding any provision of this Agreement to the contrary, and subject to the approval of the Governor and Executive Council of the State of New Hampshire as indicated in block 1.17, this Agreement, and all obligations of the parties hereunder, shall become effective on July 1, 2021 ("Effective Date").

1.2 Paragraph 2, Effective Date/Completion of Services, is amended by adding subparagraph 3.3 as follows:

3.3 The parties may extend the Agreement for up to two (2) years additional years from the Completion Date, contingent upon satisfactory delivery of services, available funding, agreement of the parties, and approval of the Governor and Executive Council.


1.2 Paragraph 6, Compliance By Contractor With Laws and Regulations/Equal Employment Opportunity, is amended to include subparagraph 6.4 as follows:

6.4 Because Contractor and its affiliates comprise a consulting firm (the "Firm") that serves clients on an international basis in numerous cases, both in and out of court, it is possible that the Firm may have rendered or will render services to, or have business associations with, other entities or people which had or have or may have relationships with the State. The Firm will not be prevented or restricted by virtue of providing the services under this contract from providing services to other entities or individuals, including entities or individuals whose interests may be in competition or conflict with the State's, provided the Firm makes appropriate arrangements to ensure that the confidentiality of information is maintained. Notwithstanding the foregoing, in the event the Firm provides services in matters which conflict with the State's interests regarding the matters in which A&M is providing services hereunder, the Firm must provide notice of such relationship to the State and the State may, at its discretion, terminate this Contract.

1.3 Paragraph 8, Event of Default/Remedies, is amended to include subparagraphs 8.4, 8.5, and 8.6 as follows:

8.4 The Contractor may terminate this Agreement upon notice if the State misrepresents or fails to disclose material facts, fails to pay undisputed fees or expenses, or makes it unethical for the Contractor to continue performance of the engagement, or other just cause exists.

8.5 Except for Contractor's liability for any data security breaches caused by the Contractor, as referenced in Exhibit K, DHHS Information Security

Requirements (Section IV, Procedures for Security, Paragraph 11), and for Contractor's indemnification obligations set forth in Paragraph 13, notwithstanding anything to the contrary, in no event shall the Contractor be liable to the State, whether a claim be in tort, contract or otherwise, for any amount in excess of the total professional fees paid pursuant to this Agreement except to the extent the damages were caused primarily from the fraud or willful misconduct of the Contractor relating to the Services. In no event shall the Parties be liable for any consequential, special, indirect, incidental, punitive, or exemplary loss, damage, or expense relating to this Agreement (including, without limitation, loss of profit, data, revenue, goodwill, or similar damages) even if advised of the possibility of such damages. This paragraph shall survive termination of this Agreement

8.6 The State's liability under this Agreement shall be limited to monetary damages not to exceed the total fees paid, but in no event shall it exceed the contract price pursuant to Paragraph 5.2. The Contractor agrees that it has an adequate remedy at law for any breach of this Agreement by the State and hereby waives any right to specific performance or other equitable remedies against the State.

1.4 Paragraph 10, Data/Access/Confidentiality/Preservation, Subparagraphs 10.2 and 10.3 are amended as follows:

10.2 All data and any property which has been received from the State or purchased with funds provided for that purpose under this Agreement, shall be the property of the State, and shall be returned to the State upon demand or upon termination of this Agreement for any reason. Notwithstanding anything to the contrary, the Contractor shall retain all right, title and interest in all of its pre-existing intellectual property and all methodologies, processes, techniques, ideas, concepts, electronic and written workpapers, trade secrets, and know-how embodied in any data that the Contractor may develop or supply in connection with this Agreement.

10.3 Confidentiality of data shall be governed by N.H. RSA chapter 91-A or other existing law. Disclosure of data requires prior written approval of the State. If any party subpoenas or requests, or any data, the Contractor will inform the State thereof.

1.5 Paragraph 12, Assignment/Delegation/Subcontracts, is amended by adding subparagraph 12.3 as follows:

12.3 Except for modifications mutually approved in writing by the Department and the Contractor, Subcontractors are subject to the same contractual conditions as the Contractor and the Contractor is responsible to ensure subcontractor compliance with those conditions. The Contractor shall have written agreements with all subcontractors, specifying the work to be performed and how corrective

action shall be managed if the subcontractor's performance is inadequate. The Contractor shall manage the subcontractor's performance on an ongoing basis and take corrective action as necessary. The Contractor shall annually provide the State with a list of all subcontractors provided for under this Agreement and notify the State of any inadequate subcontractor performance.

1.6 Paragraph 13, Indemnification, is amended as follows:

13. **INDEMNIFICATION.** Unless otherwise exempted by law, the Contractor shall indemnify and hold harmless the State, its officers and employees, from and against any and all claims, liabilities and costs for:

- (i) any personal bodily injury or real and/or tangible personal property damages asserted against the State, its officers or employees to the extent caused by the acts or omission of the Contractor, or subcontractors, in the performance of the Services that constitute negligence, reckless or intentional conduct; and
- (ii) patent or copyright infringement by the Services, provided that the foregoing shall not apply to the extent the claim of infringement arises out of: (1) the use of the Services other than in accordance with the terms of this Agreement and any applicable documentation or instructions supplied to the State; (2) any modification to the Services not expressly agreed to in writing by the parties; or (3) the combination of the Services with any materials not provided or approved by the Contractor.

The State shall not be liable for any costs incurred by the Contractor arising under this paragraph 13. Notwithstanding the foregoing, nothing herein contained shall be deemed to constitute a waiver of the sovereign immunity of the State, which immunity is hereby reserved to the State. This covenant in paragraph 13 shall survive the termination of this Agreement.

Scope of Services

1. Background

1.1. Extension of Prior Work: The Department and Contractor previously entered into two contracts:

1.1.1. The first agreement was approved by the Governor on August 31, 2020, retroactively effective to August 24, 2020, and amended with Governor approval on December 29, 2020, retroactively effective to October 30, 2020, and expired December 30, 2021.

1.1.2. The second agreement was approved by the Governor on March 11, 2021, retroactively effective to March 4, 2021, with a completion date of June 30, 2021.

1.2. In accordance with the requirements of the first agreement, the Contractor provided a strategic assessment of the Department's operations that:

1.2.1. Quantified the impact of the COVID-19 pandemic;

1.2.2. Identified programmatic improvements to increase operational efficiency and effectiveness;

1.2.3. Assessed opportunities to improve the delivery of services during and after the public health emergency; and

1.2.4. Provided the Department with specific recommendations for operations system enhancements.

1.3. Further, under the first agreement, the Contractor assessed the impact of the COVID-19 pandemic, identified vulnerabilities that may impede recovery, and provided recommendations to the Department. Through the second agreement, the Department and Contractor pursued two high-impact opportunities stemming from the pandemic related to the programmatic areas of Behavioral Health and Developmental Disabilities.

1.4. Ongoing and New Initiatives: Through this Agreement, anticipated to begin July 1, 2021, subject to Governor and Council approval, the Department and Contractor will pursue the implementation of the recommendations made under the prior agreements, related to Behavioral Health and Developmental Disabilities. Additionally, the Contractor shall: (1) assist the Bureau of Information Services with Medicaid Management Information System (MMIS) modernization and implementation efforts; and (2) support the Department's Senior Executive Team (SET) with an Organizational Change Management effort.

1.5. Strategic Relevance: The Contractor will act as a strategic partner to the Department to support both short and long-term initiatives, with the planning and implementation of key behavioral health initiatives, as well as the launch and initial implementation phases of key initiatives related to Developmental Disabilities, the modernization of the MMIS, and Organizational Change Management.





- 2. Behavioral Health:** The COVID-19 Pandemic exacerbated the incidence of behavioral health crises in New Hampshire. Nationally, record increases in mental health issues are being reported, while studies show that individuals with serious mental illness are at increased rate of suicide due to the pandemic. New Hampshire Hospital has seen its waiting list increase to its highest levels since 2015, including a record number of children. These developments, among others, have increased stress on an already taxed health system that may not be able to meet the heightened demand in a timely or safe manner. To address these challenges, the Contractor shall continue to assist the Department with implementing two major initiatives to increase positive mental health outcomes for New Hampshire citizens that include: (1) a Critical Time Intervention Program; and (2) Institutions for Mental Disease (IMD) Waiver.
- 2.1. Critical Time Intervention (CTI) Program:** The Contractor shall continue its work, started in State Fiscal Year (SFY) 2021, with the Department to implement a CTI Program with the concurrent goals of: (1) lowering hospital readmission rates; (2) decreasing hospital readmission costs to the State; and (3) better addressing the needs of the community. In SFY 2021, the Contractor finalized the implementation strategy; facilitated relationships with key stakeholders; solidified the relationship with and developed scope of services with trainer; developed the two (2) year implementation budget; and identified key performance indicators.
- 2.1.1. Year 1 - CTI Program:** The Contractor shall facilitate the continuation of the implementation and execution the following activities, started in SFY 2021, that focus on a staged roll-out of CTI in New Hampshire in Year 1 of this Agreement by:
- 2.1.1.1.** Consulting with third-party organizations and subject matter experts to collect key information necessary for implementation, ongoing education, and program evaluation.
 - 2.1.1.2.** Advising the Department on how to establish a central CTI management team within the Division for Behavioral Health, identifying additional training and other needs, and establishing a management structure.
 - 2.1.1.3.** Advising the Department on how to establish regionalized case teams and the resources, skills, and educational requirements. This includes providing effective recruitment techniques and working collaboratively with the Department to establish a system with partnering organizations. Three initial CTI teams shall be fully operational no later than January 20, 2022.
 - 2.1.1.4.** Identifying high impact areas for CTI rollout by utilizing quantifiable health and population data to utilize limited resources and maximize positive impact.

- 2.1.1.5. Coordinating training to Department employees on the CTI model and establishing long-term sustainable learning collaboratives with partnering organizations. Initial Education Series to be completed no later than November 30, 2021.
- 2.1.1.6. Assisting with the development of a process for centralized reporting of CTI data to enable Department management to make data-informed decisions and measure performance on an ongoing basis and create a strong body of evidence for future program evaluation.
- 2.1.1.7. Working with the Department to identify potential funding opportunities to offset short-term and long-term costs of the CTI program.
- 2.1.1.8. Assisting the Department with stakeholder identification, engagement, and involvement in the development and implementation of the CTI program.
- 2.1.1.9. Providing project management oversight, as needed by the Department, for each of the specific items listed above.
- 2.1.2. Year 2 - CTI Program: The Contractor shall support the Department's CTI program efforts by:
 - 2.1.2.1. Facilitating the assessment of CTI case teams statewide, particularly with CTI Program regarding size, effectiveness, and performance against budget. Statewide coverage of CTI teams shall be implemented no later than July 1, 2022.
 - 2.1.2.2. Supporting the CTI educational partnerships and models established during Year 1, and working with educational partners to adjust the timing and delivery of CTI training and best practices as necessary.
 - 2.1.2.3. Facilitating, in coordination with Department-designated resources, the design of the process by which the Department will capture CTI data and develop the reporting that will be implemented leveraging the CTI data from State systems that will inform executive-level performance reports, on a frequency to be established by the Department.
 - 2.1.2.4. Providing ongoing support for the Department's CTI management team established during or prior to Year 1, including activities that include, but are not limited to facilitation of stakeholder meetings and data analysis.
 - 2.1.2.5. Assisting the Department with the identification and development of methods to attain long-term CTI funding opportunities to attain program sustainability.
- 2.1.3. Assumptions: The timelines in Section 2 assume the continued participation and dedication of assigned resources from the Department, and the cooperation and contributions of the Department's contracted vendors.

The Contractor shall complete all assigned tasks to achieve these timelines and manage risk related to timeline delays. Acknowledging the unanticipated issues that may arise external to the Contractor's obligations under this Agreement, these timelines may be adjusted upon the mutual agreement of the Department and the Contractor.

3. **IMD Waiver:** The Contractor shall continue working with the Department to develop, write, and submit an IMD Waiver to address the concurrent goals of: (1) increasing diversion from hospital emergency departments towards community care when appropriate; (2) decreasing the average length of stay at New Hampshire Hospital; (3) enhancing the reimbursement for services at New Hampshire Hospital; and (4) increasing the available options for step-down care once inpatient treatment is no longer medically necessary by:

- 3.1. **Year 1 – IMD Waiver:** The Contractor shall support the Department with Year 1 IMD Waiver efforts by:

3.1.1.1. Assisting in the finalization and submission of the IMD Waiver specifically by incorporating feedback from the public notice period.

3.1.1.2. Planning for and coordinating the implementation of the IMD Waiver among New Hampshire Hospital, the Office of Medicaid Services, the Division for Behavioral Health, the State's actuary of record, and the Managed Care Organizations (MCOs).

3.1.1.3. Supporting the assessment of alternatives for increased psychiatric inpatient bed capacity, which may include one or more of the following: (a) expanding the capacity of existing Designated Receiving Facilities (DRFs), (b) developing new DRFs, and / or (c) building a new privately-operated IMD.

3.1.1.4. Developing a project plan to document the requirements, timelines, milestones, and stakeholder engagement resulting from the Department's chosen alternative(s) from 3.1.1.3.

3.1.1.5. Coordinating the implementation of the project plan resulting from 3.1.1.4., to include: (a) facilitating meetings (documenting the agenda, decisions made, and action items), (b) recording progress vs. milestones in regular monthly status reports, and (c) assisting with identification and escalation of timeline risks as needed.


- 3.1.2. **Year 2 – IMD Waiver:** The Contractor shall support the Department with Year 2 IMD Waiver efforts by:

3.1.2.1. Assisting with the preparation and submission of quarterly evaluation reports to Centers for Medicare and Medicaid Services (CMS) during first year of the IMD Waiver demonstration.

- 3.1.2.2. Providing project management technical support for the renewal and expansion of dual Substance Use Disorder and Serious Mental Illness. IMD waiver efforts.
- 3.1.2.3. Providing project management technical support for coordinating the implementation of the decision from Year 1 of the Agreement relative to alternatives for increased psychiatric inpatient bed capacity.



CERTIFICATION REGARDING ENVIRONMENTAL TOBACCO SMOKE



- e. "**Data Aggregation**" shall have the same meaning as the term "data aggregation" in 45 CFR Section 164.501.
- f. "**Health Care Operations**" shall have the same meaning as the term "health care operations" in 45 CFR Section 164.501.
- g. "**HITECH Act**" means the Health Information Technology for Economic and Clinical Health Act, Title XIII, Subtitle D, Part 1 & 2 of the American Recovery and Reinvestment Act of 2009.
- h. "**HIPAA**" means the Health Insurance Portability and Accountability Act of 1996, Public Law 104-191 and the Standards for Privacy and Security of Individually Identifiable Health Information, 45 CFR Parts 160, 162 and 164 and amendments thereto.
- i. "**Individual**" shall have the same meaning as the term "individual" in 45 CFR Section 160.103 and shall include a person who qualifies as a personal representative in accordance with 45 CFR Section 164.501(g).
- j. "**Privacy Rule**" shall mean the Standards for Privacy of Individually Identifiable Health Information at 45 CFR Parts 160 and 164, promulgated under HIPAA by the United States Department of Health and Human Services.
- k. "**Protected Health Information**" shall have the same meaning as the term "protected health information" in 45 CFR Section 160.103, limited to the information created or received by Business Associate from or on behalf of Covered Entity.

- l. "Required by Law" shall have the same meaning as the term "required by law" in 45CFR Section 164.103.
- m. "Secretary" shall mean the Secretary of the Department of Health and Human Services or his/her designee.

(2) Business Associate Use and Disclosure of Protected Health Information

- a. Business Associate shall not use, disclose, maintain or transmit, and Covered Entity shall not provide or disclose to Business Associate, Protected Health Information (PHI) except as reasonably necessary to provide the services outlined under Exhibit A of the Agreement. Further, Business Associate, including but not limited to all its directors, officers, employees and agents, shall not use, disclose, maintain or transmit PHI in any manner that would constitute a violation of the Privacy and Security Rule.
- b. Business Associate may use or disclose PHI:
 - I. For the proper management and administration of the Business Associate;
 - II. As required by law, pursuant to the terms set forth in paragraph d. below; or
 - III. For data aggregation purposes for the health-care operations of Covered Entity.
- c. To the extent Business Associate is permitted under the Agreement to disclose PHI to a third party, Business Associate must obtain, prior to making any such disclosure, (i) reasonable assurances from the third party that such PHI will be held confidentially and used or further disclosed only as required by law or for the purpose for which it was disclosed to the third party; and (ii) an agreement from such third party to notify Business Associate, in accordance with the HIPAA Privacy, Security, and Breach Notification Rules of any breaches of the confidentiality of the PHI, to the extent it has obtained knowledge of such breach.
- d. The Business Associate shall not, unless such disclosure is reasonably necessary to provide services under Exhibit A of the Agreement, disclose any PHI in response to a request for disclosure on the basis that it is required by law, without first notifying Covered Entity so that Covered Entity has an opportunity to object to the disclosure and to seek appropriate relief. If Covered Entity objects to such disclosure, the Business Associate shall

Associate shall refrain from disclosing the PHI until Covered Entity has exhausted all remedies.

- e. If the Covered Entity notifies the Business Associate that Covered Entity has agreed to be bound by additional restrictions over and above those uses or disclosures or security safeguards of PHI pursuant to the Privacy and Security Rule, the Business Associate shall be bound by such additional restrictions and shall not disclose PHI in violation of such additional restrictions and shall abide by any additional security safeguards.

(3) Obligations and Activities of Business Associate

- a. Business Associate and Covered Entity agree that this Exhibit I constitutes a Qualified Service Organization Agreement ("QSOA") and that in receiving, storing, processing, or otherwise dealing with any patient records (as defined in 42 CFR Part 2.11) from a Part 2 program of Covered Entity, Business Associate shall act as a qualified service organization (QSO) on Covered Entity's behalf, according to the applicable provisions of 42 USC s.290dd-2 and 42 CFR Part 2.

Accordingly, except as otherwise limited in this Agreement, Business Associate may use or disclose Protected Health Information to perform functions, activities, or services for, or on behalf of Covered Entity, provided that such use or disclosure would not violate the Privacy and Security Rules if done by the Covered Entity.
- d. Covered Entity is responsible and shall follow all requirements for obtaining appropriate patient consent necessary for Business Associate to use, disclose, maintain, or transmit PHI as reasonably necessary to provide the services under the Agreement.

Within ten (10) business days of receipt of a written request from Covered Entity, Business Associate shall make available during normal business hours the records, books, agreements, policies and procedures relating to the use and disclosure of PHI to the Covered Entity to the extent necessary for purposes of enabling Covered Entity to determine Business Associate's compliance with the terms of this Exhibit I.
- k. Within ten (10) business days of receiving a written request from Covered Entity, Business Associate shall provide access to PHI in a Designated Record Set to the Covered Entity, or as directed by Covered Entity, to an individual in order to meet the requirements under 45 CFR Section 164.524.
- l. Within ten (10) business days of receiving a written request from Covered Entity for an amendment of PHI or a record about an individual contained in a Designated Record Set, the Business Associate shall make such PHI available to Covered Entity for amendment and incorporate any such amendment to enable Covered Entity to fulfill its obligations under 45 CFR Section 164.526.
- m. Business Associate shall document such disclosures of PHI and information related to such disclosures as would be required for Covered Entity to respond to a request by an individual for an accounting of disclosures of PHI in accordance with 45 CFR Section 164.528.

- n. Within ten (10) business days of receiving a written request from Covered Entity for a request for an accounting of disclosures of PHI, Business Associate shall make available to Covered Entity such information as Covered Entity may require to fulfill its obligations to provide an accounting of disclosures with respect to PHI in accordance with 45 CFR Section 164.528.
- o. In the event any individual requests access to, amendment of, or accounting of PHI directly from the Business Associate, the Business Associate shall within five (5) business days forward such request to Covered Entity. Covered Entity shall have the responsibility of responding to forwarded requests. However, if forwarding the individual's request to Covered Entity would cause Covered Entity or the Business Associate to violate HIPAA and the Privacy and Security Rule, the Business Associate shall instead respond to the individual's request as required by such law and notify Covered Entity of such response as soon as practicable.
- p. Upon termination of the Agreement, for any reason, the Business Associate shall return or destroy, as specified by Covered Entity, all PHI received from, or created or received by the Business Associate in connection with the Agreement, and shall not retain any copies or back-up tapes of such PHI, in accordance with Exhibit K, Section III of the Agreement. If return or destruction is not feasible, or the disposition of the PHI has been otherwise agreed to in the Agreement, Business Associate shall continue to extend the protections of the Agreement, to such PHI and limit further uses and disclosures of such PHI to those purposes that make the return or destruction infeasible, for so long as Business Associate maintains such PHI. If Covered Entity, in its sole discretion, requires that the Business Associate destroy any or all PHI, the Business Associate shall certify to Covered Entity that the PHI has been destroyed.

(4) Obligations of Covered Entity

(5) Termination for Cause

opportunity for Business Associate to cure such breach within a timeframe specified by Covered Entity. If Covered Entity determines that neither termination nor cure is feasible, Covered Entity shall report the violation any breach of unsecured Protected Health Information to the Secretary as required by 45 CFR Section 164.408.

(6) Miscellaneous

- a. **Definitions and Regulatory References.** All terms used, but not otherwise defined herein, shall have the same meaning as those terms in the Privacy and Security Rule, amended from time to time. A reference in the Agreement, as amended to include this Exhibit I, to a Section in the Privacy and Security Rule means the Section as in effect or as amended.
- b. **Amendment.** Covered Entity and Business Associate agree to take such action as is necessary to amend the Agreement, from time to time as is necessary for Covered Entity to comply with the changes in the requirements of HIPAA, the Privacy and Security Rule, and applicable federal and state law.
- c. **Data Ownership.** The Business Associate acknowledges that it has no ownership rights with respect to the PHI provided by or created on behalf of Covered Entity.
- d. **Interpretation.** The parties agree that any ambiguity in the Agreement shall be resolved to permit Covered Entity to comply with HIPAA, the Privacy and Security Rule.
- e. **Segregation.** If any term or condition of this Exhibit I or the application thereof to any person(s) or circumstance is held invalid, such invalidity shall not affect other terms or conditions which can be given effect without the invalid term or condition; to this end the terms and conditions of this Exhibit I are declared severable.
- f. **Survival.** Provisions in this Exhibit I regarding the use and disclosure of PHI, return or destruction of PHI, extensions of the protections of the Agreement in section (3) i, the defense and indemnification provisions of section (3) e and Paragraph 13 of the standard terms and conditions (P-37), shall survive the termination of the Agreement.



This Exhibit K is made a part of and subject to the terms and conditions set forth in that certain professional services agreement (Subject: SS-2021-OCOM-28-CONSU-01) entered into between the New Hampshire Department of Health and Human Services and Alvarez & Marsal Public Sector Services, LLC (the "Agreement").

A. Definitions

The following terms may be reflected and have the described meaning in this document:

1. "Breach" means the loss of control, compromise, unauthorized disclosure, unauthorized acquisition, unauthorized access, or any similar term referring to situations where persons other than authorized users and for an other than authorized purpose have access or potential access to personally identifiable information, whether physical or electronic. With regard to Protected Health Information, "Breach" shall have the same meaning as the term "Breach" in section 164.402 of Title 45, Code of Federal Regulations.
2. "Computer Security Incident" shall have the same meaning "Computer Security Incident" in section two (2) of NIST Publication 800-61, Computer Security Incident Handling Guide, National Institute of Standards and Technology, U.S. Department of Commerce.
3. "Confidential Information" or "Confidential Data" means all confidential information disclosed by one party to the other such as all medical, health, financial, public assistance benefits and personal information including without limitation, Substance Abuse Treatment Records, Case Records, Protected Health Information and Personally Identifiable Information.

Confidential Information also includes any and all information owned or managed by the State of NH - created, received from or on behalf of the Department of Health and Human Services (DHHS) or accessed in the course of performing contracted services - of which collection, disclosure, protection, and disposition is governed by state or federal law or regulation. This information includes, but is not limited to Protected Health Information (PHI), Personal Information (PI), Personal Financial Information (PFI), Federal Tax Information (FTI), Social Security Numbers (SSN), Payment Card Industry (PCI), and or other sensitive and confidential information.

4. "End User" means any person or entity (e.g., contractor, contractor's employee, business associate, subcontractor, other downstream user, etc.) that receives DHHS data or derivative data in accordance with the terms of this Contract.
5. "HIPAA" means the Health Insurance Portability and Accountability Act of 1996 and the regulations promulgated thereunder.
6. "Incident" means an act that potentially violates an explicit or implied security policy, which includes attempts (either failed or successful) to gain unauthorized access to a system or its data, unwanted disruption or denial of service, the unauthorized use of a

system for the processing or storage of data; and changes to system hardware, firmware, or software characteristics without the owner's knowledge, instruction, or consent. Incidents include the loss of data through theft or device misplacement, loss or misplacement of hardcopy documents, and misrouting of physical or electronic mail, all of which may have the potential to put the data at risk of unauthorized access, use, disclosure, modification or destruction.

- 7. "Open Wireless Network" means any network or segment of a network that is not designated by the State of New Hampshire's Department of Information Technology or delegate as a protected network (designed, tested, and approved, by means of the State, to transmit) will be considered an open network and not adequately secure for the transmission of unencrypted PI, PFI, PHI or confidential DHHS data.
8. "Personal Information" (or "PI") means information which can be used to distinguish or trace an individual's identity, such as their name, social security number, personal information as defined in New Hampshire RSA 359-C:19, biometric records, etc., alone, or when combined with other personal or identifying information which is linked or linkable to a specific individual, such as date and place of birth, mother's maiden name, etc.
9. "Privacy Rule" shall mean the Standards for Privacy of Individually Identifiable Health Information at 45 C.F.R. Parts 160 and 164, promulgated under HIPAA by the United States Department of Health and Human Services.
10. "Protected Health Information" (or "PHI") has the same meaning as provided in the definition of "Protected Health Information" in the HIPAA Privacy Rule at 45 C.F.R. § 160.103.
11. "Security Rule" shall mean the Security Standards for the Protection of Electronic Protected Health Information at 45 C.F.R. Part 164, Subpart C, and amendments thereto.
12. "Unsecured Protected Health Information" means Protected Health Information that is not secured by a technology standard that renders Protected Health Information unusable, unreadable, or indecipherable to unauthorized individuals and is developed or endorsed by a standards developing organization that is accredited by the American National Standards Institute.

I. RESPONSIBILITIES OF DHHS AND THE CONTRACTOR

A. Business Use and Disclosure of Confidential Information.

- 1. The Contractor must not use, disclose, maintain or transmit Confidential Information except as reasonably necessary as outlined under this Contract. Further, Contractor, including but not limited to all its directors, officers, employees and agents, must not use,

- disclose, maintain or transmit PHI in any manner that would constitute a violation of the Privacy and Security Rule.
2. The Contractor must not disclose any Confidential Information in response to a request for disclosure on the basis that it is required by law, in response to a subpoena, etc., without first notifying DHHS so that DHHS has an opportunity to consent or object to the disclosure.
 3. If DHHS notifies the Contractor that DHHS has agreed to be bound by additional restrictions over and above those uses or disclosures or security safeguards of PHI pursuant to the Privacy and Security Rule, the Contractor must be bound by such additional restrictions and must not disclose PHI in violation of such additional restrictions and must abide by any additional security safeguards.
 4. The Contractor agrees that DHHS Data or derivative there from disclosed to an End User must only be used pursuant to the terms of this Contract.
 5. The Contractor agrees DHHS Data obtained under this Contract may not be used for any other purposes that are not indicated in this Contract.
 6. The Contractor agrees to grant access to the data to the authorized representatives of DHHS for the purpose of inspecting to confirm compliance with the terms of this Contract.
 7. The Department will provide laptops to the Contractor to view or analyze any data sets that contain Confidential Data. The Department will configure laptops and user accounts (including email and file server access) to minimize the risk of data loss, including:
 - 7.1 Ensuring such laptops are whole disk encrypted and password protected.
 - 7.2 Disabling the USB ports from use for all Department devices provided to A&M.
 - 7.3 Ensuring such laptops are adequately configured to prevent malware.
 8. The Contractor agrees to utilize and not modify any hardware or software configuration for the devices being provided, nor will any USB devices be inserted into Department issued devices.
 9. All Confidential Data shared between the Contractor and Department employees will be stored on the Department resources provided to the Contractor during the contract period, including emails and files associated with the contract deliverables.
 10. The Department will only transmit Confidential Data to the Contractor using only a Department-designated secure site, file repository, or Department email system which enforces encryption.
 11. The Department will make best efforts to de-identify datasets (including those with PHI), provided to the Contractor where feasible.
 12. The Department will provide or disclose PHI that is clearly identified as PHI and that is only accessible to Contractor on Department resources (specifically, Department's equipment that is connected to its network storing such PHI) during the term of the Agreement. Notwithstanding anything to the contrary contained herein, Contractor shall not have any responsibility for the integrity and security of the Department's equipment and technical

and physical infrastructure of Department's network and premises, including but not limited to the configuration and technical security of Department's equipment (i.e., laptops) provided by the Department to the Contractor in order to access and utilize PHI. The Contractor may act under the assumption and reliance that any storage on the Department's equipment or on the Department's network and/or transmission of PHI or PHI solely within the network and/or infrastructure of the Department is adequately secure and permitted under the HIPAA Rules. The Contractor shall not attempt to modify or alter the physical equipment or attempt to bypass any securities implemented on the equipment provided by the Department. Any alterations to the software or hardware by the Contractor would be considered a breach of contract and the Contractor would be responsible for any incurred damages to include but not limited to: HIPAA violations, physical damage, other regulatory and compliance violations.

II. METHODS OF SECURE TRANSMISSION OF DATA:

1. **Application Encryption.** If End User is transmitting DHHS data containing Confidential Data between applications, the Contractor attests the applications have been evaluated by an expert knowledgeable in cyber security and that said application's encryption capabilities ensure secure transmission via the internet.
2. **Computer Disks and Portable Storage Devices.** End User may not use computer disks or portable storage devices, such as a thumb drive, as a method of transmitting DHHS data.
3. **Encrypted Email.** End User may only employ email to transmit Confidential Data if email is encrypted and being sent to and being received by email addresses of persons authorized to receive such information.
4. **Encrypted Web Site.** If End User is employing the Web to transmit Confidential Data, the secure socket layers (SSL) must be used and the web site must be secure. SSL encrypts data transmitted via a Web site.
5. **File Hosting Services, also known as File Sharing Sites.** End User may not use file hosting services, other than Contractor instances of the service Box to transmit Confidential Data.
6. **Ground Mail Service.** End User may only transmit Confidential Data via *certified* ground mail within the continental U.S. and when sent to a named individual.
7. **Laptops and PDA.** If End User is employing portable devices to transmit Confidential Data said devices must be encrypted and password-protected.
8. **Contractor will utilize encryption at rest and in transit to secure Confidential Data.**
9. **SSH File Transfer Protocol (SFTP), also known as Secure File Transfer Protocol.** If End User is employing an SFTP to transmit Confidential Data, End User will structure the Folder and access privileges to prevent inappropriate disclosure of information.

SFTP folders and sub-folders used for transmitting Confidential Data will be coded for 24-hour auto-deletion cycle (i.e. Confidential Data will be deleted every 24 hours).

10. Wireless Devices. If End User is transmitting Confidential Data via wireless devices, all data must be encrypted to prevent inappropriate disclosure of information.

III. RETENTION AND DISPOSITION OF IDENTIFIABLE RECORDS

The Contractor will only retain the data and any derivative of the data for the duration of this Contract. After such time, the Contractor will have 30 days to destroy the data and any derivative in whatever form it may exist, unless, otherwise required by law or permitted under this Contract. To this end, the parties must:

A. Retention

1. The Contractor agrees it will not store, transfer or process data collected in connection with the services rendered under this Contract outside of the United States. This physical location requirement shall also apply in the implementation of cloud computing, cloud service or cloud storage capabilities, and includes backup data and Disaster Recovery locations.
2. The Contractor agrees to ensure proper security monitoring capabilities are in place to detect potential security events that can impact State of NH systems and/or Department confidential information for contractor provided systems.
3. The Contractor agrees to provide security awareness and education for its End Users in support of protecting Department confidential information.
4. The Contractor agrees to retain all electronic and hard copies of Confidential Data in a secure location and identified in section IV. A.2
5. The Contractor agrees Confidential Data stored in a Cloud must comply with all applicable statutes and regulations regarding the privacy and security. All servers and devices must have currently-supported and hardened operating systems, the latest anti-viral, anti-hacker, anti-spam, anti-spyware, and anti-malware utilities. The environment, as a whole, must have aggressive intrusion-detection and firewall protection.
6. The Contractor agrees to and ensures its complete cooperation with the State's Chief Information Officer in the detection of any security vulnerability of the hosting infrastructure.

B. Disposition

1. If the Contractor will maintain any Confidential Information on its systems (or its sub-contractor systems), the Contractor will maintain a documented process for securely disposing of such data upon request or contract termination; and will obtain written certification for any State of New Hampshire data destroyed by the Contractor or

any subcontractors as a part of ongoing, emergency, and or disaster recovery operations. The Contractor will provide written attestation to the Department upon request in accordance with the guidance in NIST Special Publication 800-88, Rev 1, Guidelines for Media Sanitization.

2. Unless otherwise specified, within thirty (30) days of the termination of this Contract, Contractor agrees to destroy all hard copies of Confidential Data using a secure method such as micro-cross shredding.
3. Unless otherwise specified, within thirty (30) days of the termination of this Contract, Contractor agrees to completely destroy all electronic Confidential Data by means of data erasure, also known as secure data wiping.

IV. PROCEDURES FOR SECURITY

A. Contractor agrees to safeguard the DHHS Data received under this Contract, and any derivative data or files, as follows:

1. The Contractor will maintain proper security controls to protect Department confidential information collected, processed, managed, and/or stored in the delivery of contracted services.
2. The Contractor will maintain policies and procedures to protect Department confidential information throughout the information lifecycle, where applicable, (from creation, transformation, use, storage and secure destruction) regardless of the media used to store the data (i.e., tape, disk, paper, etc.).
3. The Contractor will maintain appropriate authentication and access controls to contractor systems that collect, transmit, or store Department confidential information where applicable.
4. The Contractor will ensure proper security monitoring capabilities are in place to detect potential security events that can impact State of NH systems and/or Department confidential information for contractor provided systems.
5. The Contractor will provide regular security awareness and education for its End Users in support of protecting Department confidential information.
6. If the Contractor will be sub-contracting any core functions of the engagement supporting the services for State of New Hampshire, the Contractor will maintain a program of an internal process or processes that defines specific security expectations, and monitoring compliance to security requirements that at a minimum match those for the Contractor, including breach notification requirements.
7. The Contractor will work with the Department to sign and comply with all applicable State of New Hampshire and Department system access and authorization policies and procedures, systems access forms, and computer use agreements as part of obtaining

and maintaining access to any Department system(s). Agreements will be completed and signed by the Contractor and any applicable sub-contractors prior to system access being authorized.

8. Reserved

9. The Contractor will work with the Department at its request to complete a System Management Survey. The purpose of the survey is to enable the Department and Contractor to monitor for any changes in risks, threats, and vulnerabilities that may occur over the life of the Contractor engagement. The survey will be completed annually, or an alternate time frame at the Departments discretion with agreement by the Contractor, or the Department may request the survey be completed when the scope of the engagement between the Department and the Contractor changes.

10. The Contractor will not store any State of New Hampshire or Department data outside the boundaries of the United States unless prior express written consent is obtained from the Information Security Office leadership member within the Department.

11. Data Security Breach Liability. In the event of any security breach Contractor shall make efforts to investigate the causes of the breach, promptly take measures to prevent future breach and minimize any damage or loss resulting from the breach. For those breaches caused by the actions of the Contractor, the State shall recover from the Contractor all costs of response and recovery from the breach, including but not limited to: credit monitoring services, mailing costs and costs associated with website and telephone call center services necessary due to the breach.

12. Contractor must, comply with all applicable statutes and regulations regarding the privacy and security of Confidential Information, and must in all other respects maintain the privacy and security of PI and PHI at a level and scope that is not less than the level and scope of requirements applicable to applicable government contractors, including, but not limited to, provisions of any applicable law that govern protections for individually identifiable health information and as applicable under State law.

13. Contractor agrees to establish and maintain appropriate administrative, technical, and physical safeguards to protect the confidentiality of the Confidential Data and to prevent unauthorized use or access to it.

14. The Contractor must notify NHDHHS Information Security via the email address provided in this Exhibit, of any Incidents or Breaches immediately after the Contractor has determined that the aforementioned has occurred and that Confidential Data may have been exposed or compromised.

15. Contractor must restrict access to the Confidential Data obtained under this Contract to only those authorized End Users who have an authorized need for such DHHS Data to perform their official duties in connection with purposes identified in this Contract.

16. The Contractor must ensure that all End Users:

- a. comply with such safeguards as referenced in Section IV A. above, implemented to protect Confidential Information that is furnished by DHHS under this Contract from loss, theft or inadvertent disclosure.
- b. safeguard this information at all times.
- c. ensure that laptops and other electronic devices/media containing PHI, PI, or PFI are encrypted and password-protected.
- d. send emails containing Confidential Information only if encrypted and being sent to and being received by email addresses of persons authorized to receive such information.
- e. limit disclosure of the Confidential Information to the extent permitted by law.
- f. Confidential Information received under this Contract and individually identifiable data derived from DHHS Data, must be stored in an area that is physically and technologically secure from access by unauthorized persons during duty hours as well as non-duty hours (e.g., door locks, card keys, biometric identifiers, etc.);
- g. only authorized End Users may transmit the Confidential Data, including any derivative files containing personally identifiable information, and in all cases, such data must be encrypted at all times when in transit, at rest, or when stored on portable media as required in section IV above.
- h. in all other instances Confidential Data must be maintained, used and disclosed using appropriate safeguards, as determined by a risk-based assessment of the circumstances involved.
- i. understand that their user credentials (user name and password) must not be shared with anyone. End Users will keep their credential information secure. This applies to credentials used to access the site directly or indirectly through a third party application.

Contractor is responsible for oversight and compliance of their End Users. DHHS reserves the right to conduct onsite inspections to monitor compliance with this Contract, including the privacy and security requirements provided in herein, HIPAA, and other applicable laws and Federal regulations until such time the Confidential Data is disposed of, in accordance with this Contract. Onsite inspections shall be conducted no more than annually at the cost of the Department with reasonable notice to the Contractor - parties agree this stipulation is waived if the inspection is in relationship to a security incident or breach related to Confidential Data.

Contractor has determined that the aforementioned has occurred and that Confidential Data may have been exposed or compromised.

1. Parties acknowledge and agree that unless notice to the contrary is provided by Department in its sole discretion to Contractor, this Section V.1 constitutes notice by Contractor to Department of the ongoing existence and occurrence or attempts of Unsuccessful Security Incidents for which no additional notice to Department shall be required. "Unsuccessful Security Incidents" means, without limitation, pings and other broadcast attacks on Contractor's firewalls, port scans, unsuccessful log-on attempts, denial of service attacks, and any combination of the above, so long as no such incident results in unauthorized access, use or disclosure of PHI.
- B. In addition to, and notwithstanding, Contractor's compliance with all applicable obligations and procedures, Contractor's procedures must also address how the Contractor will:
 1. Identify Incidents;
 2. Determine if Confidential Data is involved in Incidents;
 3. Report suspected or confirmed Incidents or breach to the Department as required in this Exhibit. The Department will provide the Contractor with a NH DHHS Security Contractor Incident Risk Assessment Report for completion;
 4. Within 24-hrs of initial notification to the Department, complete the NH DHHS Security Contractor Incident Risk Assessment Report and email it to the Department's Information Security Office at the email address provided herein;
 5. Identify and convene a core response group to determine the risk level of Incidents and determine risk-based responses to Incidents and mitigation measures, prepare to include the Department in the incident response calls throughout the incident response investigation;
 6. Identify incident/breach notification method and timing;
 7. Within one business week of the conclusion of the Incident/Breach response investigation a final written Incident Response Report and Mitigation Plan is submitted to the Department's Information Security Office at the email address provided herein;
 8. Address and report incidents and/or Breaches that implicate personal information (PI) to the Department in accordance with NH RSA 359-C:20 and this Agreement;
 9. Address and report incidents and/or Breaches per the HIPAA Breach Notification Rule, and the Federal Trade Commission's Health Breach Notification Rule 16 CFR Part 318 and this Agreement.

- C. All legal notifications required as a result of a breach of information, or potential breach, collected pursuant to this Contract shall be coordinated with the State.
