REQUESTED ACTION

Authorize the New Hampshire Department of Transportation to **retroactively** pay employees, an amount not to exceed \$8,391.37 for compensation owed to them due to SOC classification issues from November 3, 2023, effective upon Governor and Council approval. 66.9% Highway Funds and 33.1% Turnpike Funds.
