REQUESTED ACTION

The Department of Transportation, Bureau of Finance and Contracts, reports all paid Small Claims in Fiscal Year 2025 totaling \$12,129.19 for individual amounts less than \$2,000 submitted under the provisions of RSA 228:29.

EXPLANATION

RSA 228:29 authorizes the Commissioner to use funds accruing to the Department of Transportation for the payment of small claims occasioned by accidents due to the activities of the Department of Transportation. Any person claiming damage due to the activities of the Department of Transportation may seek payment of the small claim if the amount is less than \$2,000.

A review of claims approved for payment during Fiscal Year 2025 indicates that seventeen (17) claims were paid.

Claimant: Adele Bakke Amount: \$449

Adele Bakke's vehicle was damaged while traveling on US 202 in Northwood on June 12th. The claimant's vehicle sustained damage to the left side of the vehicle as a result of painting operations.

Claimant: Jim Tiberio Amount: \$1,835

Jim Tiberio's vehicle was damaged while traveling on US 202 in Northwood on June 12th. The claimant's vehicle sustained damage to the left side of the vehicle as a result of painting operations.

Claimant: Mark Pellegrino Amount: \$1,865.21

Mark Pellegrino's vehicle was damaged while traveling on US 202 in Northwood on June 12th. The claimant's vehicle sustained damage to the left side of the vehicle as a result of painting operations.

Claimant: Irena Catovic Amount: \$540

Irena Catovic's vehicle was damaged while traveling on Route 11 in Sunapee on May 4th. The claimant's vehicle sustained damage as a result of a roadway insufficiency.

Claimant: Kim Mountain Amount: \$1,060

Kim Mountain's vehicle was damaged while traveling on US 202 in Northwood on June 12th. The claimant's vehicle sustained damage to the left side of the vehicle as a result of painting operations.

Claimant: John Tierney Amount: \$1,173

John Tierney's vehicle was damaged while traveling on US 202 in Northwood on June 12th. The claimant's vehicle sustained damage to the left side of the vehicle as a result of painting operations.

Claimant: Stephen Thibodeau Amount: \$399

Stephen Thibodeau's vehicle was damaged while traveling on US 202 in Northwood on June 12th. The claimant's vehicle sustained damage to the left side of the vehicle as a result of painting operations.

Claimant: Stephen Hosken Amount: \$350

Claimant: Thomas Christopher Amount: \$399.95

Thomas Christopher's vehicle was damaged while traveling on US 202 in Northwood on June 12th. The claimant's vehicle sustained damage to the left side of the vehicle as a result of painting operations.

Claimant: Town of Winchester Amount: \$400

The Town of Winchester sustained property damage on NH 119 in Winchester on August 29th, while the Department was involved in mowing operations.

Claimant: Jamie Eastman Amount: \$161.87

Jamie Eastman's vehicle was damaged while traveling on NH 116 in North Haverhill on August 2nd. The claimant's vehicle sustained damage to the left side of the vehicle as a result of painting operations.

Claimant: Rolando Dongo Amount: \$600

Rolando Dongo's vehicle was damaged while traveling on Route 28 in Windham on October 1st. The claimant's vehicle sustained damage to the left side of the vehicle as a result of painting operations.

Claimant: Tammy Clegg Amount: \$1,036.82

Tammy Clegg's vehicle was damaged while traveling on Route 3 in Nashua on February 21st. The claimant's vehicle sustained damage as a result of a bridge insufficiency.

Claimant: Wilinon Dominguez Amount: \$698.85

Wilinon Dominguez's vehicle was damaged while traveling on Route 3 in Nashua on February 21st. The claimant's vehicle sustained damage as a result of a bridge insufficiency.

Claimant: Babette Arroyo

Amount: \$232.99

Babette Arroyo's vehicle was damaged while traveling on Route 28 in Londonderry on January 12th. The claimant's vehicle sustained damage while the Department was involved in winter maintenance.

Claimant: Luca Milan

Amount: \$399

Luca Milan's vehicle was damaged while traveling on US 202 in Northwood on June 12th. The claimant's vehicle sustained damage to the left side of the vehicle as a result of painting operations.

Claimant: John Rendon

Amount: \$528.50

John Rendon's vehicle was damaged while traveling on Route 3 in Nashua on February 21st. The claimant's vehicle sustained damage as a result of a bridge insufficiency.

A summary of the action taken on all claims for Fiscal Year 2025 is on file at the Department of Transportation.
