REQUESTED ACTION

That approval be and hereby is given to the Attorney General to appoint Laura J. Raymond to Position #9U060 (Appropriation #02-20-20-201010-2623-013-500132) as an Assistant Attorney General at a salary level of \$83,000, effective upon Governor and Executive Council approval or November 14, 2025, whichever is later, for a term ending November 21, 2028.

EXPLANATION

Ms. Raymond, a Manchester resident, earned Bachelor of Arts degrees in Political Science and Mandarin Chinese from the College of the Holy Cross in 2016, and a Juris Doctor, *cum laude*, from the University of New Hampshire Franklin Pierce School of Law in 2022. During law school, she was Student Bar Association Treasurer (2019-2021), Intern in our Administrative Prosecution Unit (2020), Legal Analysis and Writing Teaching Assistant (2020-2021), and *The University of New Hampshire Law Review* Chief Articles Editor (2021-2022). She was selected for and graduated from the Daniel Webster Scholar's program. She is admitted to practice law in New Hampshire and Massachusetts. Ms. Raymond joined McLane Middleton, P.A., in September 2022 as an Associate Attorney in the Litigation Department. Her duties there included participation in evidentiary hearings and witness examinations, conducting discovery in state and federal cases, and preparing legal memoranda and briefs. She has contributed to her community and profession by serving as Vice-President of the Manchester City Library Foundation, member of the New Hampshire Bar Association New Lawyers Committee, and Networking Committee member for the New Hampshire Women's Bar Association. She joined the Department in 2023 and was assigned to the Civil Law Bureau's Civil Litigation Unit. She will be transferring to the Public Safety and Infrastructure Bureau.
