REQUESTED ACTION

The New Hampshire Lottery and Gaming Commission (Lottery) requests authorization for a **sole source** amendment to extend the contract with Scientific Games (SG) of Alpharetta, Georgia, (vendor number 175862) for instant ticket printing and cooperative services by an additional five (5) years from June 30, 2027 to June 30, 2032, while maintaining the same base cost, adding no-cost benefits, and decreasing the annual price limitation by \$2,000,000 from \$11,000,000 down to \$9,000,000. The original contract was approved by Governor & Council on June 21, 2017 (Item #125). The contract has previously been amended on May 19, 2021 (Item #93). Effective upon Governor and Council approval.

EXPLANATION

The Lottery is proposing a five (5) year extension of the contract for instant ticket printing and cooperative services with SG. This contract was first executed on June 21, 2017, with services commencing on July 1, 2017. Over the past 8 years, the contract was amended once to extend the term for services and add additional scope.

The Lottery now seeks to extend the existing agreement, which is presently set to expire on June 30, 2027, by five years. SG proposes maintaining its existing base fee, including often-utilized print options, and providing annual services that add additional value, such as an annual \$50,000 in print enhancement credit, an annual training seminar for Lottery staff, and a discount on licensed properties.


The Lottery has determined that extending the existing contract is a better value and use of resources than engaging in a new procurement. SG proposes continuing to provide the same base fee of 3.99% of gross gaming revenue (GGR), which has been in effect since the extension on May 19, 2021, for the additional term of the extended contract. This is advantageous for several reasons.

First, recent competitive bids of similar scope have been priced, on average, 25% higher than existing costs due to price increases in paper stock, printing materials, and shipping costs. In FY2025, scratch ticket sales accounted for over \$296 million in sales, equating to over \$44.4 million in profitability, almost 25% of what the Lottery returned to education in FY25. Increasing the costs for scratch ticket games and services would impact the overall profitability.

Second, because the existing services have only been in place for four years following the most recent amendment, changing the existing telephone sales, warehousing interface, and scratch ticket management support systems to a new vendor would be disruptive to the retailer network, game development, and shipping and sales operations. Third, due to contract implementation for the central gaming system conversion, not conducting a bid will allow the staff to focus on business growth and continuity.

The New Hampshire Lottery and Gaming Commission respectfully requests approval to enter into this contract amendment and extension for instant ticket printing and related services with Scientific Games International, Inc.

**Extension and Amendment to Contract Between
The New Hampshire Lottery and Gaming Commission
and
Scientific Games, LLC
for
Instant Ticket Printing and Related Services**

This Amendment is made and entered into by and between the New Hampshire Lottery and Gaming Commission ("Commission") and Scientific Games, LLC ("SG" or "Contractor"), collectively referred to as "the Parties," as follows:

WHEREAS, the Parties entered into a contract agreement for instant ticket printing and related services approved by Governor & Council on June 21, 2017 (Item #125) and commencing on July 1, 2017 with a completion date of June 30, 2021 (the "Contract");

WHEREAS, the Contract was a result of a competitive Request for Proposals ("RFP") issued by the Commission on January 3, 2017 and amended on February 21, 2017;

WHEREAS, SG was the highest scoring bidder under the RFP and was awarded the Contract;

WHEREAS, the Parties amended this agreement (Amendment #1) on April 6, 2021, which was approved by Governor & Executive Council on May 19, 2021 (Item # 93) to extend the contract term and add cooperative services for telephone sales, predictive ordering, warehouse interface, retailer and territory management software for lottery sales representative, and additional scratch ticket management support;

WHEREAS, SG changed its corporate name in 2022 to Scientific Games, LLC, preserving the corporate form and continuing to execute its obligations under the Contract;

WHEREAS, the Commission believes it is in the best interest to the State of New Hampshire and its 1,500 retailers to further extend the Contract to eliminate operational interruptions for ticket ordering and fulfillment, potential negative impacts to the business operations of the retail network, and interrupted operations of the Commission while ensuring continued revenue creation for the Education Trust Fund;

WHEREAS, the Parties have agreed to amend the Contract to extend the completion date by an additional five years, provide cost savings for enhancements and no-cost for regularly used print techniques and staff training, and secure base pricing at an advantageous rate;

NOW, THEREFORE, the Parties agree to amend the Contract as follows:

1. The Parties agree to amend Section 1.7- Completion Date to **Delete** June 30, 2027 and **Add** June 30, 2032.
2. The Parties agree to amend Section 1.8 - Price Limitation to **Delete** \$11,000,000 and **Add** \$9,000,000.

3. The Parties agree to amend Exhibit A – Scope of Services to **Delete** the existing language in its entirety and **Replace** as follows:

“The scope of services is set forth in the following documents, which are hereby incorporated by reference into this agreement:

- A. This Amendment to the Contract;
- B. The Contract approved by Governor & Council on June 21, 2017, as amended on May 19, 2021;
- C. The Request for Proposal for Instant ticket printing and Related Services dated January 3, 2017 and amended on February 21, 2017;
- D. Vendor questions to the RFP and Lottery Responses;
- E. The Proposal for Instant Ticket Printing and Related Services Contract Extension dated April 5, 2021;
- F. The SG Proposal dated March 6, 2017.
- G. The SG Proposal for Instant Ticket Printing and Related Services Contract Extension dated November 7, 2025;

In addition to the Base Ticket Pricing that will carry forward of 3.99% GGR for SG scratch tickets and 2.20% GGR for scratch tickets from any other vendor, the Commission shall continue to have the option to purchase ticket enhancements and licenses as set forth in Section 4.1 of the RFP. Such options shall be priced in the manner set forth in the SG Price Proposal dated March 26, 2021. The Parties recognize that additional enhancements and licenses may become available during the term of the agreement. SG agrees that it will make enhancements available to the Commission using the NASPL Best Practice Pricing Methodology for deliverables and services not originally defined.

The Commission shall have the following budget for ticket enhancements and licenses:

The Commission shall have the ability to roll any unused monies from one fiscal year to the next and shall have the ability to borrow from future years to meet ticket enhancement obligations in the present fiscal year. Notwithstanding the ability to move money from year to year, the Commission shall not exceed the total amount identified in this exhibit without an amendment of the Contract subject to approval of the Governor & Executive Council.”

4. The Parties agree to amend the Contract to **Delete** references to “Scientific Games International, Inc.” and **Replace** such references with “Scientific Games, LLC,” as the entity changed its name on April 4, 2022. SG acknowledges that it has and shall

continue to perform all obligations of Scientific Games International, Inc. under the Contract, as amended.

5. This Amendment represents the entire understanding between the Parties with respect to the matters set forth herein and supersedes prior representations, understandings, or agreements, whether written or oral, expressed or implied regarding those matters specifically set forth herein.
6. All terms and conditions in the Contract remain in effect, unless otherwise noted in this Amendment. The Amendment shall be contingent on approval by the Governor & Executive Council.
